The entry into force of the Convention in Maldives was recognized by the Secretary-General who replaced its non-Party name plate with that for a voting member. Maldives assured Parties that it would work with the global community on conservation matters.

Interpretation and implementation of the Convention

Amendment of the Appendices

77. Proposals to amend Appendices I and II

Proposal CoP16 Prop. 47 to include *Paratrygon aiereba* (Ceja river stingray) in Appendix II, with the annotation presented in that document, was introduced by Colombia, which noted that the species was of commercial interest. It believed that inclusion in Appendix II would ensure sustainable use.

Argentina, the Bolivarian Republic of Venezuela, Brazil, Costa Rica, Ecuador, El Salvador, Madagascar, Panama, Qatar, Senegal and Defenders of Wildlife supported the proposal.

Ireland, on behalf of the Member States of the European Union and Croatia, did not support the proposal and believed that listing in Appendix III would provide the data needed to assess whether the species warranted inclusion in Appendix II. The Food and Agriculture Organization of the United Nations (FAO) reported that the Expert Panel had decided that there was not enough information to determine whether the species met the criteria for inclusion in Appendix II, and it suggested that national management and regulation was more appropriate. Ornamental Fish International did not support the proposal either, pointing out that captive breeding was taking place and recommending inclusion in Appendix III.

Realizing that there was no consensus, the Chair called for a vote on proposal CoP16 Prop. 47. Fifty-one Parties were in favour, 51 against, and 19 abstained (see Annex 1); the proposal was therefore <u>not accepted</u>.

Colombia introduced proposal CoP16 Prop. 48 to include *Potamotrygon motoro* (ocellate river stingray) and *P. schroederi* (rosette river stingray) in Appendix II, drawing attention to additional information in document CoP16 Inf. 28. Argentina, the Bolivarian Republic of Venezuela, Brazil, Ecuador and Uruguay, all range States of one or both of these species, expressed support for the proposal, which was echoed by Qatar, Senegal, the United States of America and the Species Survival Network.

Paraguay, also a range State of one of the species, felt that its population had not been taken into account, stating that national legislation ensured there were no human pressures on it. With Guyana, also a range State, Ireland, on behalf of the Member States of the European Union and Croatia, and the European Pet Organization, it believed it was more appropriate to include this species in Appendix III. FAO believed that there was insufficient information to show that the species met the criteria for inclusion in Appendix II, suggesting it would be more useful to strengthen management measures at country level.

Seeing no consensus, the Chair proposed a vote. Fifty-five parties voted in favour of the proposal, 52 against, and 25 abstained. Proposal CoP16 Prop. 48 was therefore <u>not accepted</u> (see Annex 2).

Strategic matters

17. Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services

Mexico presented document CoP16 Com. I. 4 containing four draft decisions prepared by a drafting group, based on document CoP16 Doc. 17 (Rev. 1). These were <u>accepted</u> by consensus. It was <u>agreed</u> to repeal Decisions 15.12, 15.13 and 15.14.

Interpretation and implementation of the Convention

Species trade and conservation

65. Regional cooperation on the management of and trade in the queen conch (Strombus gigas)

Colombia introduced document CoP16 Com. I.5 containing the report of the drafting group on matters arising from the discussion on document CoP16 Doc. 65 (Rev. 1) Two corrections were noted: replace "16.FF" with <u>16.HH</u> in paragraph 16.FF,; and replace "16.EE" with <u>16.FF</u> in paragraph 16.HH. Colombia also requested some changes to the Spanish version as follows: replace "educación del público" with <u>educación pública</u> in paragraph 16.EE; replace "con arreglo" with <u>de acuerdo</u> in paragraphs 16.FF and 16.HH; and replace "normas" with <u>estándares</u> in paragraph 16.GG a).

Belize, Cuba, Ireland, on behalf of the Member States of the European Union and Croatia, Jamaica and FAO supported the draft decisions. Belize, Cuba and Jamaica offered assistance in implementing them.

France said that it would provide non-substantive editorial amendments to the French version to the Secretariat. It also proposed inserting the words <u>mentioned in 16.AA</u> after "Working Group on Queen Conch" in paragraphs 16.CC a) and 16.HH. This was <u>agreed</u> and the eight draft decisions contained in CoP16 Com. I.5, as amended, were <u>accepted</u> by consensus.

Amendment of the Appendices

77. Proposals to amend Appendices I and II

Proposal CoP16 Prop. 49 to transfer *Papilio hospiton* (Corsican swallowtail butterfly) from Appendix I to Appendix II was introduced by Ireland, on behalf of the Member States of the European Union and Croatia.

Switzerland and Peru supported the proposal, the former noting that international trade did not present a threat to the species and that the proposal had been endorsed by the Animals Committee under the *Periodic review of the Appendices*.

Proposal CoP16 Prop. 49 was accepted by consensus.

Proposal CoP16 Prop. 50 to include *Yucca queretaroensis* (Queretaro yucca) in Appendix II was introduced by Mexico.

Ireland, on behalf of the Member States of the European Union and Croatia, was concerned that there was little information on levels of trade and impacts of harvest but, noting the slow-growing nature of the species, its restricted distribution and reports of demand being met by wild specimens, expressed support for the proposal.

Proposal CoP16 Prop. 50 was <u>accepted</u> by consensus.

The Committee agreed that seven proposals submitted by Madagascar to include various succulent plant species endemic to Madagascar in Appendix II could be considered together. These proposals were CoP16 Prop. 51 concerning *Operculicarya decaryi* (jabihy); CoP16 Prop. 64 concerning *Senna meridionalis* (taraby); CoP16 Prop. 65 concerning *Adenia firingalavensis* (bottle liana); CoP16 Prop. 66 concerning *Adenia subsessifolia* (katakata); CoP16 Prop. 67 concerning *Uncarina grandidieri* (uncarina); CoP16 Prop. 68 concerning *Uncarina stellulifera* (uncarina); and CoP16 Prop. 71 concerning *Cyphostemma laza* (laza).

The United States commended Madagascar, recognizing the significant fieldwork that had been conducted by the IUCN/SSC Madagascar Plant Specialist Group and Madagascar Scientific Authority since CoP15, and noted the existence of a niche market in the United States for these species. It, together with Nigeria and Qatar, supported the proposal. South Africa, noting its consultation with Madagascar which had revealed the collection of wild specimens for trade, stated it would not oppose the proposals.

Ireland, on behalf of the Member States of the European Union and Croatia, believed several of the species to be widespread and demand to be met by artificial propagation, and therefore could not support the proposal but would not block consensus.

IUCN reported that it would be finalizing Red List assessments of the species concerned, pending the availability of funds. The Documentation Center for Species Protection believed that all species met the criteria for inclusion in Appendix II, and that *Cyphostemma laza* met the criteria for inclusion in Appendix I, noting also that *C. laza* was traded in large quantities under the synonym "*Cissus laza*".

Proposals CoP16 Prop. 51, 64, 65, 66, 67, 68 and 71 were accepted by consensus.

Proposal CoP16 Prop. 52 to amend annotation #9 relating to *Hoodia* species was introduced by Namibia, one of the co-proponents, including minor amendments proposed by the Secretariat in document CoP16 Doc. 77, Annex 1, to replace "in" with <u>under the</u>. Namibia added that the list of entities registered to benefit from the exemption in the respective range States would be made available to Parties on request, and that Parties would be informed through a Notification about the details to be contained on labels.

Switzerland was concerned that the existing annotation did not fulfill the aim of CITES, and maintained its reservation, but would not block consensus. Ireland, on behalf of the Member States of the European Union and Croatia, welcomed the proposed amendments to annotation #9 and, supported by the United States, further requested that finished products be excluded. It also proposed a draft decision as follows:

Directed to the Standing Committee

16.XX The Working Group on Annotations should review the annotation to the listing of Hoodia species with a view to its standardization and amendment, as appropriate.

Namibia supported the draft decision but pointed out that the request to exclude all finished products would expand the scope of proposal CoP16 Prop. 52. The Chair concurred.

The proposal to amend annotation #9 with the minor revisions proposed by the Secretariat, and to include the draft decision directed to the Standing Committee, was <u>accepted</u> by consensus.

The meeting was adjourned at 11h55.
