Animals Committee strategic planning for 2023-2025 (CoP19-CoP20)

IMPLEMENTATION OF THE WORK PLAN FOR 2023-2025

1. This document has been prepared by the Chair of the Animals Committee.*
2. At its 32nd meeting (AC32; Geneva, June 2023), the Animals Committee noted document [AC32 Doc. 8.1](#) and its two Annexes on Resolutions and Decisions that are directed to or that may require action from the Animals Committee or may need consultation with or assistance from the Plants Committee.
3. The present document presents an update on the progress made by the Animals Committee concerning the implementation of its work plan for 2023–2025 with regard to Decisions. The Annex to this document contains the list of instructions in Decisions directed to the Animals Committee by the 19th meeting of the Conference of the Parties (CoP19; Panama City, 2022) and details on their implementation.
4. For ease of reference, and similar to meeting agendas of the Animals Committee, the Decisions are grouped under: Administrative and financial matters; Strategic matters; Compliance; Illegal trade and enforcement; Regulation of trade; Species conservation and trade; and Appendices of the Convention. The full text of these instructions was presented in document [AC32 Doc. 8.1](#).
5. The final column “Proposed recommendation to SC or CoP” represents the recommendations as currently presented in the documents to be considered at AC33, which may be subject to change. Based on the recommendations adopted at this meeting, this column will be updated before progress on the implementation of the work plan is reported to the Standing Committee and the 20th meeting of the Conference of the Parties (CoP20).
