Species specific matters

Proposals to amend the Appendices

89. Proposals to amend Appendices I and II

The Committee resumed discussion on **proposal CoP19 Prop. 48** to include *Dipteryx* spp. in Appendix II.

Colombia reported that the co-proponents agreed with the suggested amendments put forward in the previous session to remove seeds from the proposed annotation and to add an 18-month delay in the entry into force of the inclusion in Appendix-II, if the proposal were adopted.

The Plurinational State of Bolivia requested the establishment of a working group to allow further analysis of the potential impacts of the proposal on the livelihoods of indigenous peoples. Brazil and the United Kingdom of Great Britain and Northern Ireland supported the establishment of a working group. Brazil and Guyana repeated their opposition to the proposal.

Peru reiterated its statement made in the previous session that, if the proposal were adopted, an implementation delay of 24 months would be needed for range States to put in place regulatory measures for the genus. The European Union and its Member States agreed that it could accept a 24-month delay.

Noting that there was no consensus, the Chair called for a vote on the proposal with the suggested amendments to remove seeds from the annotation and to delay the entry into effect of the inclusion in Appendix II by 24 months.

While this summary record has been adopted without changes in summary record CoP19 Com. I. Rec 11, the Secretariat has revised it at the request of the European Union that had asked to be referred to as "the European Union and its Member States" throughout all the summary records of CoP19.

With 74 votes in favour of the proposal, 13 against and 18 abstentions, proposal CoP19 Prop. 48 to list *Dipteryx* spp. in Appendix II with annotation "Logs, sawn wood, veneer sheets, plywood and transformed wood" was accepted as amended.

Maintenance of the Appendices

84. Standard nomenclature

84.2 Standard nomenclature for *Dipteryx* spp.

The European Union and its Member States introduced document CoP19 Doc. 84.2, which summarized current taxonomic uncertainty regarding the genus *Dipteryx* and contained a draft decision 19.AA directing the Plants Committee to consider the nomenclatural issues relating to *Dipteryx* spp and identify a suitable standard nomenclatural reference for the genus, also indicating that it agreed with the minor revisions proposed by the Secretariat in paragraph C of its comments. In the interim, it proposed Carvalho, C.S., de Fraga, N.C., Cardoso, D.B.O.S. and Lima, H.C. 2020. Tonka, baru and cumaru: Nomenclatural overview, typification and updated checklist of Dipteryx (Leguminosae). Taxon. 69(3), pp.582-592 as the standard nomenclatural reference *Dipteryx* species.

Draft decision 19.AA in document CoP19 Doc. 84.2, as amended by the Secretariat and the standard nomenclatural reference cited by the European Union and its Member States, were <u>accepted</u>.

Species specific matters

Proposals to amend the Appendices

89. Proposals to amend Appendices I and II

Panama, on behalf of the co-proponents, introduced **proposal CoP19 Prop. 44** to include the genera *Handroanthus*, *Roseodendron* and *Tabebuia* in CITES Appendix II with annotation #17 (Logs, sawn wood, veneer sheets, plywood and transformed wood). It drew attention to a variety of threats faced by the species and, echoed by co-proponents Colombia and the European Union and its Member States, assured Parties that the criteria for inclusion in Appendix II were met.

Argentina and Species Survival Network, on behalf of a number of other observer organizations, supported the proposal. The Plurinational State of Bolivia, Brazil, Peru, and the International Wood Products Association opposed it. Brazil considered *inter alia* that there was no robust scientific reason to include the genera in Appendix II and that the supporting statement lacked up-to-date, comprehensive information. It urged Parties to consider the opinions of range States in evaluating the proposal. Peru noted that a recent analysis had shown that many species in the genera were not threatened or were only minimally threatened and did not therefore warrant inclusion in the Appendices.

The Plurinational State of Bolivia stated that if the proposal were adopted, range States would need a 24-month delay in the entry into force to prepare for implementation. This suggested amendment was supported by Brazil and the International Wood Products Association, with Brazil clarifying that it remained in opposition to the proposal, whether or not it was amended. Canada and the United Kingdom of Great Britain and Northern Ireland opposed the suggested amendment.

The Chair advised that Parties would need to vote on the amendment proposed by the Plurinational State of Bolivia. In response to a query from Brazil, he confirmed that, according to Rule 25.5 of the Rules of Procedure as amended at CoP19, if an amended version of a proposal were suggested for consideration, but consensus could not reached on its consideration, then consideration of the amended version would be put to a vote. If the consideration of the amended proposal were accepted, the amended proposal would supersede the original proposal. The Chair of the Standing Committee agreed with this interpretation of Rule 25.5 and clarified that the vote on whether to consider the amended proposal would be a substantive rather than procedural matter.

In the light of these explanations, the United Kingdom observed that it had disagreed with the amendment to proposal CoP19 Prop. 48 on *Dipteryx* spp. and believed that, as such, there had not been consensus on whether this amendment should be considered. The Chair stated that he considered that proposal CoP19 Prop. 48 had indeed been accepted as amended; however, he noted the United Kingdom's comment for the record.

Colombia, the European Union and its Member States, and Panama, as co-proponents, stated that they agreed to the suggested amendment of the proposal to add a 24-month implementation delay.

After some discussion in which Brazil and Israel indicated that they had been expecting a vote on the amended proposal and, at the suggestion of Panama, the Chair called for a vote on the proposal as amended by the Plurinational State of Bolivia and supported by all co-proponents, in accordance with Rule 24.2 of the Rules of Procedure. With 86 votes in favour of the proposal, 17 against and 18 abstentions, proposal CoP19 Prop. 44 to include the genera *Handroanthus, Roseodendron* and *Tabebuia* in Appendix II with entry into effect of the inclusion in Appendix II delayed by 24 months was accepted.

Israel and Japan raised points of order, considering that it was unclear which version of the proposal Parties had been asked to vote on, and stated that they had thought themselves to be voting on whether to accept consideration of the Plurinational State of Bolivia's amendment to the proposal only. The European Union and its Member States were of the opinion that as all co-proponents had agreed to the amendment, no vote was needed on whether to accept the amendment, and the only proposal available for consideration by the Committee was the amended proposal.

The Chair re-confirmed the acceptance of the Committee to the inclusion of the genera *Handroanthus, Roseodendron* and *Tabebuia* in Appendix II with annotation #17 (Logs, sawn wood, veneer sheets, plywood and transformed wood) and with the entry into effect of the inclusion in Appendix II delayed by 24 months.

89. Proposals to amend Appendices I and II

The European Union and its Member States introduced **proposal CoP19 Prop. 46** to include African populations of *Afzelia* spp. in Appendix II with annotation #17 (Logs, sawn wood, veneer sheets, plywood and transformed wood). Four species were proposed on the basis of intensive logging leading to population declines and the remainder for lookalike reasons.

As co-proponents, Benin, Côte d'Ivoire and Senegal voiced support for the proposal highlighting the slow growth rate of the genus and the threat posed to it by habitat loss and climate change. Burkina Faso, Kenya, Nigeria, Niger, Uganda, Zambia also expressed support for the proposal, arguing that the inclusion of the genus would promote improved conservation. Uganda and Zambia drew attention to high levels of illegal trade in the genus.

Cameroon, the Central African Republic, Congo and Gabon opposed the proposal, reporting that *Afzelia* species are not threatened by trade in their territories and opining that sufficient controls were already in place. China stated that the views of all range States of African *Afzelia* species should be fully considered.

Noting the lack of consensus, the Chair called for a vote. With 95 votes in favour of the proposal, 12 against and 17 abstentions, proposal CoP19 Prop. 46 to include African populations of *Afzelia* spp. in Appendix II with annotation #17 (Logs, sawn wood, veneer sheets, plywood and transformed wood) was <u>accepted</u>.

The meeting was adjourned at 12h00.


