Proposals to amend the Appendices

The Chair notified participants of a change in the working programme, intending to move the remaining timber and plant species proposals to the evening session in lieu of the planned agenda items.

89. Proposals to amend Appendices I and II

Proposal CoP19 Prop. 37 to include Carcharhinidae spp. in Appendix II was introduced by Panama, with a suggested amendment agreed by all proponents, to delay the entry into effect of any inclusion in Appendix II by 12 months to allow the necessary financial and administrative mechanisms to be put in place.

The proposal was supported by Australia, Bahamas, Burkina Faso, Egypt, Fiji, the Gambia, Guatemala, Liberia, Mali, Monaco, Niger, Nigeria, Pakistan, Somalia and the Syrian Arab Republic, with Australia, Bahamas, and Monaco additionally expressing support for the implementation period delay of 12 months. The International Union for Conservation of Nature (also on behalf of TRAFFIC) and Humane Society International also supported the original proposal.

The Food and Agriculture Organization of the United Nations (FAO) drew attention to the findings of its expert panel assessment, which considered that several of the species proposed did not meet the listing criteria. Iceland, supported by Mauritania, noted discrepancies between the advice by the CITES Secretariat and that of the expert panel and urged the institutions to establish a more active coordination. Antigua and Barbuda, and Papua New Guinea opposed the proposal, stating a lack of scientific basis for the inclusion of some species and observing that it would threaten livelihoods of coastal communities, in particular in developing countries.

Chile proposed, but subsequently withdrew a suggestion to delay the entry into effect of any inclusion in Appendix II by 24 months. Peru supported the proposal subject to an amendment to exclude the genus *Prionace*. This was supported by the United States of America and opposed by Niger.

Japan opposed the proposal on the basis of the 35 species proposed for listing under the look-alike criteria; it proposed an amendment to exclude these from the proposal which would read "Exclusion of the following

genus and species: Genus *Carcharhinus*, Genus *Isogomphodon*, Genus *Loxodon*, Genus *Nasolamia*, Genus *Lamiopsis*, Genus *Negaprion*, Genus *Prionace*, Genus *Rhizoprionodon*, Genus *Scoliodon*, Genus *Triaenodon* and any other putative species of family Carcharhinidae that do not satisfy Criterion A in Annex 2b of Resolution Conf. 9.24 (Rev. CoP17)". This was supported by Canada, Indonesia, the Lao People's Democratic Republic, South Africa and the International Coalition of Fisheries but opposed by Liberia, Niger and the United States of America.

The Chair noted that the words "and any other putative species of family Carcharhinidae that do not satisfy Criterion A in Annex 2b of Resolution Conf. 9.24 (Rev. CoP17)" would increase the scope of the proposal contrary to the Rules of Procedure. The Nomenclature Specialist of the Animals Committee observer that as presently worded many species other than the 35 species proposed for listing under the look-alike criteria would also be excluded for Appendix II if the amendment were adopted. In the light of this Japan clarified that their intention was to propose the removal of the second paragraph in section A of proposal CoP19 Prop. 37.

Noting the lack of consensus on the proposed amendments and the proposal itself, China suggested establishing an in-session working group for interested Parties to discuss the species listing so as to maximise support from Parties. The Chair proceeded to a vote on the amendments, starting with Japan's. Iceland, Mauritania and Japan requested a secret ballot for this and any forthcoming votes on the proposal. This request was seconded by 27 Parties.

The proposal as amended by Japan to exclude the 35 look-alike species was rejected by secret ballot, with 43 in favour, 81 against, and 12 abstentions. The European Union and its Member States and the United States of America indicated they had voted against the proposal as amended by Japan, while Antigua and Barbuda reported they had voted for it.

The European Union and its Member States, supported by the United States asked for the list of Parties that had seconded the secret ballot to be made available; the Chair noted the matter would be referred to the Bureau. Antigua and Barbuda opposed this request.

The Chair proceeded to a vote on Peru's amendment to the proposal to exclude *Prionace* spp. also by secret ballot, this being seconded by 17 Parties. The proposal as amended by Peru was rejected, with 33 in favour, 86 against, and 14 abstentions. The European Union and its Member States indicated it had voted against the proposal as amended by Peru, while the United States indicated it had voted in favour.

A vote by secret ballot, which was seconded by 20 Parties, was then held on the original proposal as amended by Panama. With a vote of 88 Parties in favour, 29 against and 17 abstentions, the original proposal to include the family Carcharhinidae spp. in Appendix II with the entry into effect of the inclusion in Appendix II delayed by 12 months was accepted. The European Union and its Member States and the United States of America indicated they had voted in favour of the original proposal; Antigua and Barbuda indicated it had voted against it.

Proposal CoP19 Prop. 38 to include all remaining species in the Family Sphyrnidae that are not already included in the Appendices in Appendix II was introduced by the European Union and its Member States, speaking also on behalf of the co-proponents.

Argentina, Australia, Bahrain, Canada, Chile, Cuba, Gabon, Guatemala, India, Indonesia, Kenya, Monaco, New Zealand, Peru, Senegal, Sierra Leone, Somalia, the United Kingdom of Great Britain and Northern Ireland and the United States of America supported the proposal. Japan opposed it.

Canada drew attention to difficulties in distinguishing fins of different species in the Family Sphyrnidae. New Zealand also noted that the Standing Committees had reported that identification of the species at the international level remains a challenge. Brazil and Indonesia commented that inclusion of the remaining Sphyrnidae species will facilitate better management of the trade. India emphasized that its support was based on species declines as opposed to look-alikes. Peru noted the need to strengthen training and support regional studies to help develop non-detriment findings.

FAO reported that its expert panel had concluded that the species reviewed met the criteria for inclusion in the Appendices but cautioned that as these were often used for domestic consumption, domestic controls needed to be strengthened.

Given the overwhelming support for the proposal, Japan agreed that it would align with the consensus in the room.

The Committee accepted by consensus proposal CoP19 Prop. 38 to include Sphyrnidae spp. in Appendix II.

The meeting was adjourned at 17h05.
