Proposals to amend the Appendices

89. Proposals to amend Appendices I and II

Benin, speaking also on behalf of the co-proponents, introduced **proposal CoP19 Prop. 1 (Rev. 1)** to retain *Hippopotamus amphibius* in CITES Appendix II with the following annotation: "a zero export quota for wild specimens traded for commercial purposes". Benin noted that the species is categorized as globally Vulnerable in the IUCN Red List of Threatened Species, having undergone a population decline of approximately 30% since its 1994 listing.

Argentina, Belize, Burkina Faso, Burundi, the Central African Republic, Chile, Costa Rica, Congo, the Dominican Republic, El Salvador, Fiji, Gabon, Ghana, Guinea, Guinea-Bissau, Guatemala, Honduras, Israel, Liberia, Mali, Mauritania, Morocco, Niger, Nigeria, Panama, Paraguay, Peru, Rwanda, Senegal, Togo and Uruguay supported the proposal, variously noting intrinsically low reproductive rates, small and declining populations in many range States, and the threats facing the species including illegal hunting for ivory.

Botswana, Cameroon, the Democratic Republic of the Congo, the European Union and its Member States, Eswatini, Malawi, Mozambique, Namibia, South Africa, the United Republic of Tanzania, Zambia and Zimbabwe opposed the proposal. Botswana, Cameroon, the Democratic Republic of Congo, Namibia, the United Republic of Tanzania, Zambia and Zimbabwe considered the scientific data did not support the proposal, several of them urging Parties to address primary threats through national and regional management plans.

The European Union and its Member States proposed the following amendment to proposal CoP19 Prop. 1 (Rev. 1):

Retain listing on Appendix II with the following annotation: "A zero export quota for wild specimens traded for commercial purposes for the populations of Benin, Burkina Faso, the Central African Republic, Gabon, Guinea, Liberia, Mali, Niger, Senegal, Togo".

Gabon, Israel and Senegal opposed the amendment considering this approach to be impractical as continued legal trade provides an avenue through which poached ivory can be laundered.

The European Union and its Member States asked for a vote on consideration of its proposed amendment. With 58 in favour, 51 against and 14 abstentions the proposed amendment was rejected.

The Chair then called a vote on the original proposal CoP19 Prop. 1 (Rev. 1). With 56 in favour, 56 against and 13 abstentions, the proposal to retain *Hippopotamus amphibius* in Appendix II with an annotation of a zero export quota for wild specimens traded for commercial purposes, was rejected.

Zimbabwe introduced **proposal CoP19 Prop. 4** to amend annotation 2 pertaining to the populations of *Loxodonta Africana* in Botswana, Namibia, South Africa and Zimbabwe, highlighting the relatively large elephant populations in these countries and the need to raise funds for anti-poaching and for communities living near elephants.

Botswana, the Democratic Republic of the Congo, Lesotho, Namibia, the United Republic of Tanzania and Zambia supported the proposal, emphasizing the need to deliver conservation benefits to local communities.

Benin, Burkina Faso, Burundi, the Central African Republic, Eritrea, Ethiopia, the European Union and its Member States, Gabon, Kenya, Liberia, Niger, Panama, Senegal, Togo and the United Kingdom of Great Britain and Northern Ireland opposed the proposal; while several of these recognized the successful elephant conservation efforts in the four countries, many considered that the proposed amendment would undermine previous efforts to close international ivory markets and could incentivise poaching. The European Union and its Member States noted that it could not support changes to the existing annotation that would impact current trade rules.

The International Association for Wildlife (IAW) agreed the elephant populations of Botswana, Namibia, South Africa and Zimbabwe did not meet the biological criteria for inclusion in Appendix I, and said that the rights of range States to use their natural resources should be recognized. IWMC-World Conservation Trust urged the Committee to recognize the value of sustainable use as a conservation mechanism.

The Chair called for a vote on proposal CoP19 Prop. 4. With 15 in favour, 83 against and 17 abstentions, the proposal CoP19 Prop. 4 to amend annotation 2 pertaining to the African elephant populations of Botswana, Namibia, South Africa and Zimbabwe was rejected.

Burkina Faso, speaking also on behalf of the co-proponents, introduced **proposal CoP19 Prop. 5** to include all populations of *Loxodonta africana* in Appendix I through the transfer from Appendix II to Appendix I of the populations of Botswana, Namibia, South Africa and Zimbabwe. It considered that the entire species meets the criteria for listing in Appendix I and that continuing with a split-listing is not logical. Senegal echoed this as a co-proponent.

Benin, Burundi, the Central African Republic, Congo, Indonesia, Israel, Kenya, Liberia, Niger, Nigeria, Panama, Togo and Fondation Franz Weber (speaking also on behalf of 14 observer organizations) supported the proposal, arguing that a single regulatory regime for African elephants would allow populations to recover.

Botswana, the Democratic Republic of the Congo, Eritrea, Eswatini, the European Union and its Member States, Indonesia, Japan, Malawi, Namibia, Rwanda, South Africa, Uganda, the United Republic of Tanzania, the United States of America, Zambia, Zimbabwe, and Conservation Force opposed the proposal, arguing that it lacked robust scientific data and that the biological criteria for listing the Southern African populations of the species in Appendix I were not met.

Burkina Faso asked for the proposal to be put to a vote. With 44 Parties in favour, 59 against, and 13 abstentions, proposal CoP19 Prop. 5 to transfer the populations of Botswana, Namibia, South Africa and Zimbabwe of *L. africana* from Appendix II to Appendix I was rejected.

The meeting was adjourned at 18h40.
