Adoption of summary records

CoP19 Com I. Rec. 1

Summary record CoP19 Com I. Rec. 1 was adopted with no amendments.

CoP19 Com I. Rec. 2

The United States of America requested that the following sentence be added to the third paragraph under item 61: "The Secretariat explained its rationale for this text and the United States ultimately accepted this text."

Canada asked that the text "and Canada" be deleted from the third paragraph under item 54.

Summary record CoP19 Com I. Rec. 2 was adopted with these amendments.

CoP19 Com. I Rec. 3

Japan asked for the second sentence of the second paragraph under agenda item 65 to begin: "Japan indicated a process issue and called on the examination of SC74 Doc. 24 by the Animals Committee and Standing Committee."

The United States asked for the last sentence of the third paragraph under agenda item 65 to read: "The United States raised the continued challenges in facilitating the transfer of scientific samples for CITES-listed sharks and offered to provide language asking the Committees to consider this issue."; and for the last sentence of the fourth paragraph under agenda item 65 to read: "Sea Shepherd Legal, speaking also on behalf of a number of other non-governmental organization observers, raised concerns on the lack of progress with Decisions 18.221 and 18.219.".

The European Union and its Member States asked for a new additional sentence to be added to the end of the third paragraph under agenda item 62, reading: "<u>The EU highlighted that potential revisions of Resolution</u> <u>Conf. 16.10 on Implementation of the Convention for agarwood-producing taxa and consideration of Res. Conf.</u> <u>11.11 (Rev. CoP18) on Regulation of trade in plants, and Res. Conf. 10.13 (Rev. CoP18) on Implementation of the Convention for trade to any weakening of standards and definitions regarding source code A for artificial propagation"</u>.

Summary record CoP19 Com. I Rec. 3 was adopted with these amendments.

CoP19 Com. I Rec. 4

The Secretariat asked for the following text to be added to the end of item 79: "<u>The Committee agreed to delete</u> <u>Decisions 17.302 and 18.260 to 18.262.</u>" and for text at the end of item 84.1 be amended as follows: "It was agreed to delete Decisions 17.312 (<u>Rev CoP18</u>) and 18.315."

Summary record CoP19 Com. I Rec. 4 was <u>adopted</u> with these amendments.

CoP19 Com. I Rec. 5

Summary record CoP19 Com. I Rec. 5 was adopted with no amendments.

CoP19 Com I. Rec. 6

Iceland requested the following be included in the opening paragraph of agenda item 89 on Proposals to amend Appendices I and II: <u>'Iceland, supported by Mauritania, noted discrepancies between the advice by the CITES</u> Secretariat and that of the FAO Expert Panel, and urged the institutions to establish a more active coordination.'

In relation to Proposal CoP19 Prop. 37, China requested the following be inserted in paragraph 7 after the first comma: '<u>China suggested establishing an in-session working group for interested Parties to discuss the species listing so as to maximise support from Parties.</u>'

Summary record CoP19 Com I. Rec. 6 was adopted with these amendments.

CoP19 Com. I Rec. 7

World Wide Fund for Nature suggested amending the first sentence of page 2 as follows: 'The European Union and its Member States, and the United Kingdom and World Wide Fund for Nature opposed it.'

Summary record CoP19 Com I. Rec. 7 was adopted with this amendment.

Species specific matters

89. Proposals to amend Appendices I and II

Singapore, on behalf of the co-proponents, introduced proposal **CoP19 Prop. 9 (Rev. 1)** to transfer *Pycnonotus zeylanicus* (Straw-headed bulbul) from Appendix II to Appendix I. It noted that the species met the criteria for inclusion in Appendix I, having undergone a rapid and marked population decline, estimated at 80% over three generations, due to trapping of wild birds for the songbird trade and compounded by habitat loss.

Benin, China, the European Union and its Member States, Guatemala, Kuwait, the Lao People's Democratic Republic, Nigeria, Senegal, Somalia, Thailand, Viet Nam, Humane Society International speaking also on behalf of the Species Survival Network, and TRAFFIC, speaking also on behalf of a number of other observer organizations, supported the proposal.

Indonesia and Namibia opposed the proposal, stating that Appendix II sufficiently controlled trade in *P. zeylanicus* and considering an Appendix-I listing to be premature. Indonesia noted that the species had been successfully captive-bred by numerous breeders in Indonesia for the songbird trade. Indonesia, supported by Namibia, proposed an amendment to add a 24-month implementation delay if the proposal were adopted. Singapore and co-proponents proposed a 12-month delay in implementation. Indonesia concurred.

Proposal CoP19 Prop. 9 (Rev. 1), to transfer *Pycnonotus zeylanicus* from Appendix II to Appendix I amended with the annotation "entry into effect of the inclusion in Appendix I delayed by 12 months", was <u>accepted</u> by consensus.

The United States of America introduced proposal **CoP19 Prop. 10** to transfer *Phoebastria albatrus* (Shorttailed albatross) from Appendix I to Appendix II based on the outcome of the Animals Committee's Periodic Review of the Appendices. It explained that the species no longer met the criteria for listing in Appendix I, following successful international conservation efforts that had resulted in substantial and ongoing population recovery.

China asked for the following statement to be included in the summary record of the meeting:

With respect to the geographical designations regarding China's Taiwan, Hong Kong, Macao and Diaoyu Dao Islands employed in the Proposals 10, 7, 23,24, 31 and 32 submitted by the United States of America, I would like to make the following statement on behalf of the Government of the People's Republic of China:

First, there is only one China in the world. The Government of the People's Republic of China is the sole legal government representing the whole of China. Taiwan is an inalienable part of the Chinese territory. The "one China" principle is one of the fundamental norms governing international relations. Any act that creates "two Chinas" or "one China, one Taiwan" violates international law.

The US proposals have a large number of incorrect descriptions that list Taiwan as a country and fail to correctly indicate that Taiwan Province is part of China. What US has done violates the US government's repeatedly declared position of adhering to the "One China" principle and constitutes a gross violation of China's sovereignty and territorial integrity.

Second, the Chinese government resumed the exercise of sovereignty over Hong Kong and Macao in 1997 and 1999 respectively. The Hong Kong Special Administrative Region and the Macao Special Administrative Region are the two special administrative regions of the People's Republic of China and inseparable parts of the Chinese territory.

The US's proposals contain incorrect descriptions that equate Hong Kong and Macao with China and fail to correctly indicate that Hong Kong and Macao are special administrative regions of China.

Third, the Diaoyu Dao Island and its affiliated islands have been Chinese territory since ancient times. China has indisputable sovereignty over the Diaoyu Dao Island and its affiliated islands. This fact has been confirmed by a number of international law documents.

The US proposals use the term of Senkaku Island to label the Diaoyu Dao Island and its affiliated islands, and describing them as Japan's territory. This is a gross violation of China's sovereignty and territorial integrity and a intentional violation of international law.

The Chinese side firmly opposes the above wrong expressions in the US proposals regarding China's Taiwan, Hong Kong SAR and Macao SAR, and the Diaoyu Dao Islands. China' competent authorities and institutions have lodged solemn protests against the US administration directly and through the Secretariat of the Convention, and reserve rights to make further actions against US.

Japan asked for the following statement to be included in the summary record of the meeting:

In the annex of the notification No.2022/067 dated 19 September 2022, China commented on the proposal COP19 Prop.10 submitted by the United States of America. The Chinese comments in the annex of the notification are not acceptable for the Government of Japan for the following reasons.

- There is no doubt that the Senkaku Islands are indisputably an inherent territory of Japan, in light of historical facts and based upon international law.
- Indeed, the Senkaku Islands are under the valid control of Japan. There exists no issue of territorial sovereignty to be resolved concerning the Senkaku Islands.

In this regard, the Government of Japan would like to express that the Chinese comments have no place to be discussed at meetings of CITES, including this COP 19.

Cambodia, Canada, Guatemala, Mexico and New Zealand supported the proposal, congratulating range States on having successfully improved the conservation status of the species.

Proposal CoP19 Prop. 10 to transfer *Phoebastria albatrus* from Appendix I to Appendix II was <u>accepted</u> by consensus.

Brazil introduced proposal **CoP19 Prop 11** to transfer the Brazilian population of broad-snouted caiman *Caiman latirostris* from Appendix I to Appendix II. Brazil amended the proposal to add the annotation "a zero annual export quota for wild specimens traded for commercial processes" in line with the Secretariat's suggestion in document CoP19 Doc. 89.1 (Rev.1). It explained that the species no longer meets the criteria for inclusion in Appendix I and added that, if accepted, international trade would only be allowed for specimens bred in captivity.

Bahrain, Cuba, the European Union and its Member States, Guatemala, Peru, the German Society of Herpetology, and TRAFFIC also on behalf of the International Union for Conservation of Nature (IUCN) supported the proposal. Argentina and Kenya also supported the amended proposal. TRAFFIC speaking also on behalf IUCN noted that the proposal did not clearly outline the management measures that would be implemented in the event of a transfer to Appendix II as each Brazilian State is responsible for defining its own management mechanisms; they offered their support to Brazil with regard to conducting a wider evaluation of management criteria if requested. Brazil stated that it would take the recommendations on management measures into consideration.

Proposal CoP19 Prop 11 to transfer the Brazilian population of *Caiman latirostris* from Appendix I to Appendix II with an annotation to include a zero export quota for wild specimens traded for commercial purposes was <u>accepted</u> by consensus.

Proposal CoP19 Prop. 12 to transfer the Philippine population of *Crocodylus porosus* in Palawan Islands from Appendix I to Appendix II, with a zero export quota for wild specimens, was introduced by the Philippines, proposing an amendment to the proposed annotation to read: 'with an annual zero export quota for wild specimens traded for commercial purposes'.

China, Colombia, Ethiopia, the European Union and its Member States, Kenya, Namibia, the Solomon Islands, and Zimbabwe supported the proposal as amended.

IUCN, speaking also on behalf of TRAFFIC, drew attention to the fact that adoption of the proposal would result in a split-listing for the species within the Philippines and encouraged the Philippines to consider the associated practical regulatory problems.

Proposal CoP19 Prop. 12 to transfer the Philippine population of *Crocodylus porosus* in Palawan Islands from Appendix I to Appendix II, with a zero annual export quota for wild specimens traded for commercial purposes, was <u>accepted</u> by consensus.

Proposal CoP19 Prop. 13 to transfer the Thai population of *Crocodylus siamensis* from Appendix I to Appendix II with a zero quota for wild specimens was presented by Thailand with an amendment to the proposed annotation to specify with a zero quota for wild specimens traded for commercial purposes'.

Australia, Benin, Eritrea, the European Union and its Member States, Indonesia, Israel and the United Kingdom of Great Britain and Northern Ireland opposed the proposal, several citing the fragility of the wild population of *Crocodylus siamensis* in Thailand.

Cambodia, China, the Democratic Republic of the Congo, the Lao People's Democratic Republic, Zimbabwe and Wildlife Management International supported the proposal, Cambodia highlighting transfers of taxa from Appendix I to Appendix II as conservation successes.

The Chair granted Thailand's request for a vote on the amended proposal. There were 27 votes in favour, 76 against and 20 abstentions; proposal CoP19 Prop. 13 was <u>rejected</u>.

India introduced **proposal CoP19 Prop. 15** to include *Cyrtodactylus jeyporensis* in Appendix II, highlighting its limited distribution and apparent high demand amongst reptile breeders and traders.

The European Union and its Member States, Niger, and the Wildlife Trust of India, speaking also on behalf of a number of observer organizations, supported the proposal, the European Union and its Member States noting that high demand and consequent high prices might drive unsustainable exploitation.

Proposal CoP19 Prop. 7 to include Cyrtodactylus jeyporensis in Appendix II was accepted by consensus.

Viet Nam introduced **proposal CoP19 Prop. 14** to include *Physignathus cocincinus* in Appendix II. Viet Nam highlighted that pressure from harvesting on wild populations was likely to be high, noting high levels of import into the European Union and its Members States and the United States of America.

The Democratic Republic of the Congo, the European Union and its Member States (as co-proponents), the Lao People's Democratic Republic, Thailand, and the United Kingdom of Great Britain and Northern Ireland supported the proposal.

Benin, Burkina Faso, Burundi, Central African Republic, Congo, Gabon, the Gambia, Ghana, Guinea, Guinea Bissau, Kenya, Liberia, Niger, Nigeria, Senegal, and Togo opposed the proposal, being of the view that available scientific data were insufficient to justify inclusion in Appendix II and suggesting national management as more appropriate.

Seeing no consensus, the Chair moved to a vote. With 81 in favour, 27 against and 20 abstentions proposal CoP19 Prop. 14 to include *Physignathus cocincinus* in Appendix II was <u>accepted</u>.

The meeting was adjourned at 17h00.
