# CONVENTION ON INTERNATIONAL TRADE IN ENDANGERED SPECIES OF WILD FAUNA AND FLORA

### Summary record of the fourth session for Committee II

The Chair of the Credentials Committee (Morocco) reported that 151 Parties were present and 139 credentials had been accepted.

#### **Strategic matters**

#### 16. Capacity-building

New Zealand introduced document CoP19 Doc. 16 on behalf of the Standing Committee, reporting on progress with Decisions 18.39-18.46 and noting work conducted by the Standing Committee working group on capacity-building. The annexes to the document contained a draft new resolution to replace Resolution Conf 3.4 on *Technical cooperation*, and four draft decisions to continue work on the development of the capacity-building framework. The Standing Committee also recommended deletion of Decisions 18.39 to 18.46 as these had been implemented.

Benin, Cameroon, the Democratic Republic of Congo, the European Union and its Member States, Maldives, Mexico, Niger, Senegal, Togo, the United States of America, and the Sea Save Foundation expressed general support for the adoption of the draft decisions and the draft resolution in the document. Benin, Maldives and Niger expressed support for the amendments proposed by the Secretariat to paragraph 4 of the draft resolution, while Mexico and the United States proposed amendments to the Secretariat's proposed text. The European Union and its Member States proposed an amendment to paragraph 2 b) of the draft resolution in Annex 1.

Benin, Cameroon, the Democratic Republic of the Congo, Niger, Senegal and Togo highlighted capacity and resource needs and the importance of capacity-building, and, with Bahrain, acknowledged the value of the CITES Masters course run by the International University of Andalucia. China provided information on a

proposed exchange programme for sharing expertise and collaborative research. The International University of Andalucia noted that more than 100 graduates of the CITES Masters course were present at CoP19 and indicated that the course would run again in 2023-2024.

After some deliberation, the draft resolution was <u>accepted</u> with the following amendments proposed by the European Union and its Member States, Mexico and the United States of America:

#### 2. INVITES Parties to:

[...]

b) ensure the inclusion of capacity-building, including targeted, technical, enforcement and compliance assistance, in the <u>relevant</u> bilateral and multilateral <u>cooperation</u> programmes <del>of development aid in which they participate</del>; and

#### 4. DIRECTS the Secretariat to:

- a) seek external funding and provide capacity-building support to Parties', paying particular attention to the needs of Parties particularly needs identified in Resolutions and Decisions and through compliance procedures, considering CITES implementation reports and direct expressions of interest and needs of Parties, giving priority to those Parties recently acceded Parties, and the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States; ...
- b) cooperate with institutions and organizations in planning and delivering joint capacity-building activities of relevance to the Convention, in consultation with the Standing Committee and with the Animals and Plants Committees, as appropriate, as they relate to the development of new partnerships that have a scientific nexus or new or revised capacity-building materials of a scientific nature, including scholarships for in-person training or training opportunities;

. . .

- d) continue to undertake the revision and enhancement of the CITES website and of the CITES Virtual College, in consultation with the Standing Committee and with the Animals and Plants Committees, as appropriate, including selected online courses, to update the content and to improve their effectiveness in providing access to capacity-building resources to Parties; and
- e) report to the Standing Committee and to the Animals and Plants Committees on capacity-building activities and seek their advice and input, as appropriate;

The draft decisions in Annex 2 to document CoP19 Doc. 16 were <u>accepted</u>, and it was <u>agreed</u> that Decisions 18.39-18.46 be deleted.

### 30. Compliance Assistance Programme

The Chair of the Standing Committee introduced CoP19 Doc. 30, which outlined the establishment of a Compliance Assistance Programme (CAP) to provide targeted support to Parties facing persistent compliance challenges. The annexes to the document contained proposed amendments to Resolution Conf. 14.3 (Rev. CoP18) *CITES compliance procedures*, draft decisions on the implementation of the Compliance Assistance Programme and a tentative budget for implementation.

Benin, Burkina Faso, China, the Democratic Republic of the Congo, the European Union and its Member States, Gabon, Guinea, Guinea-Bissau, Mali, Nigeria, Senegal and Togo supported the proposed amendments and draft decisions.

Benin, Burkina Faso, the Democratic Republic of the Congo, Gabon, Guinea, Guinea Bissau, Mali, Senegal and Togo stressed challenges associated with implementation of the Convention and the continuing need

for the Compliance Assistance Programme. China offered to share experience in capacity-building. The Pan African Wildlife Conservation Network noted the risks faced by wildlife officials working on the ground and suggested that protection against such risks be integrated into training programmes.

The proposed amendments to Resolution Conf. 14.3 (Rev. CoP18) on *CITES compliance procedures* in Annex 1 to document CoP19 Doc. 30 were <u>accepted</u>, as were the draft decisions in Annex 2. It was <u>agreed</u> to delete Decisions 18.68, 18.69 and 18.70.

### 31. Country-wide Significant Trade Reviews

The Chair of the Animals Committee introduced document CoP19 Doc. 31, outlining progress in the implementation of Decisions 18.71 to 18.73 and proposing the adoption of draft decisions contained in Annex 1 to the document.

The United States of America supported the draft decisions and the deletion of Decisions 18.71 to 18.73.

The draft decisions in Annex 1 to document CoP19 Doc. 31 were <u>accepted</u>. It was <u>agreed</u> to delete Decisions 18.71 to 18.73.

#### **Strategic matters**

#### 13. Engagement of indigenous peoples and local communities

Kenya introduced document CoP19 Doc. 13 on behalf of the Standing Committee, drawing attention to the draft decision 19.AA under comments of the Secretariat and the proposed revisions to Decisions 17.57 (Rev. CoP18), 18.31 and 18.32 contained in Annex 1.

Botswana, Canada, China, the Democratic Republic of the Congo, Guinea, Namibia, the United Kingdom of Great Britain and Northern Ireland, Zambia, the International Union for Conservation of Nature (speaking also on behalf of TRAFFIC and World Wide Fund for Nature) and the International Council for Game and Wildlife Conservation supported the proposed revisions in Annex 1, as well as the draft decision 19.AA proposed in the Secretariat's comments on the document. China, Uganda, the United Kingdom, Zambia and Ngamiland Council of NGOs recognized that delays to planned intersessional work due to unavoidable circumstances but stressed the need for progress and concrete action on this issue. Gabon, Kenya, Togo, Uganda, the United Republic of Tanzania and Amboseli Ecosystem Trust also supported the proposed revision of Decision 18.31. Ngā lwi o Taranaki emphasized the importance of this matter and supported the recommendations contained in the document.

The United States of America was of the opinion that Parties should engage indigenous peoples and local communities (IPLC) in CITES processes at national level. It supported revised Decisions 18.31 (Rev. CoP19) and 18.32 (Rev. CoP19) as well as paragraph b) in draft decision 19.AA proposed by the Secretariat in its comments but did not support revised Decision 17.57 (Rev. CoP19) and paragraph a) in draft decision 19.AA proposed by the Secretariat in its comments.

New Zealand drew attention to information document CoP19 Inf. 29 that provides information relating to the engagement of indigenous and local people in other international treaties and processes. Switzerland highlighted the importance of the matter that was also emphasized in the IPBES Assessment on the sustainable use of wild species; reflected on the similarities between the current agenda item and items 14 and 15; and the need for improved communication on these matters.

Togo, supported by Gabon, Kenya, the United States of America, David Shepherd Wildlife Foundation and Kenya Wildlife Conservancies Association, did not support the Secretariat's proposed insertion of 'and international' in draft decision 19.AA, stating that engagement of IPLCs in CITES processes was possible through admission of observers.

China requested a vote on the inclusion of 'and international' in draft decision 19.AA a) of document CoP19 Doc. 13. Thirty Parties voted in favour, 48 against, and 14 abstained; the inclusion of the language 'and international' was therefore not accepted.

The revised Decisions 17.57 (Rev. CoP19), 18.31 (Rev. CoP19) and 18.32 (Rev. CoP19) were <u>accepted</u>, as was the draft decision 19.AA with the exception of the text 'and international' in paragraph a).

#### 14. Livelihoods

Peru, as the Chair of the intersessional working group on CITES and livelihoods, introduced document CoP19 Doc. 14, which provided a brief summary of the activities of the working group to implement Decisions 18.33 to 18.37. Annex 1 contained revised versions of these Decisions proposed for renewal. Peru drew attention to the Secretariat's comments, including the proposed transfer of paragraph b) of Decision 18.33 (Rev. CoP19) to document CoP19 Doc. 13 in order to resolve overlapping Decisions and provide clear mandates to the different working groups.

China, Maldives and Mexico supported the adoption of the revised decisions.

Burkina Faso, Israel and Togo, opposed the acceptance of revised Decisions 18.33 to 18.35, expressing particular concern with the valuation of species included in the CITES Appendices without consideration of how the benefits of such trade might be distributed.

The meeting was adjourned at 17h00.
