Examen périodique des espèces inscrites à l'Annexe I et à l'Annexe II

VUE D'ENSEMBLE DES ESPÈCES DANS L'EXAMEN PÉRIODIQUE

1. Le présent document a été préparé par le Secrétariat.
2. Dans la résolution Conf. 12.8 (Rev. CoP19), *Étude du commerce important de spécimens d'espèces de l'Annexe II*, la Conférence des Parties a convenu d'un processus et de lignes directrices pour guider l'examen périodique, par le Comité pour les animaux et le Comité pour les plantes, des espèces d'animaux ou de plantes inscrites aux annexes de la CITES. Au paragraphe 7, la Conférence des Parties :
 7. *DONNE INSTRUCTION au Secrétariat de tenir un registre des espèces sélectionnées pour un examen périodique, y compris des espèces ayant fait l'objet ou faisant actuellement l'objet d'un examen, des dates des documents pertinents des Comités, des recommandations issues des examens, et de tout rapport et document connexes.*
3. Le dernier calendrier pour l'examen périodique des annexes reste celui entamé à la suite de la 17^e session de la Conférence des Parties (CoP17 ; Johannesburg, 2016). Le dernier registre des espèces sélectionnées pour un examen périodique a été communiqué par le Secrétariat à la séance conjointe de la 31^e session du Comité pour les animaux et de la 25^e session du Comité pour les plantes (AC31/PC25, en ligne, juin 2021) dans le document AC31 Doc. 41.1/PC25 Doc. 39.1.
4. Faute de ressources suffisantes, le Secrétariat n'a pas été en mesure de réaliser l'évaluation décrite au paragraphe 3 b) de la résolution Conf. 14.8 (Rev. CoP19) pour examen à la 26^e session du Comité pour les plantes (PC26 ; Genève, juin 2023) et à la 32^e session du Comité pour les animaux (AC32 ; Genève, juin 2023). En conséquence, le Comité pour les animaux et le Comité pour les plantes n'ont pas pu établir de nouveau calendrier pour l'examen périodique ni dresser une liste de taxons qu'ils proposent d'examiner au cours des deux prochaines périodes intersessions lors de la première session de chacun des deux Comités suivant la session de la Conférence des Parties. Conformément au paragraphe a) de ladite résolution, une nouvelle période d'examen aurait dû démarrer à la première session suivant la 19^e session de la Conférence des Parties (CoP19 ; Panama, 2022).
5. Le Secrétariat a obtenu les ressources nécessaires pour donner un aperçu des espèces faisant l'objet d'un examen périodique dans le présent document et pour entreprendre l'évaluation requise comme indiqué au paragraphe 3 b) et dans l'annexe à la résolution afin de sélectionner de manière éclairée les espèces proposées pour examen (voir documents PC27 Doc. 33.2 et AC33 Doc. 45.2).

Vue d'ensemble des espèces dans l'examen périodique

6. Les examens périodiques en cours pour les espèces d'animaux concernent les espèces prévues au calendrier pour les périodes d'examen CoP15 (2010) - CoP17 (2016), CoP16 (2013) - CoP18 (2019) et CoP17 (2016) - CoP19 (2022).

7. En ce qui concerne les espèces sélectionnées pour examen sur la période allant de la CoP17 à la CoP19, la 31^e session du Comité pour les animaux (AC31 ; en ligne, juin 2021) a examiné trois rapports présentés par le Mexique (documents AC31 Doc. 41.2, *Cynomys mexicanus*, AC31 Doc. 41.3, *Terrapene coahuila* et AC31 Doc. 41.4, *Aphonopelma pallidum*). Le Comité pour les animaux a appuyé les recommandations figurant dans les examens périodiques présentées par le Mexique (voir le compte rendu résumé AC31 SR), à savoir :
 - a) le transfert de *Cynomys mexicanus* de l'Annexe I à l'Annexe II,
 - b) le maintien de *Terrapene coahuila* à l'Annexe I, et
 - c) le maintien d'*Aphonopelma pallidum* l'Annexe II.
8. En outre, les États-Unis d'Amérique ont présenté deux rapports à la 31^e session du Comité pour les animaux (documents AC31 Doc. 41.5, *Branta canadensis leucopareria* et AC31 Doc. 41.6, *Phoebastria albatrus*). Le Comité pour les animaux a appuyé les recommandations figurant dans les examens périodiques présentés par les États-Unis d'Amérique (voir le compte rendu résumé AC31 SR), à savoir :
 - a) le transfert de *Branta canadensis leucopareria* de l'Annexe I à l'Annexe II, et
 - b) le transfert de *Phoebastria albatrus* de l'Annexe I à l'Annexe II.
9. Le Mexique a ensuite soumis une proposition d'amendement en vue du transfert de *Cynomys mexicanus* de l'Annexe I à l'Annexe II à la CoP19 (proposition CoP19 Prop. 6) et les États-Unis d'Amérique ont soumis des propositions d'amendement en vue du transfert de *Branta canadensis leucopareria* (proposition CoP19 Prop. 7) et de *Phoebastria albatrus* (proposition CoP19 Prop. 10) de l'Annexe I à l'Annexe II à la CoP19. Ces propositions ont été acceptées par consensus au sein du Comité I et adoptées par la Conférence des Parties à sa 19^e session [CoP19 Plen. Rec. 4 (Rev. 1)].
10. À sa 32^e session, le Comité pour les animaux a examiné le rapport du spécialiste de la nomenclature zoologique (voir document AC32 Doc. 46), lequel comprenait une section consacrée à *Ramphastos (vitellinus) citreolaemus* (toucan ariel). L'espèce a été inscrite « accidentellement » à l'Annexe II après adoption de la mise à jour d'une référence de nomenclature normalisée pour les oiseaux et en raison de procédures complexes liées à l'inscription de l'espèce à l'Annexe II. Le Comité pour les animaux a étudié la question et proposé d'inclure *Ramphastos (vitellinus) citreolaemus* dans l'examen périodique ; il a invité les représentants de l'Amérique centrale, de l'Amérique du Sud et des Caraïbes à trouver un volontaire de leur région pour mener cet examen. Les États-Unis d'Amérique ont proposé d'offrir une assistance technique en vue de l'examen. Le Secrétariat n'a reçu aucune confirmation de la part d'États de l'aire de répartition s'étant portés volontaires pour réaliser l'examen.
11. Le Mexique a soumis les deux examens suivants pour étude à la 33^e session du Comité pour les animaux :
 - a) *Arctocephalus townsendi* (voir document AC33 Doc. 45.3) – L'espèce a été sélectionnée à la 29^e session du Comité pour les animaux (AC29, Genève, 2017). (AC29 Com. 7 (Rev. by Sec.)).
 - b) *Monachus tropicalis* (voir document AC33 Doc. 45.4) – L'espèce a été sélectionnée lors de la 25^e session du Comité pour les animaux (AC25, Genève, 2011) (AC25 Doc. 15.6 Annexe 2; AC25 WG3 Doc. 1 et Compte rendu résumé de l'AC25). Une décision avait été reportée dans l'attente de la décision de la Conférence des Parties sur le traitement des espèces éteintes, laquelle a été prise à la CoP17.
12. Conformément au paragraphe 7 de la résolution Conf. 14.8 (Rev. CoP19), le présent document contient le registre des espèces d'animaux sélectionnées pour examen par le Comité pour les animaux, comme suit :
 - a) **Annexe 1A :** espèces d'animaux sélectionnées pour examen entre la 13^e et la 15^e sessions de la Conférence des Parties (CoP13, Bangkok, 2004 et CoP15, Doha, 2010) ;

17. En ce qui concerne les espèces sélectionnées pour examen au cours de la période allant de la CoP17 à la CoP19, la 25^e session du Comité pour les plantes (PC25 ; en ligne, juin 2021) a examiné deux rapports établis par le Mexique (voir les documents PC25 Doc. 39.2, *Ariocarpus retusus*, et PC25 Doc. 39.3,

CoP16) have been met. The Plants Committee, at its 21st meeting, agreed that there is insufficient information to determine if the 17 species of *Aloe* spp. in Appendix I; 17 species of *Didiereaceae* spp. in Appendix II and 10 species of *Euphorbia* spp. in Appendix I that were selected for the review period CoP13-CoP15 are appropriately listed in the Appendices. Madagascar was requested to submit a revised and updated version of Annex 5 of document [PC18 Doc. 16.1.1](#) to PC22, which should contain recommendations for the appropriate listing of the species and which should be translated. At PC22, Madagascar introduced document [PC22 Doc. 20.3.1](#). While noting that *Didiereaceae* was not endemic to Madagascar, speakers supported the conclusion reached by Madagascar, proposing no change to the current listing of these species. The review of *Aloe helenae* from Madagascar is ongoing (see Annex 1).
