Examen periódico de las especies incluidas en los Apéndices I y II

**CUADRO PANORÁMICO DE LAS ESPECIES INCLUIDAS EN EL EXAMEN**

1. Este documento ha sido preparado por la Secretaría.
2. En la Resolución Conf. 14.8 (Rev. CoP19), sobre *Examen periódico de especies incluidas en los Apéndices I y II*, la Conferencia de las Partes acordó un proceso y unas directrices para que los Comités de Fauna y de Flora realizasen un examen periódico de las especies de fauna y flora incluidas en los Apéndices de la CITES. En el párrafo 7 de la resolución, la Conferencia de las Partes:

“7. ENCARGA a la Secretaría que mantenga un registro de las especies seleccionadas para el examen periódico, incluyendo las especies examinadas previa y actualmente; las fechas de los documentos relevantes del Comité; las recomendaciones derivadas de los exámenes; y cualquier informe o documentos asociados.”.
3. El calendario más reciente para el examen periódico de los Apéndices sigue siendo el iniciado tras la 17<sup>a</sup> reunión de la Conferencia de las Partes (CoP17; Johannesburgo, 2016). El registro más reciente de las especies seleccionadas para el examen periódico fue comunicado por la Secretaría en la reunión conjunta de la 31<sup>a</sup> reunión del Comité de Fauna y la 25<sup>a</sup> reunión del Comité de Flora (AC31/PC25, en línea, junio de 2021) en el documento [AC31 Doc. 41.1/PC25 Doc. 39.1](#).
4. Debido a la falta de recursos, la Secretaría no pudo realizar la evaluación prevista en el párrafo 3 b) de la Resolución Conf. 14.8 (Rev. CoP19) para su consideración por la 26<sup>a</sup> reunión del Comité de Flora (PC26; Ginebra, junio de 2023) y la 32<sup>a</sup> reunión del Comité de Fauna (AC32; Ginebra, junio de 2023). En consecuencia, los Comités de Fauna y de Flora no pudieron establecer un nuevo calendario para el examen periódico o preparar una lista de las especies cuyo examen proponen durante los dos próximos períodos entre reuniones en la primera reunión de los Comités después de la reunión de la Conferencia de las Partes. En relación con el párrafo a) de la Resolución, debería haberse iniciado un nuevo período de examen en la primera reunión después de la 19<sup>a</sup> reunión de la Conferencia de las Partes (CoP19; Ciudad de Panamá, 2022).
5. La Secretaría obtuvo los recursos necesarios para proporcionar una visión general de las especies objeto de examen periódico en el presente documento e iniciar la evaluación correspondiente como se especifica en el párrafo 3 b) y en el Anexo de la resolución para fundamentar la selección de las especies propuestas para su examen (véase el documento PC27 Doc. 33.2 / AC33 Doc. 45.2).

Cuadro panorámico de especies de fauna incluidas en el proceso de examen periódico

6. Los exámenes periódicos en curso para las especies de fauna se refieren a las especies seleccionadas en los calendarios para los períodos de examen CoP15 (2010) – CoP17 (2016), CoP16 (2013) – CoP18 (2019) y CoP17 (2016) – CoP19 (2022).

7. En relación con las especies seleccionadas para su examen durante el periodo comprendido entre la CoP17 y la CoP19, en la 31<sup>a</sup> reunión del Comité de Fauna (AC31; en línea, junio de 2021) se consideraron tres informes presentados por México (documentos [AC31 Doc. 41.2](#), [AC31 Doc. 41.3](#) y [AC31 Doc. 41.4](#)) sobre *Cynomys mexicanum*, *Terrapene coahuila* y *Aphonopelma pallidum*. El Comité de Fauna apoyó las recomendaciones formuladas por México (véase el acta resumida [AC31 SR](#)):
  - a) transferir *Cynomys mexicanum* del Apéndice I al Apéndice II,
  - b) retener *Terrapene coahuila* en el Apéndice I, y
  - c) retener *Aphonopelma pallidum* en el Apéndice II.
8. Adicionalmente, Estados Unidos presentó dos informes en la AC31 (documentos [AC31 Doc. 41.5](#) y [AC31 Doc. 41.6](#)) sobre *Branta canadensis leucopareria* y *Phoebastria albatrus*. El Comité de Fauna apoyó las recomendaciones formuladas por Estados Unidos (véase el acta resumida [AC31 SR](#)):
  - a) transferir *Branta canadensis leucopareria* del Apéndice I al Apéndice II, y
  - b) transferir *Phoebastria albatrus* del Apéndice I al Apéndice II.
9. Posteriormente, México presentó una enmienda a la transferencia de *Cynomys mexicanum* del Apéndice I al Apéndice II en la CoP19 (propuesta [CoP19 Prop. 6](#)) y Estados Unidos presentó enmiendas a las propuestas de transferir *Branta canadensis leucopareria* ([CoP19 Prop. 7](#)) y *Phoebastria albatrus* ([CoP19 Prop. 10](#)) del Apéndice I al Apéndice II en la CoP19. Las propuestas fueron aceptadas por consenso en el Comité I y adoptadas por la Conferencia de las Partes en su 19<sup>a</sup> reunión [[CoP19 Plen. Rec. 4 \(Rev. 1\)](#)].
10. En la AC32, el Comité examinó el informe del especialista en nomenclatura zoológica (véase el documento [AC32 Doc. 46](#)) que incluía una sección sobre *Ramphastos (vitellinus) citreolaemus* (tucán de pico acanalado). La especie se incluyó ‘accidentalmente’ en el Apéndice II basándose en la adopción de una referencia normalizada actualizada para las aves y las complejidades relacionadas con la inclusión de la especie en el Apéndice II. El Comité de Fauna examinó la cuestión y propuso incluir *Ramphastos (vitellinus) citreolaemus* en el examen periódico e invitó a los representantes de América Central, del Sur y el Caribe a coordinarse para buscar un voluntario de su región para realizar el examen. Estados Unidos de América se ofreció a prestar apoyo técnico para el examen. La Secretaría no ha recibido confirmación de ningún Estado del área de distribución ofreciéndose como voluntario para realizar el examen.
11. México presentó los dos exámenes siguientes a la consideración de la 33<sup>a</sup> reunión del Comité de Fauna:
  - a) *Arctocephalus townsendi* (véase el documento AC33 Doc. 45.3) – La especie se seleccionó en la 29<sup>a</sup> reunión del Comité de Fauna (AC29, Ginebra, 2017) ([AC29 Com. 7](#) (Rev. por la Sec.).
  - b) *Monachus tropicalis* (véase el documento AC33 Doc. 45.4) – La especie se seleccionó en la 25<sup>a</sup> reunión del Comité de Fauna (AC25, Ginebra, 2011) ([AC25 Doc. 15.6 Anexo 2](#); [AC25 WG3 Doc. 1](#) y [acta resumida AC25](#)). Se aplazó una decisión pendiente de la decisión de la Conferencia de las Partes sobre el tratamiento de las especies extinguidas, que se concluyó en la CoP17.
12. En cumplimiento del párrafo 7 de la Resolución Conf. 14.8 (Rev. CoP19), el presente documento contiene el registro de las especies de fauna seleccionadas para su examen por el Comité de Fauna, como sigue:
  - a) **Anexo 1A:** registro de las especies de fauna seleccionadas para su examen entre las reuniones 13<sup>a</sup> y 15<sup>a</sup> de la Conferencia de las Partes (CoP13, Bangkok, 2004 y CoP15, Doha, 2010);
  - b) **Anexo 1B:** registro de las especies de fauna seleccionadas para su examen entre la CoP15 y la 17<sup>a</sup> reunión de la Conferencia de las Partes (CoP15, Doha, 2010 y CoP17, Johannesburgo, 2016)

13. La Secretaría propone las siguientes medidas en relación con las especies respecto de las que no se había finalizado el examen pendiente de la decisión de la Conferencia de las Partes sobre el tratamiento de las especies extinguidas, que se concluyó en la CoP17 [véase el documento de la sesión [CoP17 Com. I.19](#)) y el acta resumida [CoP17 Plen. 4 \(Rev. 1\)](#)]:

*CoP15 a CoP17 – Especies seleccionadas en la 25<sup>a</sup> reunión del Comité de Fauna (AC25; Ginebra, julio de 2011)*

Recomendaciones

Se invita a los Comités de Fauna y de Flora a tomar nota del documento y de la actualización oral proporcionada por la Secretaría y considerar y acordar la eliminación de las especies del examen periódico con arreglo a lo propuesto por la Secretaría en los párrafos 13, 14 y 19 y solicitar a la Secretaría que actualice los registros en los Anexos, en consecuencia.

At PC22, Madagascar introduced document [PC22 Doc. 20.3.1](#). While noting that Didiereaceae was not endemic to Madagascar, speakers supported the conclusion reached by Madagascar, proposing no change to the current listing of these species. The review of *Aloe helenae* from Madagascar is ongoing (see Annex 1).
