## REVIEW OF REPORTING REQUIREMENTS (DECISION 16.45)

1. This document has been prepared by the Chair of the Standing Committee Working Group on Special Reporting Requirements<sup>1</sup>, in consultation with the Secretariat.

### Background

2. At its 16th meeting (CoP16, Bangkok, 2013), the Conference of the Parties adopted Decision 16.45 on *Review of Reporting Requirements*, as follows:

### Directed to the Animals and Plants Committees

- 16.45 The Animals and Plants Committees, with the assistance of the Standing Committee Working Group on Special Reporting Requirements and the Secretariat, shall undertake the following actions at their 27th meeting (AC27) and 21st meeting (PC21), respectively:
  - a) review the special reporting requirements identified by the Standing Committee Working Group on Special Reporting Requirements which relate to animals and plants, respectively;
  - b) assess whether any of these reporting requirements are still current and valid, or whether they are outdated or otherwise unnecessary and can be considered for deletion; and
  - c) advise the Standing Committee Working Group on Special Reporting Requirements of the results of the review and assessments mentioned in paragraphs a) and b) above, in a timely manner, so that it can provide a collated report on valid reporting requirements for the 65th meeting of the Standing Committee (SC65).

Three other decisions on the same subject were directed to the Parties (Decision 16.43), the Standing Committee (Decision 16.44) and the Secretariat (Decision 16.46), respectively.

The geographical designations employed in this document do not imply the expression of any opinion whatsoever on the part of the CITES Secretariat or the United Nations Environment Programme concerning the legal status of any country, territory, or area, or concerning the delimitation of its frontiers or boundaries. The responsibility for the contents of the document rests exclusively with its author.

- 3. The Standing Committee Working Group on Special Reporting Requirements have undertaken a multiyear review of the reporting requirements agreed by CITES Parties. Details of the work undertaken so far have been provided to the 61st meeting of the Standing Committee (SC61, Geneva, August 2011) in document SC61 Doc. 24, the 62nd meeting of the Standing Committee (SC62, Geneva, July 2012) in document SC62 Doc 24.2, and the 16th meeting of the Conference of the Parties in document CoP16 Doc. 30.
- 4. In order to facilitate its review task, the Working Group developed a spreadsheet of reporting requirements. This was intended to serve as a resource to give the Group an idea of the numbers of requests for information received by Parties and illustrate the types of special reporting requests which have arisen over the years.
- 5. The Working Group made recommendations in paragraph 40 of document SC62 Doc 24.2 to involve the Animals and Plants Committees in assessing whether any of these reporting requirements are still current and valid, or whether they are outdated or otherwise unnecessary and can be considered for deletion. At SC62, the Standing Committee agreed<sup>2</sup> to these recommendations, noting the need to avoid any unnecessary burden on Parties and the Secretariat. The implications of this are to seek to reduce the number of reporting requirements to the minimum necessary, and not to retain reporting requirements that impose unnecessary burdens. Draft decisions to take forward the recommendations, and other work, were made in Annex 4 of document CoP16 Doc. 30, which led to the adoption of Decision 16.45 by the Conference of the Parties.
- 6. Following CoP16, the spreadsheet of reporting requirements was revised by the Working Group on Special Reporting requirements to incorporate new requirements arising from deliberations at CoP16. Based on an analysis of the 57 reporting requirements identified, it is suggested that 18 may need to be reviewed by Animals Committee, nine by Plants Committee, and 47 by Standing Committee. For some of the requirements it is necessary to request more than one of the committees to undertake a review, depending on the relevance of the subject matter. The numbers given in this paragraph are slightly different to the figures given in paragraph 20 of document CoP16 Doc 30, as it has been determined that a few of the requirements are no longer valid, and more work has been undertaken since CoP16. A table listing the reporting requirements to be reviewed, and which Committee(s) should consider them is provided in Annex 1.
- 7. During its work, the Working Group has been guided by the following language contained in Resolution Conf. 11.17 (Rev. CoP16):

ACKNOWLEDGES that the Conference of the Parties may request that Parties provide special reports not required by the Convention, if additional information is needed that cannot be sought via the national reports required under Article VIII, paragraph 7, of the Convention;

RECOGNIZES that the Conference of the Parties, when requesting special reports, should give consideration to making those special reports time-limited, where this is appropriate, to avoid the potential for unnecessarily increasing reporting burdens;

- 8. The Group has also been guided by the following language contained in Resolution Conf. 4.6 (Rev. CoP15) under RECOMMENDS that:
  - when drafting resolutions and decisions which require the gathering of information, a Party consider whether such information could be sought via the annual or biennial report, or if a special report is needed, and generally ensure that the reporting burden is kept to a minimum;

## **Recommendations**

- 9. It is recommended that the Animals and Plants Committees review each of the reporting requirements identified in Annex 1 as being relevant to them (and others if they consider they are also relevant to the Animals or Plants Committees' remits) and advise in the last column of Annex 1 whether the requirement is:
  - a) still current and valid, or;

- b) outdated or otherwise unnecessary, and therefore no longer required.
- 10. The review requested in paragraph 9 above will aid the Working Group on Special Reporting Requirements to report at the 65th meeting of the Standing Committee (SC65, Geneva, July 2014). The Working Group report at SC65 will also cover other aspects of the group's mandate, including proposals to streamline the annual and implementation reports, and to align them more closely with the CITES Strategic Vision.

# REPORTING REQUIREMENTS, AND WHETHER THEY SHOULD BE REVIEWED BY STANDING, ANIMALS, OR PLANTS COMMITTEE(S)

- Row Key is the number of the reporting requirement in the spreadsheet developed by the Working Group on Special Reporting Requirements, and is included to allow cross reference with the spreadsheet, which is the master version of this information. If any reader wishes to have access to the actual spreadsheet they are recommended to contact the Chair of the Working Group via the Secretariat.
- SC = Standing Committee, AC = Animals Committee, PC = Plants Committee. A '1' in any of these columns indicates that the relevant committee should review the requirement and provide comment on whether it is still valid or not.
