OVERVIEW OF THE REVIEW OF SIGNIFICANT TRADE

- 1. This document has been prepared by the Secretariat.
- 2. In Resolution Conf. 12.8 (Rev. CoP17) on Review of Significant Trade in specimens of Appendix-II species, the Conference of the Parties:
 - 5. DIRECTS the Secretariat, for the purpose of monitoring and facilitating the implementation of this Resolution and the relevant paragraphs of Article IV:
 - a) to report at each meeting of the Animals or Plants Committee on the implementation by the range States concerned of the recommendations made by the Committee; and
 - b) to maintain a database of species/country combinations that are included in the review process set out in this Resolution including a record of progress with the implementation of recommendations:

Implementation by range States of recommendations made by the Animals Committee

- 3. The last update of the status of the Review of Significant Trade for fauna species was reported to the Animals Committee at its 29th meeting (AC29, Geneva, July 2017; see document AC29 Doc. 13.1). Six species/range State reviews were subsequently considered at the 69th meeting of the Standing Committee (SC69, Geneva, November 2017). The following three reviews were concluded at SC69: Mozambique/Hippopotamus amphibius, Malaysia/Python reticulatus and Thailand/Hippocampus trimaculatus. Three species from Togo were retained within the review: Pandinus imperator, Kinixys homeana and Chamaeleo gracilis.
- 4. In the case of *Python reticulatus*, the Standing Committee further urged Malaysia to publish their revised quota of 162,000 skins from peninsular Malaysia and requested Malaysia to share with Parties details of the size limits associated with their quota. In this regard, Malaysia wrote to the Secretariat on 5 March 2018 to notify an agreed quota of 155,000 skins for peninsular Malaysia for 2018. This figure is 7,000 skins less that the quota recommended by the Standing Committee. Malaysia also informed the Secretariat that it has introduced additional precautionary measures including a size limit restriction. Concerning the size limit, Malaysia stated that "effective from 1 April 2017, collection of wild *Python reticulatus* with snout-vent length (SVL) less than 2.4 m is prohibited". Any hunters who failed to comply with this regulation shall be fined up to MYR10,000 (approximately equivalent to 2,500 USD) or imprisonment not exceeding 1 year or both. Malaysia also pointed out that the dry skin size processed from live python with 2.4m SVL is estimated to be 280 cm in length and 30 cm in width. Based on this calculation, licenced skin traders were instructed to sell their entire skin stockpiles that are smaller than this size by 1 January 2018, and to declare any remaining skins of this size after this date. The number of allowable exports would be based on this declaration following checks by PERHILITAN officers. Following the introduction of this new measure, Malaysia anticipates a 13%

reduction in the total harvest of *P. reticulatus*. The Secretariat informed Malaysia that it would bring this information to the attention of the Parties at the present meeting of the Animals Committee.

- 5. The most recent list of countries under a recommendation to suspend trade for certain species selected for the Review of Significant Trade, and following non-compliance with Article IV of the Convention, was published in Notification to the Parties No. 2018/006 of 15 January 2018. The recommendations and decisions were made in accordance with Resolution Conf. 12.8 (Rev. CoP17), or Resolution Conf. 12.8 (Rev. CoP13), or its predecessor Resolution Conf. 8.9 (Rev.). The cases involving a suspension of trade are kept under regular review by the Standing Committee in line with paragraph 1 p) of Resolution Conf. 12.8 (Rev. CoP17).
- 6. The Annex to the present document provides an updated overview of all these ongoing cases (fauna species / range State combinations), with an indication of their current status under the review process, and the reference documents that provide detailed information for the cases in question. It also indicates the reviews that were completed since AC29.
- 7. At its 17th meeting (CoP17, Johannesburg, 2016), the Conference of the Parties adopted amendments to Resolution Conf. 12.8 (Rev. CoP13) on *Review of Significant Trade in specimens of Appendix-II species*, as outlined in document CoP17 Doc. 33, allowing for a more transparent, timely and simple process for conducting the reviews. The revised Resolution provides clear guidance and recommendations for the selection of species/country combinations to be reviewed, the consultation process with the range States, the compilation of information, the categorization and recommendations from the Animals and Plants Committees, measures to be taken regarding the implementation of recommendations and support to the range States. The new process was initiated at AC29 when species/country combinations were selected for review post CoP17. The initial species/country reviews are presented in document AC30 Doc. 12.2.

Decisions 17.108 to 17.110 on Review of Significant Trade

- 8. Decision 17.108 requests the Secretariat, within six months of the adoption of Resolution Conf. 12.8 (Rev. CoP17) and building on the work done to date, to develop, test and establish a Review of Significant Trade Tracking and Management database as an essential tool for the effective implementation and transparency of the process. The Secretariat has carefully reviewed the best approaches to implement Decision 17.108 by inventorying and identifying problems with the existing database that need to be adjusted or modified to suit the new Review of Significant Trade process; discussing options for improvements with the authors of the existing database; and developing a realistic project plan and timeframe.
- 9. Decisions 17.109 and 17.110 are both directed to the Secretariat, calling it, subject to the availability of funds, to develop respectively: a user-friendly guide to the Review of Significant Trade that can also be included in the initial letter to range States; and a comprehensive training module on the Review of Significant Trade (including case studies as appropriate). Thanks to the generous support from the European Union, the necessary resources have now been secured to move these Decisions forward.
- 10. The Secretariat intends to provide oral updates at the present meeting on progress regarding the implementation of Decisions 17.108 to 17.110.

11. The Animals Committee is invited to note this document.
