13. Philippines

 Training of Trainers on the Application of the Wildlife Law Enforcement Manual of Operations

The DENR, through BMB, in partnership with the USAID-Protect Wildlife implemented the seventh series of the Training of Trainers on the Application of the Wildlife Law Enforcement Manual of Operations. This was conducted on November 20-24, 2017 at the Palacio del Sur, Zamboanga City. Thirty-two (32) participants completed the training from Enforcement Division of DENR Region 9, PNP-Maritime Group, PNP-ARRM and DA-

NMIS. The trainees now form part of the wildlife conservation and law enforcement network in the country.

- Stop Illegal Wildlife Trade Campaign
 - The "Stop Illegal Wildlife Trade Campaign" is a continuing effort aimed to raise public awareness and gain support of key agencies and entities in putting an end to illegal wildlife transport/trade. For 2017, efforts included the following:
 - a) Conduct of a series of "Orientation-Seminars on National and International Policies on Ivory and Wildlife Trade" These seminars were held for officers/personnel from both public and private entities operating in/manning five (5) sea and air ports, such as: Lipata Port, Surigao City (7 June 2017); Matnog, Sorsogon (24 August 2017); Liloan, Leyte (7 September 2017); Clark, Pampanga (15 September); and, Iloilo International Airport and Port of Iloilo, Iloilo City (19 September 2017). The seminars were participated by representatives from the Enforcement Division and Wildlife Monitoring Units of the DENR Regional/ Field Office, Philippine Ports Authority, Philippine National Police, Philippine Coast Guard, Department of Agriculture Quarantine Offices, vessel operators, cargo forwarders and courier service providers.
 - b) Production of materials Three types of materials were produced and distributed to various agencies/offices for their reference and use in public awareness campaigns. These materials are tarpaulins on threatened species (60 pieces); 1,300 copies of Republic Act 9147 ("Wildlife Resources Conservation and Protection Act" of 2001; and, 1,000 copies of pocket-sized version of the Wildlife Law Enforcement Manual of Operations.
 - c) The "Orientation-Seminar on National and International Policies on Ivory and Wildlife Trade" continues for 2018, adding two (2) locations focusing on seaports: Batangas Port (8 February 2018) and Calapan Port (20 February 2018).
- Wildlife Forensics and Criminal Investigation Training To further enhance the skills and knowledge on wildlife law enforcement, the DENR, through BMB, in partnership with the US-DOI and USAID-Protect Wildlife conducted a Wildlife Forensics and Criminal Investigation Training from 18-24 March 2018 at the Green Canyon Eco Art Resort, Clark, Pampanga. The training was participated in by 45 individuals from by various Philippine law enforcement agencies and DENR Regional
- Attendance to Conservation Managers' Leadership Course, International Conservation Chiefs Academy (ICCA), Shepherdstown, West Virginia, U.S.A Dr. Esteven Toledo, enforcement staff of BMB attended the training "Conservation Managers' Leadership Course" held from 10-23 March 2018 at the International Conservation Chiefs Academy (ICCA), Shepherdstown, West Virginia, USA. The training was organized by the US Government through the US Fish and Wildlife Service, and designed to strengthen global law enforcement relationships to combat illegal wildlife trafficking, with emphasis on creating a shared undertaking of the illegal wildlife trafficking problem globally, and in strengthening individual and international relationships, including building adaptive leadership. The training catered primarily to officers in law enforcement agencies whose responsibilities include providing leadership and training in the enforcement of laws on endangered species, carrying out wildlife law enforcement, and related operations.
- O The 3rd National Wildlife Quiz Bee
 As part also of the 2018 World Wildlife Day celebration, with the global theme "Big cats: predators under threat", the DENR, through the Biodiversity Management Bureau (BMB), hosted the 3rd National Wildlife Quiz Bee, a knowledge-based competition and learning event which aimed to: encourage the target students to give attention to current developments in wildlife, both nationally and internationally; raise awareness and appreciation of the richness, importance, status and conservation of the Philippine wildlife among the students, their advisers and the public in general; and, encourage the youth to be active in pursuing their role as environment and wildlife conservation stewards. Thirty (30) Grade 9 students from public schools in Central Luzon, CALABARZON, and the National Capital Region participated in the contest. The cash prizes for the winners and incentives for non-winning students were sponsored by USAID and USDOI. The DENR-BMB provided the tokens.

There were many law enforcement activities done during 2017: 45 cases compiled to the court, issued 70 letters to stop the sale of wildlife meat and specimens, confiscated by law enforcers 621 cases, 3067 heads donated by public, and confiscated 5,111 heads of live wildlife, 3030 dead wildlife and 1254 kgs of meat and specimens.

18. *Indonesia*

- Significant seizure:
 - August 2017: Balai Gakkum LHK and INP seized 2 babies orang utan (*Pongo pygmaeus*) from an online seller at Ketapang region, West Kalimantan province.
 - September 2017: INP and Balai Gakkum LHK Jakarta seized 20000 deer antlers and 10000 turtles shells from a warehouse at Tangerang Region.
 - October 2017: Indonesian Navy seized 3000 belangkas/ horseshoe crab (Tachypleus gigas) at Lhokseumawe Seaport, Aceh Province.
 - January 2018: Balai Gakkum LHK Papua seized 200 protected species (offset) from a Foreign citizen at Sentani Airport, Jayapura Region.
 - February 2018: Balai Gakkum KLHK Papua, Balai KSDA, INP, Quarantine and Airport Authority seized 1195 pig nose turtle (*Carettochelys insculpta*) ata Mopah Airport, Merauke Region.

- February 2018: Custom seized 2 boxes of reptiles at Ngura Rai Airport, Bali Province.
- February 2018: Custom seized boxes of snakes skin at Soekarno Hatta Airport, Jakarta Province.

19. Philippines

- Development of a ten-year Wildlife Law Enforcement Action Plan (WildLEAP, 2018-2028). The WildLEAP was formulated through a multistakeholder consultation process, envisioned to serve as a guide in fundsourcing, resource allocation, prioritization of enforcement activities, and evaluation of impacts of wildlife law enforcement works in the Philippines.
- Implementation of the USAID-Protect Wildlife Project and ADB-GEF 6funded Project "Combatting Organized Environmental Crime in the Philippines."

The Protect Wildlife Project is part of the technical assistance program of the US Government to the Philippines. This five-year project aims to address the threats to biodiversity, including illegal wildlife trade concerns in target sites in the Philippines, and to demonstrate the integration of conservation and socioeconomic development. The Project envisions achieving these objectives through a holistic and strategic approach that combines capacity building and technical assistance, conservation financing and partnerships, science and technology, wildlife law enforcement and behavior change.

The three-year World Bank-GEF funded project, on the other hand, aims to combat environmental organized crime in the Philippines through legal and institutional reforms, capacity building in the law enforcement chain, and demand reduction measures. Specific activities would include economic valuation studies for two priority species and production and dissemination of audience-segmented communications materials engaging Key Opinion Leaders and other influencers.

Conferment of Fifth Wildlife Law Enforcement Awards
The Department of Environment and Natural Resources (DENR) honored
last 02 March 2018, 28 officers from the NB1 and PNP for their valuable
contribution to the 2017 wildlife law enforcement operations. The awarding
ceremony once again served as a venue for the DENR to call for stronger
support and greater commitment from each of the awardees and their
respective institutions/agencies to curb illegal wildlife trade. It was also a
way to encourage support from a wider sector of the society and the Filipino
citizenry in protecting wildlife.

20. <u>Singapore</u>

- Collaboration with international partners
 - To mark the 50th anniversary of diplomatic relations between Brazil and Singapore, the Singapore Jurong Bird Park (JBP) imported 2 Spix's macaws and 4 Lear's macaws (both endangered species native to Brazil) from conservation and breeding facilities in Germany and Qatar. The blue macaws were on a 10year loan to support the breeding and conservation

of the species. The project aims to support the re-introduction of the rare macaws in Brazil.

On 23-27 April 2018, Dr Sam Wasser and his team from the University of Washington visited Singapore and collaborated with AVA to collect ivory samples from a shipment of 1,787 pieces (weighing ~3,500 kg) of tusks seized in March 2018. DNA analysis will be carried out to determine the origin of the ivory and elephants population. US Homeland Security Investigation (HSI) was present to support in the DNA sampling process. The collaboration between the US and Singapore aims to support African countries to identify poaching hotspots and strengthen enforcement, in compliance with Resolution Conf. 10.10 (Rev. CoP17) on Trade in Elephant Specimens.

Significant enforcement case(s)

The following highlights a few significant wildlife (including parts and derivatives) seizures made by Singapore:

- On 2 August 2017, a Vietnamese man was fined \$10,000 for smuggling ivory products (2 bird cage accessories and 2 bracelets) into Singapore for sale. The ivory products were forfeited. In accordance to Resolution Conf. 10.10 (Rev. CoP17), the seizure was reported to ETIS, and details of the case were shared through the Ecomessage system.
- On 26 February 2018, a Vietnamese man was sentenced to 15 months' imprisonment for smuggling 8 cut pieces of rhino horns and 1 bag of horn shavings through Singapore. The man had flown from Dubai to Laos, in transit via Singapore, when the illegal rhino horns were detected in his luggage. The rhino horns were forfeited and samples were shared with the Forensic Science Laboratory of the South African Police Service for DNA analysis to trace the origin. Details of the case were shared through the Ecomessage system.
- On 5 March 2018, Singapore authorities seized a container of groundnuts from Nigeria while en-route to Vietnam and uncovered 61 bags of elephant ivory tusks (1,787 pieces), weighing about 3,500kg. The illegal shipment was detected as a result of inter-agency risk assessment and collaboration. A local company had been assisting the authorities with the investigation. The details of the case were shared through the Ecomessage system. In accordance to Resolution Conf. 10.10 (Rev. CoP17), the seizure was reported to ETIS, and DNA sampling of the seized ivory was conducted. This was performed in collaboration with Professor Sam Wasser (University of Washington), with DNA analyses currently in progress.

- CITES annual report

Singapore submitted its CITES annual report for 2016 to the CITES Secretariat on 2 October 2017. The timely submission of a CITES annual report is an obligation of a Party to the Convention. The report recorded the type of CITES permits and certificates granted, quantities, species, origin and types of specimens traded for that year.

21. Thailand

- 30 August 2017: 136 lived pangolins and 450 kg of pangolin scales.
- 11 December 2017: 14 pieces of rhinoceros horns (11.16 kg) from South Africa at Suvarnabhumi Airport.

22. Viet Nam

 - 10 July 2017: 3,500 head of fresh water crocodile (juvenile) were seized in Tay Ninh province.
 - September 2017: 1.4 tons of ivory seized at Cat Lai Seaport in Ho Chi Minh City.
 - 18 September 2017: Over 1.4 tons of ivory was confiscated in Bac Lieu Province
 - 19 October 2017: 32 heads of pangolin, 22 bear arms, 69 heads of Big-Headed Turtle and 1.4m3 timber were seized in Hoa Binh province.
 - 27 October 2017 in Binh Phuoc province: Confiscation of 12 heads Java pangolin, 16 heads of King Cobra 52 long-tailed macaca.
- International cooperation:
 - 11 July 2017: Viet Nam and South Africa had a bilateral meeting on strengthening the implementation of the MoU and the Action Plan on cooperation to conserve biodiversity.
 - 1 August 2017, Viet Nam and Mozambique Governments signed the MoU on Cooperation in Wild Species Protection and Conservation, setting the foundation for cooperative conservation and monitoring wildlife trade activities

23. Japan

- For the fiscal years of 2015-2019, the Fisheries Agency of Japan (FAJ) provided finacial support to the project of the Southeast Asian Fisheries Development Center (SEAFDEC) with the aims to; 1) understand the current situation of resources, fisheries and utilization of catadromous eels in Southeast Asia; ii) improve data collection and statistics of catadromous eel catches in Southeast Asia, and; iii) enhance knowledge and capacity for the conservation, management and sustainable utilization of catadromous eel resouces.
- For the fiscal years of 2015-2019, FAJ provided finacial support to the FAO's project to improve knowledge of the impact and implication of CITES listings, including the development of operational tools for use in by-catch monitoring and assessment.

This regional event took place last 11-15 September 2017 at the Miracle Grand Convention Hotel in Bangkok, Thailand. Two representatives from the DENR, namely: Sr. Ecosystems Management Specialist Dr. Rogelio D. Demelletes, Jr. from BMB and Enforcement Division Chief Modesto Lagumbay from DENR-Region

XIII formed part of the Philippine delegation to the said event, along with NBI-Environmental Crime Division Chief, Atty. Czar Eric Nuqui and Mr. Niilo Estoya from the PCSDS. The Dialogue was organized by the Department of National Parks, Wildlife and Plant Conservation (DNP) of the Ministry of Natural Resources and Environment (MNRE) of the Kingdom of Thailand. It aimed to: a) update and report on current situation, and progress of enforcement efforts of ASEAN member-countries against trafficking of wild flora and fauna; b) strengthen collaboration and build strong partnership between member-countries; c) share best practices in combating trafficking of wild flora and fauna; and, d) elaborate and determine the detail of Plan of Action for Tire ASEAN Cooperation on CITES and Wildlife Enforcement (2016-202Q) to support and promote implementation of the activities related to combating trafficking of wild fauna and flora.

International Conference on Illegal Wildlife Trade This Conference was held in New Delhi, India from October 2-6,2017. It was attended by USEC Ernesto D. Adobo, Jr. and BMB enforcement staff, Dr. Esteven U. Toledo. The meeting hosted wildlife experts, leading practitioners across 19 GWP countries with the theme "Peoples' participation in Wildlife Conservation". The Conference provided a venue for knowledge exchange to combat illegal poaching of wildlife and improve governance on wildlife conservation. Participating nations included Afghanistan, Ethiopia, Cameroon, Botswana, Indonesia, Mali, Malawi, Kenya, Mozambique, Philippines, Republic of Congo, South Africa, Tanzania, Thailand, Vietnam, Zambia, and Zimbabwe.
