The Task Force consists of Directorate General of Forest Protection and Nature Conservation, NCB, Interpol, Ministry of Marine Affairs and Fisheries, Customs, Ministry of Agriculture, Quarantine, Justice and Police.
- b) Development of coordination with stakeholders
- c) CITES MA Indonesia is developing coordination with other stakeholders such as Customs, quarantine, Ministry of Marine Affairs, on the matters related to CITES implementation and wildlife trade monitoring in Indonesia.
- d) Socialization of CITES to the local University, NGO and government agencies.

6. Capacity building

Indonesia

- a) Training on CITES.
- b) Regular (annual) Training on CITES Law Enforcement for field enforcement officers such as Customs, Quarantine and Provincial Conservation Agencies is conducted annually. This regular training has been undertaken since 1995 to enhance the skill and knowledge of the officers on CITES implementation. The training materials include Introduction to species conservation, Introduction to CITES, Permit Systems and Procedures, Wild Crime and Law Enforcement, Customs and Quarantine Procedures. Training on CITES were conducted in North Sumatra and West Kalimantan. Some training on CITES and its implementation has also been carried out by Regional Conservation Unit Office in Jakarta and Bali. Other training on CITES has been done for field officer of the Ministry of marine Affairs and Fisheries, since this Ministry be appointed as the CITES Management Authority.
- c) Training on CITES listed identification.
- d) In year 2008 Regular annual training on the CITES listed identification were held back to back with the Regular Training on CITES.

Kuwait

- a) 14 27 November 2008, Workshop regarding CITES Training Identification of Specimens with Cooperation with CITES Secretariat.
- b) A public Awareness lecture on: Introduction to CITES Convention addressed to the Agarwood Traders in Kuwait.

Malaysia

- a) Briefing on The International Trade in Endangered Species Act 2008 (Act 686) to all States/province office.
- b) Introduction of CITES Act 686 and identification of Species most traded.

Thailand

- May, June and July 2008, CITES MA for Flora organized the training course on implementation and identification of plant under CITES listed for Plant Quarantine Officer in 34 Checkpoint for 5 times.
- b) August 2008, Annual Seminar on the CITES Implementation for Flora, the participants from MA, SA, Customs and Police.
- c) November 2008, report on Non-detriment Finding of *Vanda coerulea* submitted to be discussed in Expert Meeting of NDF held in Mexico.
- 7. Report, dissemination and enforcement

Indonesia

- a) Annual report.
- b) The Indonesia CITES Management Authority has submitted Annual report on CITES implementation in the country.
- c) CITES Handbook
- d) CITES MA Indonesia has established the CITES Handbook in Bahasa Indonesia. The Handbook consists of list appendixes, decision, text convention and resolution. This handbook has been distributed to related stakeholders.
- e) Field handbook monitoring.
- f) Scientific Authority has published several field guide book for population monitoring of several species group of Appendix II CITES.

Kuwait

a) The CITES Management Authority is in process to electronically connect with Custom system which facilitate and improve CITES enforcement in Kuwait.

Malaysia

- a) Group Discussion with Singapore MA on CITES implementation.
- b) Preparation of SOP on issuance of CITES permit/certification.
- c) Department of Agriculture had printed and distributed 10,000 copies of pamphlet on Regulate of CITES Terrestrial Plants to all related stakeholders including exporter, importer, agent, industry, orchids association, government agencies and individual for the awareness and publicity program on CITES.

Singapore

a) In May and September 2008, the Agri-Food and Veterinary Authority (AVA) investigated two cases in civing the export of wild orchids (Orchidaceae species) and pitcher plants 9Nepenthes species) from East Malaysia without CITES permits. The plants were illegally imported into Singapore via parcel post and mis-declared as others items. The offenders were fined \$ 1000 – 2500 for importing wild orchids and pitcher plants without CITES permit, a violation of the Singapore's Endanger Species (Import and Export) Act 2006.

- b) In August November 2007, following some tip-offs that consignments of red sanders wood (*Pterocarpus santalinus*) were illegally transshipped via Singapore from India. The AVA uncovered a total of more than 20 tones of red sanders wood from three separate consignments. All the containers of red sanders wood were mis-declared as other non-wood products, bound for China. The shipments were seized and repatriated to India. Investigations are ongoing.
- 8. Significant trade

China: Medicinal Plants

Management listed species in China

- a) According to CITES and regulation on the Import and export management of Endanger Wild Fauna and Flora, China has all along taken stricter measure of trade control that CITES import, export and re-export of specimens of CITES listed species require an import, export or re-export permit issued by CITES MA and customs staff clear the import, export and re-export after examining the pertinent permit.
- b) If importing, exporting and re-exporting specimens of CITES listed species of exporting specimens of National Key Protected, Wild species, only after making NDF by SA.
- b) MA checked and send out license according to relevant regulations. More strict measures have been taken especially for significant trade and sensitive species.

Indonesia: Cyathea spp.

- a) It was mentioned in the national report that Indonesia applies domestic measures stricter than the provision of the CITES convention. Several actions have been carried out in order to improve the implementation of CITES for *Cyathea contaminans* and fulfill recommendations of CITES Secretariat. The National Quota setting for Cyathea spp is decreasing for 2007 to 2008 from 1000 ton to 315 ton.
- b) Since December 2005, MA registered all exporters of *Cyathea* to improve CITES implemantion. All registered traders are united to form a single association. Strict control on export quotas for *Cyathea contaminans* was based on the recom-mendations of CITES Secretariat and Indonesian Scientific Authority/ Indonesia submitted procedure to make non-detriment findings for trade of *Cyathea contaminans* in Indonesia in accordance with the Significant Trade Review Process.
- c) Report on the implementation the provisions of Article IV for trade *of Cyathea contaminans* is under process.
