ORCHIDS: ANNOTATION FOR SPECIES INCLUDED IN APPENDIX II

1. This document has been prepared by the Secretariat.
2. At its 14th meeting (The Hague, 2007), the Conference of the Parties adopted the following Decisions:

Directed to Parties and the Plants Committee

- 14.133 *Countries of export and import should make recommendations and prepare identification material on further exemptions for artificially propagated hybrids of Orchidaceae spp. included in Appendix II, taking into consideration the capacities of countries to implement and control such exemptions effectively. The results shall be sent to the Plants Committee, which shall evaluate them and adopt the appropriate measures.*

Directed to the Plants Committee

- 14.134 *The Plants Committee shall monitor and assess possible conservation problems arising from the implementation of the annotation to Orchidaceae spp. included in Appendix II and shall report on the issue at the 15th meeting of the Conference of the Parties.*

3. With Notification to the Parties No. 2008/045 issued on 15 July 2008, the Secretariat asked exporting and importing countries to send identification material and technical information for taxa exempt from CITES controls or that could be exempted in the future.
4. In order to fulfil Decision 14.134, Parties were invited in the same Notification to respond to a questionnaire. Seven Parties responded (Brazil, Canada, Madagascar, New Zealand, Thailand, the United Kingdom of Great Britain and Northern Ireland, and the United States of America) and their responses are contained in the Annex to this document in the language in which they were submitted.
5. The Committee is invited to analyse these responses and to prepare its report on this issue for the 15th meeting of the Conference of the Parties.

Canadian Response to CITES Notification 2008/045 Orchids: Annotations for species included in Appendix II

In response to CITES Notification 2008/045 concerning annotations of orchid species included in Appendix II, Canada is pleased to provide the following response.

In regards to questions under paragraph 2d):

- i) It has generally been argued that exemptions may aid in facilitating illegal activity (e.g. the smuggling of non-exempt specimens within shipments of exempt specimens). However, there has been no known increase in illegal activity resulting from the implementation of the annotation for artificially propagated orchid hybrids in Canada.
- ii) Although the exemption is implemented in Canada, use of the exemption is limited. This is likely because the shipping conditions required in the exemption do not necessarily reflect actual shipment characteristics. Specifically:
 - Orchids are rarely shipped "labelled with printed labels and packaged with printed packages; and labels or packages indicates the name of the hybrid and the country of final processing". The added cost and time involved to label and prepare specimens as required under the exemption is too great; it is easier to apply for a CITES permit.
 - *Phalaenopsis* and *Cymbidium* are often too large as mature plants to be packaged and shipped in the manner the exemption requires.
 - The minimum number of plants to qualify for the exemption results in an unfair advantage to companies who trade in larger volumes compared to small nurseries which export fewer plants per shipment.
 - Specimens are not always in flower.

Nurseries exporting shipments that would meet the specifications of the exemption have expressed concern that they would rather “be safe” and have a valid CITES permit to ensure there are no difficulties at the border of the exporting or importing country in regards to the shipment not being accompanied by a CITES permit should the border officials not being aware of the exemption and/or the importing country does not implement the exemption.

iv) The annotation allows us to focus efforts on trade in specimens potentially associated with a higher risk to the conservation of wild populations (i.e. non-hybrids). It may be worthwhile for the Plants Committee to consider a further exemption by annotation of artificially propagated human-made genera such as *Colomonara*, *Brassocattleya*, *Odontocidium*, etc. as they do not pose a risk to wild populations.

Madame,

En réponse à la notification n°2008/045 portant annotation aux espèces d'Orchidées inscrites à l'Annexe II, envoyée par le Secrétariat de Genève, nous pouvons dire, d'une part, que nous n'avons pas encore reçu de demande de dérogation pour les hybrides du fait qu'ils ne sont pas encore exportés. En revanche, l'année dernière, certains opérateurs malgaches ont eu quelques problèmes avec la douane malgache quant au rapatriement des plantules *in vitro* d'orchidées malgaches qu'ils avaient multipliées à l'étranger. Nous remercions l'Organe de Gestion de faire une annotation ou un arrêté concernant ce genre de rapatriement étant donnée que la multiplication *in vitro* des espèces d'orchidées malgaches par les opérateurs a été encouragée.

D'autre part, nous recommandons la préparation d'une guide illustrée d'identification des espèces sauvages, parents potentiels des hybrides, dans le but de distinguer dans le futur les cultivars hybrides des parents sauvages. En outre, une demande de financement a déjà été sollicitée auprès de la GTZ en vue de la « Conception des fiches d'identification de quelques espèces d'orchidées endémiques et commercialisées malgaches ». Cette demande est encore sans réponse jusqu'à ce jour.



**UK RESPONSE TO NOTIFICATION 2008/045: ORCHID ANNOTATION
FOR SPECIES INCLUDED IN APPENDIX II**

We have no identification material or technical information to submit in respect of paragraph 2(a) of the Notification (in addition to the CITES and Plants Guides previously provided to and distributed by the Secretariat).

In response to the questions in Para 2 (d):

i) Have you encountered any problems concerning the exemption annotation of Orchidaceae spp. included in Appendix II as exporting or importing country or for both?

No, other than -

ii) Please describe the problems that have been arising.

Traders still find the exemptions complex and sometimes request permits for exempt material as they are worried that consignments may not fully match the details of the exemptions, or that globally there may be different interpretations of the exemptions. They ask for permits as a 'fail safe' option.

iii) What is your recommendation to resolve the problems?

We would fully support a process which continues the exemptions of artificially propagated orchid hybrids which is as simple as possible and easy to interpret by all stakeholders. Simplicity and utility should be key. We have no evidence of illegal trade due to the exemptions or any case attempting to smuggle material using the exemptions.

iv) Do you observe positive effects or do you have any other comments?

There has been a positive response from the trade as they see evidence of CITES trying to address one of the orchid trade's long-term concerns. It remains vital that we continue to try to remove from CITES the control of material which has no links with wild plants and the regulation of which causes a burden on CITES Parties - without any conservation benefit. The limited resources available to CITES should be better targeted.

This letter responds to paragraphs d) and e) of Notification to the Parties No. 2008/045 of July 15, 2008. We have consulted with our colleagues in the U.S. Department of Agriculture, Animal and Plant Health Inspection Service (USDA/APHIS), the agency responsible for inspection and clearance of live CITES-listed plants entering the United States, in preparing this response.

With regard to the information requested in paragraph d), the U.S. plant inspection authorities have noted that most imports covered under the annotation for Orchidaceae spp. are large and demonstrate characteristics of artificial propagation, such that this exemption has not caused implementation problems for the United States. They do note, however, that some Management Authorities continue to issue CITES permits for shipments that would be covered under the exemption. We believe that it might be useful to explore whether this is a result of some countries requiring exporters to continue obtaining permits for this exempted material or if exporters are concerned that importing Parties might not recognize the exemption.

With regard to the information requested in paragraph e) of the Notification, we believe that it would be helpful to more clearly define the term 'hybrid' in the context of Annotation 7. It is not clear whether the term refers to interspecific hybrids, intergeneric hybrids, or both. The United States recommends that the annotation be applied only to interspecific and intergeneric hybrids, where both parents are derived only from the exempted genera in the annotation.
