# 2. Regarding problems not related to the implementation of Article IV

- a) The working Group expressed concern that while there is no reported CITES trade in *Bulnesia sarmientoi* emanating from Bolivia, during the recent workshop on this species held in Paraguay, there were informal reports that some illegal exports of *Bulnesia sarmientoi* from Bolivia might be occurring under the name "guayacán". If this is the case, such trade is unregulated by CITES. The CITES Secretariat is requested, as appropriate, to bring this matter to attention of the Standing Committee.
- b) A number of countries in their responses (Cambodia, Myanmar) sought assistance to carry out field surveys and address illegal trade and the CITES Secretariat is requested to review possible means of assistance to these countries to address their concerns.
