#### Interpretation and implementation of the Convention

# Annual reports

#### LATE OR NON-SUBMISSION OF ANNUAL REPORTS

- 1. This document has been prepared by the CITES Secretariat. The cut-off date for information included in this report was 31 March 2001. Any information received after that date will be conveyed in the Secretariat's oral report to the Standing Committee at its 45th meeting.
- 2. Article VIII, paragraph 7 a) of the Convention requires each Party to prepare an annual report containing a summary of its trade in specimens of Appendix I, II and III species. Such reports reflect the Parties' implementation of the Convention. They are the basis for monitoring the nature and scale of legal wildlife trade as well as for identifying suspected incidents of and trends in illegal trade.
- 3. Guidelines for the preparation of annual reports were provided by the Secretariat in 1994 through Notification to the Parties No. 788. A revised version of the Guidelines was provided in Notification to the Parties No. 1999/85, and at its 45th meeting the Standing Committee will consider several additional amendments to the terminology section of the Guidelines that should assist Parties in their reporting (see SC45 Doc. 13.2).
- 4. The overall quality and timeliness of annual reports submitted by the Parties have improved significantly over the years. More Parties are developing national databases to assist their ongoing management of wildlife resources, including trade in those resources. The fact that more annual reports are submitted in electronic format has made it easier to transmit trade data and to incorporate them into the trade monitoring database maintained for the Secretariat by the UNEP-World Conservation Monitoring Centre.
- 5. Despite the importance of annual reports and general improvements in the level and quality of reporting, the Secretariat's records show that a significant number of Parties have failed to comply with the obligation to submit such reports. At its 11th meeting (Gigiri, 2000), the Conference of the Parties decided that trade should be suspended in CITES-listed species with those Parties that have, without excuse, failed to report for three consecutive years.

#### 6. Decision 11.89 provides:

"The Standing Committee shall, on the basis of reports presented by the Secretariat, determine which Parties have failed, without having provided adequate justification, to provide the annual reports required under Article VIII, paragraph 7 (a) of the Convention

for three consecutive years within the deadline established in Resolution Conf. 11.17, or the extended deadline that is provided for in that Resolution."

- 7. Decision 11.37 further provides that, from 1 January 2001, Parties should not authorize any trade in specimens of CITES-listed species with any Party subject to the Standing Committee determination above.
- 8. In September 2000 the Secretariat issued Notification to the Parties No. 2000/057 reminding Parties of Decision 11.37 and providing early warning to the 53 Parties that might be subject to a recommendation to suspend trade.
- 9. In December 2000 the Secretariat provided an update to the Chairman of the Standing Committee regarding the Parties that might be subject to a recommendation to suspend trade. By this time, the number had declined to 46.
- 10. By February 2001 it had declined to 35 and the Secretariat sent individual letters to the Parties that remained potentially subject to a recommendation to suspend trade, urging them to submit the missing reports, provide copies of the permits issued and received or give adequate justification for their failure to submit either reports or permits.
- 11. As of 31 March 2001, the following 20 Parties still had not submitted annual reports for a period of three consecutive years since 1991 or provided justification for not doing so: Afghanistan, Bangladesh, Burkina Faso, Central African Republic, Congo, Djibouti, Dominica, Egypt, Equatorial Guinea, Eritrea, Gambia, Georgia, Honduras, Liberia, Niger, Rwanda, Saint Lucia, Saint Vincent and the Grenadines, Saudi Arabia and Somalia.
- 12. The Bahamas wrote to the Secretariat on 1 November 2000 advising that it would be providing its annual report for 1999 by the end of November 2000 (which the Secretariat received on 7 December 2000). No mention was made of other annual reports, and the Secretariat on 28 February 2001 replied reminding the Bahamas that the annual reports for the years 1996-1998 still had not been received.
- 13. The Secretariat received an email message from Burundi on 29 March 2001 attaching a letter and its annual reports for the years 1994-1996. The Management Authority stated that annual reports for 1997-1999 could not be furnished because Burundi was subject to an international economic embargo during those years and there were no official wildlife trade transactions recorded by the Management Authority. This statement is viewed as constituting an annual report for those years.
- 14. Cameroon sent an email message to the Secretariat on 27 October 2000 requesting an extension until 30 November 2000 to submit its annual report for 1999. In a letter dated 3 November 2000, Cameroon indicated that it was reformulating the annual reports for 1996-1999 to conform to the Guidelines in Notification to the Parties No. 1999/85 and indicated that it would be submitting all of them at the end of November 2000. The Secretariat received Cameroon's annual report for 1999 but the annual reports for 1993-1998 have never been received. The Secretariat wrote to Cameroon on 28 March 2001 reminding them that these reports had not been submitted. It should be noted, however, that Cameroon does regularly submit copies of its permits.
- 15. Comoros wrote to the Secretariat on 21 March 2001 stating it had never received Notification No. 2000/057. Although they admitted not having submitted annual reports for the years 1996-1999, it indicated that this was because trade in CITES-listed species was not well known before April 2000 when two commercial companies began such trade. Comoros mentioned having requested technical assistance from the Secretariat on

- 11 January 2001 but never having received a response. The Secretariat responded on 30 March 2001 suggesting again that Comoros might simply provide copies of the CITES permits that had been issued and received and attaching a copy of its telefax of 22 January 2001 which responded to the earlier request for technical assistance.
- 16. Guinea-Bissau wrote to the Secretariat on 22 March 2001, advising that it would not be possible to provide any annual reports for the years prior to 1999 owing to civil unrest in the country during the years 1998 and 1999. During this period the building where the Management Authority was located was bombed and all its records were destroyed. Guinea-Bissau informed the Secretariat that the country is now more politically stable and assured the Secretariat that every effort would be made to submit annual reports in a timely fashion in future.
- 17. Papua New Guinea wrote to the Secretariat on 13 November 2000 describing the efforts of the Management Authority to improve the storage, processing and dissemination of wildlife trade data. It indicated that it would furnish the relevant reports to the Secretariat by the end of March 2001. The Secretariat responded on 17 November 2000 taking note of Papua New Guinea's extension request and indicating that it looked forward to receiving the reports by 31 March 2001.
- 18. Uganda contacted the Secretariat by telephone on 30 March 2001 and indicated that they would provide an official response during the week of 2-6 April 2001.
- 19. Vanuatu wrote to the Secretariat on 8 March 2001 acknowledging its failure to submit annual reports since 1994 and indicating that this was due to a lack of human resource capacity within the Management Authority and Scientific Authority. It asked that the Standing Committee consider Vanuatu's difficulties and allow it an extension of six months for the Management Authority to complete the annual reports from 1995 to 2000 by the end of September 2001. The Secretariat responded on 29 March 2001 indicating that Vanuatu's request would be passed to the Standing Committee for its consideration.
- 20. For reference, the Secretariat's updated list of Annual Reports of CITES Parties (1991-1999) is attached (Annex 1). The Secretariat also has attached trade-monitoring data provided by UNEP-WCMC on the 29 countries potentially affected by Decision 11.89 (Annex 2).
- 21. The Secretariat has not commented on the quality of specific reports but some of them fail to follow the Guidelines and may even leave out entire areas of information. This raises the question as to whether an annual report should meet certain minimum standards in order to be considered and accepted as an annual report.
- 22. The Secretariat, UNEP-WCMC, IUCN and TRAFFIC have been considering the subject of trade data and annual reports with a view to further improving the generation, maintenance and use of trade monitoring information. This includes the possibility of linking annual reports more closely to: population statistics for animals and plants in the wild; information on available habitats; trends in population and habitat; the nature and scope of domestic consumption; and total off-take figures. In this connection, the Secretariat has continued to participate in discussions among biodiversity-related conventions to streamline and harmonize national reporting.

#### Recommendations

- 23. The Secretariat recommends that the Standing Committee determine whether the Bahamas, Cameroon, Comoros, Papua New Guinea, Uganda and Vanuatu have provided adequate justification for not submitting annual reports for three consecutive years.
- 24. With regard to the countries listed in paragraph 11 above, the Secretariat recommends that the Standing Committee decide which Parties have failed, without having provided adequate justification, to provide annual reports for three consecutive years.
- 25. When Decision 11.89 was agreed by the Conference of the Parties, the Secretariat believed it would be an effective means for encouraging Parties to submit annual reports. It did not envisage that about 20 per cent of the Parties might be potentially subject to a recommendation to suspend trade by the other 80 per cent. Although the submission of annual reports remains a concern, the Secretariat does not think it would be helpful to penalize such a large number of Parties in relation to this issue. Accordingly, in connection with paragraphs 21 and 22, the Standing Committee may wish to consider whether it wishes to apply Decision 11.89 to the period 1991-1999 or the period 1997-1999.
- 26. If the Standing Committee decides to apply Decision 11.89 to Parties that have not provided reports for the period 1997-1999, or provided justification for not doing so, the following 18 Parties fall into this category: Afghanistan, Bangladesh, Burkina Faso, Central African Republic, Congo, Djibouti, Dominica, Equatorial Guinea, Eritrea, Gambia, Georgia, Liberia, Niger, Rwanda, Saint Lucia, Saint Vincent and the Grenadines, Saudi Arabia and Somalia.

# Afghanistan

No commercial trade, only three records of imports of personal items.

# <u>Bahamas</u>

The main species exported by the Bahamas is *Strombus gigas*, with almost 143 tonnes of meat and more than 30,000 shells being reported by importing countries in 1999 alone. Imports by the Bahamas, as shown by the annual reports of exporting countries, and by the annual reports of Bahamas for 1993, 1995 and 1999, appear to consist of personal imports of pet parrots and commercial shipments of artificially propagated plants.

# **Bangladesh**

Exports reported by Bangladesh for the period 1991 to 1993 include quantities of up to 721 tonnes of live *Indotestudo elongata*, and between 1991 and 1992 of up to 950 tonnes of frog's legs, *Hoplobatrachus tigerinus*. No such trade has been reported since. In 1997 and 1998, Italy's annual reports included imports of 4,300 and 8,000 skins of *Ptyas mucosus* from Bangladesh. There are limited reported exports to Bangladesh of live parrots, mostly captive-bred, and an average of 1,800 kg of agar wood chips, *Aquilaria malaccensis*, each year since the taxon was listed in Appendix II in 1995.

#### Burkina Faso

There have been small numbers of exports of hunting trophies, particularly *Panthera leo* and *Papio hamadryas anubis*, and of pet parrots, *Psittacus erithacus*, reported by Burkina Faso between 1991 and 1995 (and by importing countries for the years for which Burkina Faso has not submitted an annual report) but these do not appear to be significant. The only significant export to Burkina Faso appears to be 408 live *Python regius*, reported by Benin in 1999.

# <u>Burundi</u>

Since 1997 Burundi has exported 11,403 kg of teeth of *Hippopotamus amphibius* according to importers' annual reports, 1,000 kg in 1997, 2,930 kg in 1998 and 7,473 kg in 1999. Other species exported in significant quantities appear to be *Geochelone pardalis* and *Chamaeleo* spp. although the numbers reported recently by importing countries are only a fraction of those reported by Burundi between 1991 and 1993. There are no significant reports of exports to Burundi.

#### Cameroon

N.B. Cameroon has regularly submitted permits to the Secretariat since 1993, however it is not known whether all valid permits were so forwarded.

Cameroon is a major exporter of parrots, notably *Poicephalus gulielmi* and *Psittacus erithacus*, live chameleons and snakes (particularly *Calabaria reinhardtii* and *Python sebae*), reptile skins (*Varanus niloticus* and *Python sebae*), timber of *Pericopsis elata* (23,000 m³ in 1999) and powdered bark of *Prunus africana* (nearly 300 tonnes in 1999). In addition there are regular

exports of small numbers of live primates (*Miopithecus talapoin*) and live raptors, and there is an apparently thriving trophy hunting industry. Reported exports to Cameroon are insignificant.

#### Central African Republic

Hunting trophies of antelope, baboon, leopard and lion are the major exports although the number of specimens of each species involved rarely exceeds 20 per year. There have also been non-commercial exports of *Psittacus erithacus*. In 1995 the Central African Republic reported exporting 147,710 kg of timber of *Pericopsis elata* to Japan but there are no other records of trade in this species reported from this country. Exports to Central African Republic are insignificant.

# **Comoros**

There have been very few reported imports from Comoros, limited to a few specimens of *Phelsuma* spp. in 1992 and a dozen specimens of *Pteropus livingstonei* between 1991 and 1992. Exports to Comoros are insignificant.

#### Congo

Congo is a major exporter of timber of *Pericopsis elata* and also was the reported destination of such timber exported by the Democratic Republic of the Congo in 1995 and 1996, presumably for re-export. No other significant exports to Congo have been reported. The last few years have seen some commercial exports of parrots, notably 200 specimens of *Poicephalus gulielmi* in 1997 and 310, 302, 3,187 and 1,075 specimens of *Psittacus erithacus* in 1994, 1997, 1998 and 1999 respectively, reported by importing countries.

# <u>Djibouti</u>

There appear to be no significant commercial exports from or imports to Diibouti.

# **Dominica**

The only significant export appears to be that of 2,500 kg of *Strombus gigas* meat reported as an import in the United States of America annual report for 1996. Exports to Dominica appear to be insignificant apart from 898 m³ and 706 m³ of mahogany *Swietenia macrophylla* reported by Nicaragua in 1995 and 1996.

[N.B. It is very likely that some of the reported trade involving Dominica (DM) actually involve the Dominican Republic (DO) as a result of the similarity in country names and ISO-codes.]

#### Egypt

The annual reports of Japan suggest that Egypt exported or re-exported considerable numbers of live falcons and owls between 1994 and 1996. These included 150 specimens of *Falco alopex*, 122 *Tyto alba*, 80 *Athene noctua* and 260 *Glaucidium perlatum*. In the same period 1,079 specimens of *Vulpes zerda* were also reported as imports, particularly by Japan and the United States of America. Considerable numbers of live tortoises, *Testudo graeca* (8,288) and *T. kleinmanni* (5,217), spiny-tailed lizards, *Uromastyx* spp. (29,970), chameleons, *Chamaeleo chamaeleon* (2,473), and sand boas, *Eryx* and *Gongylophis* spp. (1,723) were also exported or re-exported between 1991 and 1996 according to the reports of both Egypt and importing countries. 1999 saw the re-export of 6,108 skins of *Varanus niloticus* to the United States of America. Since 1994 there have been considerable exports of live clams, *Tridacna* spp.

Exports to Egypt appear to consist mainly of captive-bred parrots but there have also been massive imports of Nile monitor skins (375,302 in 1991, 328,600 in 1992, 69,500 in 1996 and 51,811 in 1999) and African python skins (106,034 in 1991, 9,800 in 1992, 7,225 in 1996 and 571 in 1999) from the Sudan, reported by Egypt.

#### **Equatorial Guinea**

The only significant imports from this country are 719,493 kg and 161,655 kg of powdered bark of *Prunus africana* reported by Spain in 1998 and 1999 respectively. The United States of America reported importing over 3,000 chameleons of four different species in 1998 but it is likely that the real exporter was Cameroon. There are no reported exports to Equatorial Guinea.

# Eritrea

There is no significant trade reported with Eritrea.

#### Gambia

There appear to be no exports from the Gambia and very few imports apart from pet parrots. Ghana reported exporting live reptiles to Gambia in 1992 but it is possible that this was a typographical error and the ISO-code GM was used in error.

#### Georgia

Small numbers of hunting trophies of bear, wolf and mouflon are imported annually from Georgia and circus animals are exported and re-imported from that country. In recent years there have been 5,000,000 snowdrops originating in Georgia re-exported annually to the Netherlands by Turkey.

[N.B. The ISO-code GE is frequently used incorrectly to indicate Germany (DE)].

# **Guinea**

Guinea is a major exporting country, particularly of live birds. Between 1998 and 1999 permits were issued for the export of over 75,000 parrots and more than 1,100 raptors. Many thousands of Appendix-III birds are exported annually and, in the early 1990s, large volumes of reptile skins also. Guinea is also an outlet for live parrots that are unable to be exported from Liberia and Sierra Leone as a result of the civil unrest in those countries.

## Guinea-Bissau

There are occasional reports of Appendix-III birds imported from Guinea-Bissau, although it is possible that the real source was Guinea. Most reported trade, both imports from and exports to Guinea-Bissau, involves non-commercial shipments of pet birds.

#### <u>Honduras</u>

Honduras is a major exporter of *Strombus gigas*, including meat, shells and live animals according to annual report data from the United States of America. Imports, exports and reexports of skins of *Caiman crocodilus* and timber of *Swietenia macrophylla* were significant between 1995 and 1997, much of this trade originating in Nicaragua. Other significant exports to Honduras are captive-bred parrots.

#### <u>Liberia</u>

Very little trade with Liberia has been reported until 1998 and 1999 when Belgium, Greece, Portugal and South Africa reported importing significant quantities of live parrots.

# <u>Niger</u>

There appears to be very little trade involving Niger, although there are regular reports of personal imports of pet parrots from that country. In 1999 Portugal reported seizing a shipment of live Appendix-III birds and on three occasions there have been small shipments of specimens of *Geochelone sulcata* reported by the United States of America. In 1996 Indonesia reported exporting 12 species of live reptiles to Niger but it is thought that this might be a typographical error.

[N.B. the ISO-code NE is sometimes used in error for the Netherlands (NL)].

#### Papua New Guinea

Papua New Guinea is a major exporter of meat and skins of crocodiles, notably *Crocodylus novaeguineae* and *C. porosus*, amounting to between 25,000 and 30,000 skins annually. The other major exports are of birdwing butterflies, both dead specimens and live pupae. Exports to Papua New Guinea are insignificant and mainly consist of artificially propagated orchids.

# **Rwanda**

There is no significant trade involving Rwanda.

#### Saint Lucia

There were considerable exports of *Strombus gigas* from Saint Lucia, both meat and live animals, reported as imports by France and its Caribbean territories, between 1993 and 1997, however no further trade in that species has been reported since then apart from a very small number of shells. Exports to Saint Lucia are insignificant and mostly involve artificially propagated orchids and small quantities of caviar.

# Saint Vincent and the Grenadines

There were considerable exports of *Strombus gigas* from Saint Vincent and the Grenadines, both meat and live animals, reported by France and its Caribbean territories between 1993 and 1997. No further trade in that species has been reported since then apart from a very small number of shells. Exports to Saint Vincent and the Grenadines are insignificant.

# Saudi Arabia

Reported imports from Saudi Arabia are mostly insignificant and mainly involve personal shipments of pet parrots and falcons. However, in 1995 and 1996 there were two personal imports of live houbara bustards, *Chlamydotis undulata*, reported by Morocco, amounting to some 510 birds.

Exports to Saudi Arabia are far more significant and, apart from a large number of manufactured items of reptile leather, involve commercial shipments of caviar (at least 1,300 kg in 1999), live falcons, parrots and Appendix-III birds (both wild-caught and captive-bred) and agar wood, *Aquilaria malaccensis* (an average of almost 45 tonnes annually between 1995 and 1999).

#### Somalia

There is no significant trade involving Somalia.

# <u>Uganda</u>

The only significant exports from Uganda appear to be of teeth of *Hippopotamus amphibius* (over 10 tonnes between 1995 and 1997 reported as imports by Hong Kong) and skins of *Crocodylus niloticus*. Uganda reported exporting 4,817 skins from ranched crocodiles to Hong Kong in 1994, and Singapore reported importing 4,269 skins from Uganda in 1995.

Exports to Uganda appear to be insignificant apart from the reported export from the Democratic Republic of the Congo of 200 *Geochelone pardalis*, 100 *Kinixys belliana*, 50 *Bradypodion fischeri* and 50 *Chamaeleo johnstoni* in 1995.

#### <u>Vanuatu</u>

Almost 11,000 live *Tridacna crocea* were reported as being imported from Vanuatu in 1998 and about half that number, 5,620, in 1999. The other main exports are corals, Scleractinia spp., both live and dead. Exports to Vanuatu appear to be insignificant.
