#### ADMISSION OF OBSERVERS

- 1. In accordance with Rule 6, paragraph 2, of the Rules of Procedure of the Standing Committee, four intergovernmental organizations and 32 non-governmental organizations submitted to the Secretariat, on or before 14 June 2008, a request to attend the 57th meeting of the Standing Committee.
- 2. On 17 June 2008, the Secretariat sent the requests from observer organizations to the members of the Committee, who provided their comments to the Chairman of the Standing Committee or to the Secretariat.
- 3. In consequence, the Secretariat, on behalf of the Chairman of the Standing Committee, sent to the organizations listed in the Annex to this document an invitation to attend the 57th meeting. This list also includes the names of five organizations from the UN system that were invited to attend. (This list does not include UNEP, which provides the administration of the Secretariat.)
- 4. The list excludes the following three organizations which did not receive an invitation because they registered after the deadline, did not provide, and had not previously provided, sufficient information to demonstrate that they were technically qualified in protection, conservation or management of wild fauna and flora and/or the proof of the approval of the Management Authority of the State in which they are located:
  - EOWAS (Nigeria);
  - New Era Environment Development of Africa (Ghana); and
  - Nava Sahara Nepal.
