Administrative matters

ADMISSION OF OBSERVERS

1. This document has been prepared by the Secretariat.
2. In accordance with Rule 6, paragraph 2, of the Rules of Procedure of the Standing Committee, any body or agency technically qualified in protection, conservation or management of wild fauna and flora wishing to be represented at a meeting of the Committee by observers shall submit a request to the Secretariat at least 30 days before the meeting.
3. By 16 July 2011, which was the deadline for submitting requests to attend the 61st meeting, the Secretariat had received such requests from 5 intergovernmental organizations and 35 non-governmental organizations. On 20 July 2011, the Secretariat sent these requests to the members of the Committee, who provided their comments to the Chair of the Standing Committee or to the Secretariat.
4. No objection was received to the participation of any of the organizations that had requested to participate.
5. In consequence, the Secretariat, on behalf of the Chair of the Standing Committee, sent to the organizations listed in the Annex to the present document an invitation to attend the 61st meeting.
6. The above procedure does not apply to observers representing States not party to the Convention, nor to the United Nations, its Specialized Agencies or the International Atomic Energy Agency, which are entitled to be represented at meetings of the Standing Committee in accordance with Rule 5 of the Rules of Procedure. The list in the Annex includes the names of the organizations from the UN system that have informed the Secretariat of their wish to attend the present meeting. (It does not include UNEP, which administers the Secretariat.)
