AGENDA

1. The Secretariat has prepared, for the approval of the Standing Committee, a first draft of the provisional agenda for the 16th meeting of the Conference of the Parties (CoP16). This is annexed to the present document.
2. It should be noted that the right-hand column of the draft agenda currently indicates the Resolutions and Decisions that are relevant to the agenda item and the source from which a report is expected. In the provisional agenda to be issued for the meeting, however, this column will instead indicate the document numbers.
3. Obviously, the draft agenda is subject to change, depending on the documents (and, hence, agenda items) that are submitted by Parties for discussion. In accordance with Resolution Conf. 4.6 (Rev. CoP15) on *Submission of draft resolutions and other documents for meetings of the Conference of the Parties*, the deadline for communicating documents to the Secretariat is 150 days before the meeting. CoP16 is planned to be held from 3 to 14 March 2013. This means that the deadline for submission of documents is 4 October 2012.
