Interpetation:

In accordance with the provisions of Article XV, paragraph 1, sub-paragraph (c), of the Convention, the amendments adopted at the fourth meeting of the Conference of the Parties entered into force 90 days after that meeting, i.e. on 29 July 1983, for all Parties except those which made a reservation before that date.
7. Following the adoption of these amendments a revised edition of Appendices I and II was prepared by the Secretariat. This revised edition is reproduced on pages 1109 to 1147 of the present Proceedings.
8. Some of the adopted amendments concern species or other taxa which were listed on Appendix III of the Convention. A revised edition of this appendix was therefore prepared by the Secretariat. It is reproduced on pages 1148 to 1152 of the present Proceedings and also entered into force on 29 July 1983.
