# CONVENTION ON INTERNATIONAL TRADE IN ENDANGERED SPECIES OF WILD FAUNA AND FLORA

### Fifth Meeting of the Conference of the Parties

Buenos Aires (Argentina), 22 April to 3 May 1985

#### Committee Reports and Recommendations

#### IDENTIFICATION MANUAL COMMITTEE

### 1. Terms of Reference and Membership

- 1.1 At the fourth ordinary meeting, the Conference of the Parties decided (Resolution Conf. 4.19) to extend the mandate of the Identification Manual Committee up to the fifth meeting. The Conference invited
  - a) the Parties to submit in consultation with the Committee appropriate contributions for existing listings on the appendices;
  - b) the Parties that propose additions to the appendices to provide appropriate data for inclusion in the Identification Manual within one year after acceptance of such additions; and
  - c) one or more of the French or Spanish speaking Parties to provide funding for the translation of the Identification Manual.
- 1.2 The Committee is chaired by Switzerland. Current members are experts nominated by the following Parties: Australia, Austria, Canada, Chile, Colombia, France, Federal Republic of Germany, Guatemala, India, Switzerland, United Kingdom, United States of America and Uruguay.

#### 2. Work of the Committee

Some of the members of the Committee met during the TEC meeting held at Brussels from 25 to 30 June 1984. Information circulars were sent out by the Chairman to the Committee members on 8 July 1983, 27 December 1983, 21 February 1984, 8 June 1984, 15 October 1984, 11 December 1984 and 15 March 1985. The remaining work was done by individual correspondence or by personal contacts.

On 4 November 1983 and 4 July 1984 the Chairman submitted interim reports to the Standing Committee. On 20 November 1984 he delivered - to the attention of UNEP - a terminal report on the UNEP Project to the Secretariat.

### 3. Progress Report

3.1 The binders for three volumes of the Flora part have been produced.

The production costs were borne by World Wildlife Fund Switzerland.

3.2 The following chapters or sections have been printed since the submission of the last report to the Parties (deadline: 31.12.1984):

Together with the sheets printed prior to the Gaborone meeting, a total of 583 sheets, including 44 in colour, have been produced and distributed to the Parties.

3.3 Nine sheets have been revised and reprinted.

- 3.4 Each Party received one set of binders (Volumes 1, 2, 4 and 5) and a copy of all chapters and sections produced during the reporting period. Parties having paid their contributions to the CITES Trust Fund received six more complete sets free of charge upon request. For the sale of surplus copies a price of US\$ 250 was agreed between the Secretary General and the Chairman. This price includes postage and up to ten supplementary distributions until a total of 1,000 sheets is reached (see Notification to the Parties No. 309 dated 28 August 1984).
- 3.5 The Parties were given the opportunity to purchase additional copies of the chapter on Felidae skins printed in colour. Several Parties ordered between 10 and 1,000 copies.

### 5. Translations

Canada translated the contributions on Prosimiae and Chamaeleonidae submitted by France (in French) into English. The French versions of these two chapters were made available to the French-speaking Parties by the Management Authority of Switzerland which sponsored the printing. In addition, Canada offered to translate future contributions submitted in French into English and, moreover, to translate the entire Manual from English into French.

Switzerland distributed slightly shortened French versions of the Testudinidae, Cheloniidae and Snake Skin chapters to the French-speaking Parties.

TRAFFIC-USA will provide a Spanish version of the Crocodile/Crocodylian Skin chapter. The Director of the Department of Wild Fauna and Flora of Mexico started to translate the Felidae section into Spanish.

#### 6. Staff Matters

Although the UNEP project provides that a part-time editor and a full-time secretary be employed for the purposes of the Manual, and financed from the UNEP fund, all editorial and secretarial work had been done gratuitously by the Swiss Management Authority from 1979 to 1983. At the end of 1983, it became apparent that Switzerland was no longer in a position to provide all secretarial functions. Therefore, the Secretary General decided to provide a part-time secretary (20 %) to the Chairman of the Identification Manual Committee. This secretary was hired on 1 February 1984. Due to lack of co-operation from IUCN, she had to be employed by the Chairman, her salary had to be paid from his personal NGO account, and he had to request reimbursement of the money from IUCN monthly.

#### 7.2 Funding from NGOs

The German Fur Trade Association/Artenschutzkreis des Kürschnerhandwerks paid DM 10,000 (SFr. 8,440) to the Chairman for the production of the Felidae Chapter.

The German Fur Trade Association also sponsored the colour printing of the chapter on Felidae Fur Skins with SFr. 20,000 which were received on 14 November 1984.

World Wildlife Fund Switzerland sponsored the 3,000 binders of the Flora part of the Manual, including the printing of the title sheets, with SFr. 14,580. This amount was received on 26 September 1984.
