Interpretation:

In accordance with the provisions of Article XV, paragraph 1, sub-paragraph (c), of the Convention, the amendments adopted at the sixth meeting of the Conference of the Parties entered into force 90 days after that meeting, i.e. on 22 October 1987 for all Parties except those which made a reservation before that date.
8. Following the adoption of these amendments a revised edition of Appendices I and II was prepared by the Secretariat. This revised edition is reproduced on pages 941 to 985 of the present Proceedings.
9. Some of the adopted amendments concern species or other taxa which were listed in Appendix III of the Convention. A revised edition of this appendix was therefore prepared by the Secretariat, which also entered into force on 22 October 1987. This revised edition is reproduced on pages 987 to 994 of the present Proceedings.
