# 5. Information on Similar Species

There are some similar <u>Cynolebias</u> species which are not listed in CITES appendices: <u>Cynolebias fluminensis</u>, <u>Cynolebias ladigesi</u>, Cynolebias sandrii and <u>Cynolebias sichleri</u>.

## 6. Comments from Countries of Origin

The Brazilian Management Authority gives no tentative view regarding the proposal. On the questionnaires it is indicated that the situation of the species could become more critical if removed from Appendix II, despite the fact that there is no evidence of trade and that the threat is attributed to deterioration of habitat in all five species and to environmental pollution in constanciae, marmoratus, opalescens and splendens.
