CONVENTION ON INTERNATIONAL TRADE IN ENDANGERED SPECIES OF WILD FAUNA AND FLORA

Eighth Meeting of the Conference of the Parties Kyoto (Japan), 2 to 13 March 1992

ADMISSION OF OBSERVERS

Bodies and Agencies Applying for Observer Status

- 1. According to Article XI, paragraph 7, of the Convention, any body or agency technically qualified in protection, conservation or management of wild fauna and flora, in the following categories, which has informed the Secretariat of its desire to be represented at a meeting of the Conference by observers, shall be admitted unless at least one-third of the Parties present object:
 - a) international agencies or bodies, either governmental or non-governmental, and national governmental agencies and bodies; and
 - b) national non-governmental agencies or bodies which have been approved for this purpose by the State in which they are located.
- 2. Rule 2, paragraph 3, of the Rules of Procedure [Doc. 8.3 (Fin.)] requires that bodies and agencies desiring to be represented at the meeting by observers shall submit the names of these observers and, in the case of bodies and agencies referred to in paragraph (2) (b) of this Rule, evidence of the approval of the State in which they are located to the Secretariat of the Convention at least one month prior to the opening of the meeting.
- 3. These provisions apply to all agencies or bodies other than the United Nations and its Specialized Agencies (which are not subject to the admission procedure of Article XI, paragraph 7, of the Convention, according to paragraph 6 of the same Article, and Rule 2, paragraph 1, of the Rules of Procedure).
- 4. Listed in the Annex of the present document are all bodies and agencies which as of 2 February 1992 had informed the Secretariat of their desire to be represented at the meeting by observers and which, in the case of national non-governmental agencies or bodies only, had been approved for this purpose by the State in which they are located.
- 5. The list is submitted to the Conference of the Parties for purposes of admission of observers in accordance with Article XI, paragraph 7, of the Convention.
