RESULTS OF THE DIALOGUE MEETING ON THE AFRICAN ELEPHANT

Introduction

- This document has been prepared by the Secretariat and has been adopted by the participants in the seventh dialogue meeting of African elephant range States as the official record of the outcome of the meeting.
- 2. At its 53rd meeting (Geneva, June July 2005), the Standing Committee agreed to Terms of Reference for dialogue meetings. On 26 February 2007, in accordance with those Terms of Reference, the Standing Committee called for the Secretariat to convene a dialogue meeting of range States of the African elephant (*Loxodonta africana*). This dialogue meeting was consequently held from 31 May to 1 June 2007 at the World Forum Convention Center, The Hague, The Netherlands, preceded by an associated one-day meeting to discuss MIKE, ETIS and other elephant matters.
- 3. The Secretariat raised sufficient funds to cover the attendance costs of at least one representative of each Party range State of the African elephant coming from developing countries that had requested financial assistance. The range States and the Secretariat are extremely grateful to the European Commission and the Governments of Germany, Ireland, Japan, the Netherlands, the United Kingdom of Great Britain and Northern Ireland, and the United States of America for their generous support.
- 4. With the assistance of the Secretariat, the Chairman of the Standing Committee, as Chairman of the dialogue meeting, consulted the CITES Management Authorities of the range States of the African elephant on the provisional agenda for the meeting on 20 March 2007. The Secretariat subsequently distributed the final provisional agenda to these Authorities on 13 April 2007 and invited them to send representatives to the meeting. The range States approved the agenda for the meeting which is contained in Annex 2 to this document, subject to item 7.5 being discussed in close connection with item 8.
- 5. The dialogue was attended by 25 of the 36 range States that are party to the Convention. A list of participants is contained in Annex 1 to this document. The range States elected Niger and the United Republic of Tanzania as Vice-Chairmen of the meeting. They further approved the participation as observers of one representative from each of the Parties who provided funding for participants to attend the meeting and of representatives of TRAFFIC and IUCN-The World Conservation Union to serve as resource persons.

Proposals to amend the Appendices for *Loxodonta africa* to be considered at the 14th meeting of the Conference of the Parties (CoP14).

6. Proponents of proposals to amend the Appendices with respect to the listing for *Loxodonta africa* to be considered at CoP14 introduced their proposals and explained the rationale for them. This enabled

the range States to have a good appreciation of all aspects of the proposals and to engage in an indepth discussion of the issues raised by them. There was a full and frank exchange of ideas and consideration of the options available for finding a consensus between the range States over the proposals. All participants expressed a strong desire to obtain such a consensus.

Conclusion

7. In the light of these constructive debates, the range States agreed to continue their discussions on an informal basis during the period leading up to the discussion of the matter at CoP14.
