CUADRO PANORÁMICO DE ESPECIES INCLUIDAS EN EL EXAMEN PERIÓDICO

1. Este documento ha sido preparado por la Secretaría.
2. En la Resolución Conf. 14.8 (Rev. CoP16), sobre *Examen periódico de especies incluidas en los Apéndices I y II*, la Conferencia de las Partes acuerda un proceso y unas directrices para que los Comités de Fauna y de Flora realicen un examen periódico de las especies de fauna y de flora incluidas en los Apéndices de la CITES, y en el párrafo 6:
 6. *ENCARGA a la Secretaría que mantenga un registro de las especies seleccionadas para el examen periódico, incluidas las especies examinadas anteriormente y actualmente, fechas de los documentos pertinentes del Comité, recomendaciones de los exámenes y cualesquiera otros informes y documentos conexos.*
3. En el Anexo 1 se muestra el registro de las especies de fauna seleccionadas para su examen entre las reuniones 13ª y 15ª de la Conferencia de las Partes (CoP13, Bangkok, 2004 y CoP15, Doha, 2010). En la última página de dicho Anexo figura una representación gráfica del origen de las propuestas de especies presentadas en la CoP16.
4. En el Anexo 2 se muestra el registro de las especies de fauna seleccionadas para su examen entre las reuniones 15ª y 17ª de la Conferencia de las Partes (CoP17, 2016). En la última página de dicho Anexo figura una representación gráfica del origen de las propuestas de especies presentadas en la CoP17.
5. Las especies de fauna seleccionadas por el Comité de Fauna para ser examinadas entre la CoP16 y la 18ª reunión de la Conferencia de las Partes (CoP18, 2019) figuran en el Anexo 3.
 - a) Mediante las Decisiones 16.124, 16.125 y 13.93 (Rev. CoP16), se encargó al Comité de Fauna que incluyera a *Cuora galbinifrons*, *Mauremys annamensis*, *Chelodina mccordi* y Felidae spp. en su Examen Periódico de los Apéndices después de la CoP16 (véanse los documentos AC27 Doc. 24.3.1 y AC27 Doc. 24.3.2).
 - b) En su 28ª reunión (AC28; Tel Aviv, agosto de 2015), el Comité de Fauna examinó el documento AC28 Doc. 20.1 (Rev.1) y aprobó, entre otras, las siguientes medidas (véase el documento AC28 Acta resumida):

El Comité [...] acuerda suprimir del examen periódico a esas especies que se seleccionaron para su examen entre la CoP15 y la CoP17 y respecto de las cuales ningún Estado del área de distribución se ha ofrecido voluntario para realizar el examen.

*El Comité acoge con agradecimiento la expresión de interés de Bhután de examinar *Semnopithecus schistaceus* y *Varanus bengalensis*, pero observando su solicitud de apoyo financiero para realizar este examen y la falta del mismo, acuerda suprimir la especie del examen periódico.*

6. En el Anexo 4 se presenta un resumen de todos los casos en curso hasta mayo de 2017.
7. Los registros de las especies seleccionadas para el examen periódico, que figuran en los Anexos 1 a 3, siguen el mismo modelo y formato que las presentaciones anteriores de la Secretaría. Sin embargo, no está claro si los campos de datos que contienen información que pueda cambiar posteriormente (estado de la conservación; distribución) deben mantenerse actualizados, y la Secretaría agradecería recibir instrucciones al respecto. Además, en sus observaciones con relación al documento CoP17 Doc. 82.1, la Secretaría indicó que el mantenimiento de los registros para el Examen Periódico constituía una labor cada vez más ardua y que sería preferible desarrollar una base de datos sobre el Examen Periódico en línea manejable y en la que se puedan realizar búsquedas. En los Anexos 1 y 2, la Secretaría ha tratado de proporcionar una representación gráfica de los datos poco afinada, pero este proceso podría mejorarse considerablemente si se dispusiera de una base de datos perfeccionada. La Secretaría no cuenta con financiación en el presupuesto ordinario para estas actividades, y sería necesario garantizar una financiación externa para establecer y mantener una base de datos sobre el Examen Periódico. Los costos serían de aproximadamente 50 000 USD para el período comprendido entre la CoP17 y la CoP18.
8. En el Anexo 5 figura una lista de las abreviaturas y en el Anexo 6 figura una lista de los códigos ISO de los países.

Recomendaciones

9. Se invita al Comité de Fauna a:
 - a. formular comentarios con relación a las observaciones de la Secretaría que aparecen en el párrafo 7; y
 - b. tomar nota de este documento.




