INFORME DE LA PRESIDENCIA *

Introducción

1. Noruega fue elegida por los miembros del Comité Permanente en su 60^a reunión para la Presidencia, tras la 15^a reunión de la Conferencia de las Partes (CoP15, Doha, 2010). Los Estados Unidos de América fueron elegidos para ocupar la Vicepresidencia, y Kuwait la Vicepresidencia suplente. Desde la CoP15 se han celebrado dos reuniones del Comité: la 61^a en agosto de 2011, y la 62^a en julio de 2012 (ambas en Ginebra). La 63^a reunión se celebrará en marzo de 2013 (Bangkok), inmediatamente antes de la CoP16.
2. Desde la CoP15 se ha adherido a la Convención una nueva Parte: Bahrein, con lo que el número total de Partes asciende a 176.
3. El actual Secretario General, John Scanlon, asumió su cargo el 3 de mayo de 2010.
4. Al Comité Permanente se le asignó una considerable carga de trabajo en la CoP15 (véase el Anexo), así como a los dos comités científicos. Debido a este creciente volumen de trabajo y al nivel de interés en la labor del Comité, nuestras reuniones se han convertido, como señaló el Secretario General en la 62^a reunión, en mini Conferencias de las Partes. En razón de este gran volumen de trabajo, al Comité Permanente no le ha sido posible terminar toda su labor en la 62^a reunión, transfiriéndose algunas materias a grupos de trabajo. En varias ocasiones, el Comité Permanente accordó que el grupo de trabajo sometiera su informe y sus recomendaciones directamente a la CoP, pero con el visto bueno del Presidente. Esta ha sido una de las consecuencias directas de la pesada carga de trabajo del Comité.
5. En el período transcurrido desde la CoP15, el Comité se ha centrado en tareas esenciales que le ha confiado la CoP (véase el Anexo). [NB: En vista de la extensión del documento, el Anexo se proporciona en inglés solamente.] Estas tareas comprenden, entre otras, la actualización del Memorando de Entendimiento entre la CITES y el PNUMA y entre la CITES y la FAO; el Reglamento de los Comités de Fauna y de Flora respecto a conflictos de intereses; los objetivos de la diversidad biológica después de 2010; la Plataforma intergubernamental científico-normativa sobre diversidad biológica y servicios de los ecosistemas (IPBES); el Colegio Virtual de la CITES; criterios para la inclusión de especies en los Apéndices I y II; definición del término "introducción procedente del mar"; conservación y comercio de rinocerontes africanos y asiáticos; conservación del elefante; gestión del comercio y la conservación de serpientes, y examen del uso de las votaciones secretas. Estas actividades se describen en detalle en informes de las reuniones del Comité Permanente y en informes de los grupos de trabajo, que se deben consultar para tener una idea completa de cada actividad. Por lo tanto, lo que sigue es un resumen de las actividades del Comité sobre estas y otras cuestiones.

6. Como Presidente, estoy agradecido a todos los miembros del Comité Permanente por su dedicación, su ardua labor y ayuda. También estoy agradecido a los observadores Parte y a los observadores que no son Parte por su importante contribución a la labor del Comité.
7. El Comité está igualmente agradecido al Secretario General y al personal de la Secretaría por su valiosa y excelente ayuda a las actividades del Comité.
8. El Comité también está en deuda con los Comités de Fauna y de Flora y con los numerosos grupos de trabajo por su entrega y su incansable aportación a las tareas.
9. El Presidente del Comité Permanente ha tenido la oportunidad de participar en todas las reuniones de los Comités de Fauna y de Flora en el período transcurrido desde la CoP15 y de visitar la Secretaría en Suiza en varias ocasiones. El Secretario General también visitó al Presidente en Noruega antes de la 61^a reunión del Comité.

Colaboración con otras organizaciones

Memorando de Entendimiento con el Director Ejecutivo del Programa de las Naciones Unidas para el Medio Ambiente (PNUMA)

10. Un grupo de trabajo presentó en la 61^a reunión del Comité Permanente un proyecto de Acuerdo revisado entre el Comité Permanente de la CITES y el Director Ejecutivo del PNUMA. El Comité adoptó el proyecto revisado y autorizó al Presidente del Comité Permanente a firmarlo en nombre del Comité y a transmitirlo al PNUMA. Subsiguientemente, fue firmado por el Director Ejecutivo del PNUMA el 1º de septiembre de 2011, fecha en que entró en vigor. Este nuevo Memorando de Entendimiento representa un importante hito en cuanto a certidumbre y transparencia en las relaciones administrativas entre el PNUMA y la CITES.

Memorando de entendimiento con la Organización de las Naciones Unidas para la Alimentación y la Agricultura (FAO)

11. El Comité Permanente consideró este asunto en sus 61^a y 62^a reuniones. En esta última el Comité estableció un grupo de trabajo para preparar un proyecto de memorando de cooperación revisado, sobre la base del documento SC62 Doc. 14.4, Anexo 1, para examinarlo en la 63^a reunión.

Programa de trabajo conjunto con la Convención sobre la Conservación de las Especies Migratorias de Animales Silvestres (CMS)

12. En 2004 se firmó un Memorando de Entendimiento con la CMS. El Comité discutió un programa de trabajo conjunto en su 61^a reunión, y transmitió un proyecto revisado al Comité Permanente de la CMS. El programa de trabajo conjunto fue respaldado posteriormente por el Comité en su 62^a reunión, y figura como anexo al documento SC62 Doc. 14.3. Este programa de trabajo conjunto es un documento muy concreto y pragmático que refleja fielmente ambas Convenciones.

Diretrices para la cooperación con la Comisión Internacional para la Conservación del Atún del Atlántico (CICAA)

13. Después de la CoP15, la CICAA envió a la Secretaría un proyecto de directrices para la cooperación con la CITES. En su 62^a reunión, el Comité apoyó las directrices, que figuran como anexo al documento SC62 Doc. 14.6.

Plataforma intergubernamental científico-normativa sobre diversidad biológica y servicios de los ecosistemas (IPBES)

14. En la Decisión 15.12 se encarga a la Secretaría de la CITES y a los Presidentes de los Comités de Fauna y de Flora que sigan los debates de una posible IPBES y proporcionen aportaciones al proceso. Los Presidentes debían informar al Comité Permanente y recabar orientaciones adicionales. El Comité de Fauna y el Comité de Flora y la Secretaría han participado en el Comité de Organismos Consultivos Científicos (CSAB) de Acuerdos Ambientales Multilaterales y han seguido las reuniones y el desarrollo de la IPBES. En su 61^a reunión, el Comité acordó mantener el seguimiento del desarrollo de la IPBES y que el Comité participara como observador en el marco del Grupo de Expertos Multidisciplinario de la IPBES. El Comité creó un nuevo grupo de trabajo en su 62^a reunión para actuar de enlace con el CSAB e

informar a la IPBES en los plazos fijados sobre solicitudes de servicios de la IPBES. En su 62^a reunión, el Comité sancionó las recomendaciones del grupo de trabajo para presentarlas como proyectos de decisiones en la CoP16. Ha habido muy buena colaboración con la Secretaría, otras convenciones relativas a la diversidad biológica y el PNUMA sobre esta cuestión.

Observador en la Organización Mundial del Comercio (OMC)

15. El Presidente del Comité Permanente ha escrito a la OMC para solicitar la condición de observador en el Comité de Medidas Sanitarias y Fitosanitarias y en el Comité de Obstáculos Técnicos al Comercio de la OMC. Todavía no se ha tomado una decisión favorable sobre estas solicitudes.

Conservación del elefante

16. En la Decisión 14.77 se pide al Comité Permanente que establezca un mecanismo de adopción de decisiones para un proceso de comercio de marfil bajo los auspicios de la Conferencia de las Partes para presentarlo en la CoP16 a más tardar. En su 62^a reunión, el Comité Permanente no pudo llegar a un acuerdo sobre el proyecto de propuesta que se presentó, y decidió recabar nuevas observaciones a fin de que la Secretaría pudiera preparar un documento para la CoP16, en nombre del Comité. Se someterá a la CoP16 un documento separado sobre esta cuestión.
17. En su 61^a reunión, el Comité Permanente acordó crear un grupo de trabajo para revisar la Resolución Conf. 10.10 (Rev. CoP15) conforme se le encarga en la Decisión 15.74. El Subgrupo MIKE-ETIS debía revisar las secciones pertinentes de la Resolución. En la 62^a reunión se presentó un informe preliminar, y el Comité acordó que el grupo de trabajo continuaría su labor y que la propuesta definitiva se sometería a la aprobación del Presidente del Comité Permanente antes de presentarla a la CoP16. Después de recibir los resultados de los debates del grupo de trabajo, considerando que todavía existían muchos puntos de desacuerdo, solicitó la asistencia de la Secretaría para preparar un proyecto refundido (versión modificada de la Resolución) basado en las observaciones y en los resultados del grupo de trabajo, y eliminando los corchetes en la medida de lo posible. Los resultados se presentan en un documento separado para esta reunión.
18. En la Decisión 14.78 (Rev. CoP15) se encarga a la Secretaría que, en espera de la financiación externa, prepare un análisis actualizado de los datos MIKE; invite a TRAFFIC a presentar un análisis actualizado de los datos ETIS; invite a los Grupos de especialistas en elefantes africanos y asiáticos de la CSE/UICN a actualizar el estado de conservación del elefante y sobre acciones de conservación y estrategias de conservación pertinentes, e invite a los Estados del área de distribución del elefante africano a facilitar información sobre los progresos alcanzados en la aplicación del *plan de acción sobre el elefante africano*. Además, en la Decisión 14.79 (Rev. CoP15), entre otras cosas, se pide a la Secretaría que establezca un Fondo para el elefante africano que se dedicará a aplicar el *plan de acción sobre el elefante africano*. Ese plan de acción fue aprobado por los Estados del área de distribución en 2010, y la Secretaría ha dado pasos importantes en el establecimiento del Fondo para su aplicación, que se creó en 2011 bajo los auspicios del PNUMA. En la 62^a reunión del Comité Permanente se presentó un informe refundido de MIKE y ETIS que reflejaba un aumento de las importantes confiscaciones de marfil, y el Comité pidió a los países consumidores que intensificaran sus esfuerzos para reducir el comercio ilícito. Este asunto se discutirá más a fondo en la presente reunión.

Conservación y el comercio de rinocerontes

19. En la Decisión 15.71, sobre la aplicación de la Resolución Conf. 9.14 (Rev. CoP15), se encargó a la Secretaría que informara al Comité Permanente. En la Decisión 15.72 se pide a la Secretaría que contribuya a mejorar los esfuerzos de cooperación y que trate de obtener fondos para convocar un Grupo especial mixto de la CITES para la observancia sobre los rinocerontes y el marfil. El comité Permanente estableció un grupo entre reuniones presidido por el Reino Unido para identificar, entre otras cosas, medidas concretas que deban adoptar las Partes y elaborar recomendaciones para la CoP16. El Comité apoyó las propuestas del grupo de trabajo para avanzar sobre esta cuestión.

Grandes felinos asiáticos

20. En la Decisión 15.70 se encarga al Comité que examine y actualice el formulario y las orientaciones que figuran en los Anexos 1 a 3 de la Resolución Conf. 12.5 (Rev. CoP15) e informe a la CoP16. Esto incluye la revisión del formulario de información sobre incidentes de delitos contra la vida silvestre, comercio ilícito, caza furtiva e información significativa. El Comité acordó asignar al Grupo de Expertos Principales

del ICCWC la tarea de realizar el examen y presentar la actualización a la CoP16. El Comité acogió con satisfacción la información en su 62^a reunión sobre los progresos realizados en la Iniciativa Mundial para la Conservación del Tigre, presentada por el representante del Banco Mundial.

Caoba de hoja ancha y otras especies maderables neotropicales

21. La caoba de hoja ancha es una de las especies incluidas en los Apéndices de la CITES que figuran en el programa OIMT-CITES. “Garantizar que el comercio internacional de especies de madera incluidas en los Apéndices de la CITES es coherente con su ordenación sostenible y conservación”, que abarcó el período 2006-2010. La colaboración con la OIMT ha dado como resultado un compendio sobre tecnologías de seguimiento de la madera y la sugerencia de continuar con una segunda fase de la cooperación OIMT-CITES. Esto puede incluir un estudio comparativo sobre las lecciones extraídas hasta ahora en relación con la caoba de hoja ancha y cómo pueden utilizarse para ayudar a los Estados del área de distribución de cualesquier especies de madera incluidas en los apéndices de la CITES. En su 61^a reunión, el Comité convino en que Perú había satisfecho los tres indicadores de cumplimiento adoptados en la 59^a reunión del Comité Permanente. Sin embargo, Perú aceptó enviar un informe a la Secretaría sobre sus continuos esfuerzos para mejorar la gestión del comercio de caoba de hoja ancha.

La CITES y los medios de subsistencia

22. En la Decisión 15.5 se pide al Comité que encargue a un grupo de trabajo que revise el proyecto de resolución contenido en el Anexo 1 al documento CoP15 Doc. 14, para, entre otras cosas, finalizar un juego de herramientas para la rápida evaluación de los efectos de la aplicación de decisiones de inclusión en los Apéndices de la CITES sobre los medios de subsistencia de los pobres (véase la Resolución Conf. 8.3 (Rev. CoP13). En su 62^a reunión, el Comité sancionó un proyecto de resolución y encargó al grupo de trabajo que terminara las tareas y presentara los resultados a la CoP16. A finales de septiembre de 2012 se celebró en Perú un taller sobre Medios de subsistencia.

Cambio climático

23. En la Decisión 15.15 se encarga a los Comités de Fauna y de Flora que identifiquen los aspectos científicos de las disposiciones de la Convención y de las Resoluciones que se ven, de hecho o probablemente, afectadas por el cambio climático. Esto incluye propuestas de inclusión, dictámenes de extracción no perjudicial, examen periódico de inclusiones, examen del comercio significativo, establecimientos de cupos y comercio de especies invasoras. El Comité Permanente apoyó la conclusión (documento SC62 Doc. 18) de que las actuales disposiciones de la Convención y de las Resoluciones son suficientemente amplias y flexibles para tener en cuenta los efectos del cambio climático para la adopción de decisiones con base científica.

Introducción procedente del mar

24. En la Decisión 14.48 se encarga al Comité que amplíe el mandato del grupo de trabajo sobre la introducción procedente del mar, que se estableció en su 57^a reunión. En la 62^a reunión, el Comité Permanente apoyó el proyecto de revisión de la Resolución Conf. 14.6 (Rev. CoP15) y pidió al grupo de trabajo que continuara su labor sobre la aplicación, y en particular la cuestión del fletamiento. En su 62^a reunión, el Comité acordó transmitir los resultados del grupo de trabajo a la CoP16 como cuatro anexos al proyecto de revisión de la Resolución Conf. 14.6 (Rev. CoP15): 1) Texto sobre fletamiento que debe incluirse en el proyecto de revisión de la resolución; 2) Notas explicativas del proyecto de revisión de la resolución; 3) proyecto de revisión de la Resolución Conf. 12.3 (Rev. CoP15) sobre nuevos códigos fuente para especímenes procedentes del medio marino no sometido a la jurisdicción de ningún Estado; 4) dos proyectos de decisión sobre fletamiento y creación de capacidad, respectivamente. El Comité Permanente está en deuda con los copresidentes y la Secretaría y con todos los miembros del grupo de trabajo por su labor, sumamente ardua, con el fin de concluir este proyecto para la CoP16.

Leyes nacionales para la aplicación de la Convención

25. El Comité Permanente ha instado a las Partes cuya legislación se encuentra en la Categoría 2 o 3 en el Proyecto de legislación nacional a que intensifiquen su impulso legislativo. Además, el Comité ha considerado la utilización de medidas de cumplimiento apropiadas para las Partes que requieran atención prioritaria. En sus 61^a y 62^a reuniones se presentó al Comité un gráfico de situación actualizado. Se ha contactado a los países identificados y se les ha solicitado información sobre sus actividades para corregir la situación. El Comité ha aprobado suspensiones, a menos que se reciban respuestas adecuadas.

Cuestiones financieras y administrativas

26. En la CoP15, la Conferencia de las Partes apoyó un aumento del 6% del presupuesto para el bienio 2012-2013 y recurrir a las reservas del Fondo Fiduciario por una cuantía de 450.000 USD anuales. El Subcomité de Finanzas y Presupuesto se reunió dos veces con ocasión de la 61^a y de la 62^a reuniones del Comité Permanente para facilitar los debates del Comité sobre prioridades y cambios propuestos en las líneas presupuestarias.
27. En su 61^a reunión, el Comité fue informado por la Secretaría de la situación financiera, y de un déficit de 480.000 USD para el año 2011, debido principalmente a aumentos de los costos relacionados con los sueldos y de las fluctuaciones de los tipos de cambio monetarios. Se señaló que el presupuesto de la CITES se establece en dólares estadounidenses, pero que la inmensa mayoría de los gastos se realizan en francos suizos. No obstante, este déficit se ha reducido mediante economías de 250.000 USD en las actividades programáticas y los gastos de funcionamiento de la Secretaría. Como consecuencia de las restricciones financieras mundiales, varias Partes están atrasadas en el pago de sus contribuciones al Fondo Fiduciario. A finales de 2011, las reservas ascendían a 2.298.000 USD.
28. En la 62^a reunión del Comité Permanente, la Secretaría presentó sugerencias sobre la escala de contribuciones para el próximo trienio, que deberán aprobarse en la CoP16. A causa del nivel de aumentos adoptado en las reuniones anteriores de la Conferencia de las Partes ha sido necesario reducir el personal a fin de compensar la disminución de los presupuestos en los últimos diez años. En el período transcurrido entre 2000 y 2011 se han dejado sin cubrir siete vacantes, reduciéndose el personal de 26 a 19 funcionarios en 2012. La Secretaría presentó al Comité una propuesta de aumento de las contribuciones en el próximo trienio, necesario simplemente para mantener el statu quo, y advirtió que de no ser así tal vez hubiera que reducir más el número de funcionarios e introducir otros cambios en la organización de la Secretaría. Si se aplicaran más recortes al presupuesto de la Secretaría ello tendría inevitablemente un impacto negativo en el número de funcionarios, con lo que disminuiría la capacidad de la Secretaría para prestar servicios a las Partes. El Comité reflexionó sobre la difícil situación financiera de muchas Partes e instó a la Secretaría a considerar también toda posible economía y fuentes alternativas de financiación, además de posibles aumentos de las contribuciones de las Partes.
29. En la 62^a reunión del Comité Permanente, el Subcomité de Finanzas y Presupuesto propuso que el Programa de trabajo desglosado por costos para el siguiente trienio reflejara sólo las tareas que se acometerán. Esto deberá ajustarse a la *Visión Estratégica de la CITES 2008-2013*. Además, habrá un presupuesto que se financiará con contribuciones voluntarias adicionales. El Comité apoyó la adopción del nuevo formato del Programa de trabajo desglosado por costos, y presupuestos separados para las contribuciones asignadas y voluntarias adicionales, así como escenarios de presupuestos de crecimiento nominal cero y crecimiento real cero para considerarlos en la CoP16. También acordó recabar el acuerdo de la Conferencia de las Partes para convertir al Subcomité de Finanzas y Presupuesto en comité permanente.

Acceso a mecanismos financieros

30. En la 62^a reunión del Comité Permanente, la Secretaría informó al Comité de mecanismos innovadores para financiar actividades relacionadas con la CITES, pues actualmente hay sólo dos fuentes principales de financiación (contribuciones de las Partes y contribuciones voluntarias). En su 61^a reunión, el Comité pidió al Subcomité de Finanzas y Presupuesto que creara un grupo de trabajo entre reuniones sobre “acceso a la financiación”, incluida la financiación del FMAM. El FMAM ha aprobado un proyecto por valor de 3 millones USD que reforzará las capacidades médico-legales para las especies silvestres en Sudáfrica, a fin de combatir los delitos contra la vida silvestre. El Comité Permanente tomó nota de que la Secretaría presentaría a la CoP16 una propuesta para que el FMAM actúe de mecanismo financiero de la CITES y sobre otras medidas para mejorar la financiación de actividades de la CITES. Además, el Secretario General de la CITES y el Presidente de la Fundación de Financiación Innovadora anunciaron el 9 de febrero de 2012 el inicio de una colaboración para desarrollar una cartera de actividades de financiación innovadoras con la participación de asociados de la industria y el sector financiero.

La aprobación del primer proyecto del FMAM en relación con la CITES es un hito para la CITES.

Mejorar la transparencia de las votaciones durante las reuniones de la Conferencia de las Partes

31. En su 61^a reunión, el Comité debatió y apoyó una propuesta de la Unión Europea para modificar el Artículo 25 de la Conferencia de las Partes a fin de garantizar que los resultados de las votaciones

electrónicas abiertas en la CoP16 y reuniones futuras se muestren en una pantalla, para poder verificar inmediatamente los votos emitidos. Además, el Comité discutió el uso de la votación secreta, y pidió a la Secretaría que presentara en la 62^a reunión un análisis del uso de las votaciones secretas. De conformidad con el Artículo 25.2, las Partes pueden pedir que se proceda a votación secreta en asuntos distintos de las elecciones de candidatos, aunque no será utilizada normalmente. Sin embargo, el análisis documentó que la votación secreta se ha utilizado 69 veces entre la CoP10 y la CoP15, y sólo una vez para la elección de candidatos. Según el Artículo 25.2, toda moción para tomar una decisión de fondo por votación secreta ha de ser apoyada por 10 representantes. El Comité discutió la necesidad de aumentar el número requerido de Partes que apoyen la moción, habida cuenta del mayor número de Partes en la Convención desde que se aprobó la disposición. En su 62^a reunión, el Comité tomó nota del análisis de la Secretaría.

Otras cuestiones planteadas por la Secretaría

El Consorcio Internacional para Combatir los Delitos contra la Vida Silvestre (ICCWC)

32. La nueva iniciativa, ICCWC, se lanzó en 2011 y es una colaboración entre la CITES, OIPC-Interpol, la Organización Mundial de Aduanas, la Oficina de las Naciones Unidas contra la Droga y el Delito (ONUDD) y el Banco Mundial. La finalidad es reforzar la capacidad entre administraciones de aduanas, policía y autoridades CITES, además de mejorar el perfil de la CITES entre quienes determinan las políticas y el poder judicial nacional. Este consorcio es muy prometedor en cuanto a una respuesta más coordinada y formidable para combatir los delitos contra la vida silvestre.

Fomento de capacidad

33. En cumplimiento de la *Visión Estratégica de la CITES: 2008-2013*, contenida en la Resolución Conf. 14.2, el objetivo es lograr el cumplimiento, la aplicación y la observancia de la Convención. Con este fin se han establecido programas de creación de capacidad. La Secretaría ha informado de diversas actividades relacionadas con la creación de capacidad nacional e internacional. La Secretaría se ha centrado en un marco de asociaciones para producir resultados mensurables y acordes con los objetivos de la Resolución Conf. 14.2. Las actividades importantes en el último período han sido: 1) un proyecto financiado por la Comisión Europea sobre el fortalecimiento de la capacidad de países en desarrollo para aplicar la CITES (proyecto plurianual iniciado en 2010), la financiación conjunta de proyectos específicos por países, la colaboración con la ONUDD, OIPC-Interpol, el Banco Mundial, la OMC y países de Asia (que ha dado como resultado un *Juego de herramientas analítico de delitos contra la vida silvestre y forestales*), y la formación en el uso de documentación de comercio electrónico (sistemas de emisión electrónica de permisos CITES); 2) el establecimiento del Colegio Virtual de la CITES como plataforma basada en la web (acogido por la Universidad de Andalucía) para proporcionar acceso a cursos de formación; 3) creación de capacidad y ciencia en relación, entre otras cosas, con dictámenes de extracción no perjudicial, y 4) creación de capacidad y observancia en relación, entre otras cosas, con la Iniciativa Aduanas Verdes para mejorar la capacidad del personal pertinente.

Observaciones finales

34. El volumen de las tareas asignadas al Comité por la CoP ha aumentado mucho en el último decenio. Esto somete también a presión a los grupos de trabajo del Comité y a los Comités de Fauna y de Flora. A pesar de esta carga de trabajo, en mi opinión este ha sido un período exitoso desde la CoP15. Se han abordado y resuelto satisfactoriamente muchas cuestiones importantes. Espero que la labor del Comité ayude a la CoP en sus deliberaciones sobre cuestiones de gran significado, como la "Introducción procedente del mar". Estoy agradecido por las contribuciones voluntarias que se han hecho en el período, que han permitido realizar una importante labor sobre la promoción y aplicación de los requisitos de la CITES. Sin esas contribuciones la situación no hubiera sido buena para las iniciativas relacionadas con la CITES. La CITES está firmemente situada como AAM importante mundialmente que contribuye a la utilización sostenible de la diversidad biológica. Muchas Partes siguen teniendo en todo el mundo grandes dificultades para cumplir las exigencias de la Convención. Recomiendo, pues, que se intensifiquen los esfuerzos en la aplicación nacional mediante iniciativas selectivas y concretas. La colaboración entre Partes es un mecanismo recomendado. La Secretaría de la CITES cuenta también con inapreciables conocimientos de la Convención y se le debe permitir que contribuya más proactivamente al fortalecimiento de la aplicación a nivel nacional. Sin embargo, corresponde a la CoP decidir cómo puede contribuir la CITES a este fin. El debate sobre el presupuesto de la Secretaría de la CITES y un mecanismo para financiar las actividades requeridas en el ámbito nacional deben ser, pues, cuestiones cruciales en la CoP16.

TERMS OF REFERENCE and DUTIES OF REGIONAL REPRESENTATIVES

Terms of Reference

The general terms of reference of the Standing Committee are specified in Resolution Conf. 11.1 (Rev. CoP15) on *Establishment of Committees Annex 1*, as follows:

within the policy agreed to by the Conference of the Parties, the Standing Committee shall:

- a) *provide general policy and general operational direction to the Secretariat concerning the implementation of the Convention;*
- b) *provide guidance and advice to the Secretariat on the preparation of agendas and other requirements of meetings, and on any other matters brought to it by the Secretariat in the exercise of its function;*
- c) *oversee, on behalf of the Parties, the development and execution of the Secretariat's budget as derived from the Trust Fund and other sources, and also all aspects of fund raising undertaken by the Secretariat in order to carry out specific functions authorized by the Conference of the Parties, and to oversee expenditures of such fund-raising activities;*
- d) *provide coordination and advice as required to other committees and provide direction and coordination of working groups established by either itself or the Conference of the Parties;*
- e) *carry out, between one meeting of the Conference of the Parties and the next, such interim activities on behalf of the Conference as may be necessary;*
- f) *draft resolutions for consideration by the Conference of the Parties;*
- g) *report to the Conference of the Parties on the activities it has carried out between meetings of the Conference;*
- h) *act as the Bureau at meetings of the Conference of the Parties, until such time as the Rules of Procedure are adopted; and*
- i) *perform any other functions as may be entrusted to it by the Conference of the Parties;*

Duties of regional representatives

The duties of the regional representatives in the Standing Committee are also laid down in Resolution Conf. 11.1 (Rev. CoP15), as follows:

- a) *regional representatives should maintain a fluid and permanent communication with the Parties of their region and the Secretariat;*
- b) *before the meetings of the Standing Committee, the representatives should communicate to the Parties of their region the items on the agenda, to request their opinions, preferably on matters specifically relevant to the countries or the region. They should also inform them of the results of the meeting. At least two regional meetings should take place between meetings of the Conference of the Parties, one of which should be specifically to deal with proposals to be submitted to the Conference at its next meeting. The regional representatives should convene these meetings; and*
- c) *the regional representatives should report in detail on their activities, initiatives and achievements at the regional sessions that are taking place during meetings of the Conference of the Parties. The Parties may make comments on these reports, which should be included in the proceedings.*

Directed to the Secretariat

15.3 The Secretariat shall continue to monitor Parties that are in arrears of the payment of their financial contributions to the Convention by:

- a) sending reminders twice yearly, with copies to the permanent missions in Geneva;
- b) visiting the permanent missions in Geneva of the Parties in arrears for three or more years; and
- c) seeking assistance from regional representatives to the Standing Committee in following up with Parties concerned.

Cooperation between Parties and promotion of multilateral measures

Directed to the Standing Committee

14.29 The Standing Committee shall continue the Working Group on Multilateral Measures, established at its (Rev. 57th meeting, which, operating by electronic means, should:
CoP15)

- a) review and, if necessary, revise any consultancy report produced under Decision 14.30 (Rev. CoP15);
- b) organize, with the help of the Secretariat, a meeting with representation from all CITES regions to discuss the above report; and
- c) based on the report of the meeting mentioned above, consider the need to draft for consideration at the 16th meeting of the Conference of the Parties any revised or new resolutions.

- c) finalize the voluntary guidelines for Parties to address the negative impacts, in order to assist Parties in developing local, national and regional initiatives that take account of the impacts of implementing CITES listing decisions on the livelihoods of the poor; and
- d) prepare a final version of the tools and guidelines for review and endorsement by the Standing Committee at its 62nd meeting.

The Working Group shall continue to work electronically through a forum available on the CITES website. If funding is available, consideration may be given to holding one or more meetings, if possible in regions more likely to be affected by the outcome.

The process shall not include consideration of the criteria for amendment of the Appendices or the requirement to make non-detriment findings.

Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES)

Directed to the Animals and Plants Committees and the Secretariat

15.12 Without taking a position about the necessity for, or nature of, such a Platform, the Chairs of the Animals and Plants Committees and the Secretariat shall, subject to external funding, participate in discussions concerning a possible IPBES, to provide all necessary input into the process of IPBES and to ensure that the role of CITES receives due recognition. The Chairs of the Animals and Plants Committees and the Secretariat shall report to the Standing Committee to seek additional guidance.

Directed to the Secretariat

15.13 The Secretariat shall work with the United Nations Environment Programme to identify possible sources of external funding to support the participation called for in Decision 15.12.

Directed to the Standing Committee

15.14 The Standing Committee shall report at the 16th meeting of the Conference of the Parties concerning the IPBES.

Climate change

Directed to the Animals and Plants Committees

15.15 Given the implications of climate change for science-based decision-making, the Animals and Plants Committees shall identify the scientific aspects of the provisions of the Convention and of Resolutions

of the Conference of the Parties that are actually or likely to be affected by climate change, report their findings, and make recommendations for further action in relation to the Convention and to Resolutions of the Conference of the Parties as appropriate, at the 62nd meeting of the Standing Committee.

Directed to the Secretariat

- 15.16 The Secretariat shall request from the secretariats of other multilateral environmental agreements information on their activities that may be linked to climate change and CITES, and report to the Animals and Plants Committees and the Standing Committee.

Directed to the Standing Committee

- 15.17 The Standing Committee shall consider the reports of the Animals and Plants Committees and the Secretariat and report at the 16th meeting of the Conference of the Parties.

Completed. See document SC62 Sum. 8 item 18.

Food and Agriculture Organization of the United Nations (FAO)

Directed to the Standing Committee

- 15.18 The Standing Committee shall analyse the current Memorandum of Understanding (MoU) between CITES and FAO, determine the cooperative scheme between CITES and FAO on forestry issues, and ensure that future cooperation between FAO and CITES is carried out under the framework of the MoU.

Review of Resolutions

CoP15) to some or all of the commercially exploited aquatic species that were proposed for inclusion on Appendix II at the 13th, 14th and 15th meetings of the Conference of the Parties, highlighting any technical difficulties or ambiguous issues encountered, including, where appropriate, illustrations of these matters by comparison with application of the criteria to other species;
- b) request IUCN/TRAFFIC and the Food and Agriculture Organization of the United Nations to each prepare a report, subject to the availability of external funding, with the same requirements as the report referred to in paragraph a) above; and

- c) submit its report and any received under paragraph b) above for consideration at the 25th meeting of the Animals Committee.

Directed to the Animals Committee

15.29 The Animals Committee shall:

- a) on receipt of any or all of the reports referred to in Decision 15.28, and having sought the participation of representative(s) of the Plants Committee, IUCN, TRAFFIC, the Food and Agriculture Organization of the United Nations and other appropriate experts, develop guidance on the application of criterion B and the introductory text of Annex 2 a of Resolution Conf. 9.24 (Rev. CoP15) to commercially exploited aquatic species proposed for inclusion on Appendix II;
- b) recommend the best way to incorporate the guidance for use when applying Resolution Conf. 9.24 (Rev. CoP15) to commercially exploited aquatic species, without affecting the application of Resolution Conf. 9.24 (Rev. CoP15) to other taxa; and
- c) submit its conclusions and recommendations at the 62nd meeting of the Standing Committee.

Directed to the Standing Committee

15.30 The Standing Committee shall:

- a) consider the report and recommendations submitted by the Animals Committee under Decision 15.29 together with comments or other input that the Food and Agriculture Organization of the United Nations may wish to submit; and

- d) report at the 61st and 62nd meetings of the Standing Committee on Parties' progress in adopting adequate measures and, if necessary, recommend the adoption of appropriate compliance measures, including suspension of trade;
- e) identify for the Standing Committee any countries that require attention as a priority under the National Legislation Project; and
- f) report at CoP16 on the progress made with regard to the implementation of Resolution Conf. 8.4 (Rev. CoP15) and Decisions 15.38, 15.39, 15.40 and 15.41.

National reports

Directed to the Standing Committee

14.37 The Standing Committee, with the assistance of its Working Group on Special Reporting (Rev. Requirements and the Secretariat, shall:
CoP15)

- a) continue its review of the recommendations to Parties to provide special reports under the Convention, assess whether they have been or might be effectively incorporated into the annual and biennial reports, and consider how the biennial report format might be revised to facilitate such incorporation;
- b) revise the standard biennial report format to gather information from Parties on incentive measures for implementation of the Convention, conservation measures for Appendix-I listed species and case studies on user fees;
- c) by its 61st meeting (SC61), follow up on how the reporting required in the indicators for the *CITES Strategic Vision: 2008-2013* would be undertaken and, by SC62, begin applying the indicators; and
- d) report at the 16th meeting of the Conference of the Parties on its conclusions and recommendations.

- b) identify additional ways to reduce the reporting burden on Parties, *inter alia*, in the context of Party-led initiatives, its ongoing review of the Resolutions and Decisions of the Conference of the Parties, its support to the Standing Committee on electronic permitting and its work with partners to compile and analyse CITES-related reports; and
- c) report at the 16th meeting of the Conference of the Parties on the results of this work.

Reporting on trade in artificially propagated plants

Directed to the Secretariat

14.39 The Secretariat shall, subject to available funding, in consultation with the UNEP World Conservation Monitoring Centre:

(Rev.
CoP15)

- a) conduct a survey of reporting practices of Parties relating to trade in artificially propagated plants of taxa included in Appendix II, e.g. regarding the degree of completeness and detail;
- b) identify cases where the compilation of trade data pertaining to artificially propagated plants of taxa included in Appendix II has contributed to a significant extent to the detection of illegal trade or to any other analysis related to the conservation of wild flora;
- c) taking into consideration the results of paragraphs a) and b) above, analyse the Convention text and Resolutions in order to identify binding and non-binding elements of reporting, with special emphasis on artificially propagated plants of taxa included in Appendix II. The Secretariat shall list options for streamlining such reporting; and
- d) report on its findings to the Plants Committee prior to its 20th meeting.

Directed to the Plants Committee

14.40 The Plants Committee shall, after considering the report of the Secretariat:

(Rev.

- CoP15)
- a) determine whether there are any taxa of Appendix-II plants artificially propagated for which detailed reporting is less valuable; and
 - b) report its findings to the Standing Committee at its 62nd meeting.

Directed to the Standing Committee

14.41 The Standing Committee shall:

(Rev.

- CoP15)
- a) taking into consideration the findings of the Plants Committee, determine whether it is possible to streamline the reporting of trade in artificially propagated Appendix-II plants; and
 - b) report on its findings at the 16th meeting of the Conference of the Parties and submit draft wording to amend Resolutions concerned, where appropriate.

Completed. Work continue through revised or new decisions by CoP16.

Gathering and analysis of data on illegal trade

Directed to the Secretariat

15.42 The Secretariat shall establish an illegal trade database working group to:

- a) design and implement a database to be used by the Parties and the Secretariat for the gathering and analysis of data related to illegal trade in specimens of CITES-listed species;

- b) seek external funding to enable the group to conduct its activities, assisted by a relevant consultant if appropriate; and
- c) report to the Standing Committee at its 61st and 62nd meetings on the progress of the working group.

Directed to the Standing Committee

- 15.43 The Standing Committee shall consider the reports of the Secretariat and also consider:
- a) endorsing any relevant recommendation or measure that could be implemented prior to the 16th meeting of the Conference of the Parties (CoP16); or
 - b) requesting the Secretariat to prepare a report for consideration at CoP16.

Completed. At SC61 the SC agreed that it was impracticable for the Secretariat to maintain an illegal trade database. See Summary Record, item 31. The Working Group on Special Reporting Requirements was asked to consider this issue and has produced a report for CoP16.

Illegal trade in great apes

Directed to the Secretariat

- 15.44 The Secretariat shall seek external funding to undertake, in conjunction with GRASP, ICPO-INTERPOL and the World Customs Organization, technical missions to a limited number of gorilla range States. The Secretariat shall report to the Standing Committee on the outcome of the missions.

Directed to the Standing Committee

- 15.45 The Standing Committee shall consider the report of the Secretariat and also consider:
- a) endorsing any relevant recommendation or measure that could be implemented prior to the 16th meeting of the Conference of the Parties (CoP16); and
 - b) requesting the Secretariat to prepare a report for consideration at CoP16.

Asian big cats

Directed to Parties, especially tiger range States

- 15.46 All Parties, but particularly tiger range States, should submit, by 30 June 2010, information relating to incidents of poaching of and illegal trade in tigers that have occurred within their territory since the beginning of 2007. Information should be submitted using the Ecomessage format distributed in Notification to the Parties No. 2009/028 of 22 July 2009. Ecomessage forms for each incident should be submitted to the CITES Secretariat or to the General Secretariat of ICPO-INTERPOL via INTERPOL National Central Bureaus.

Directed to the Secretariat

- 15.47 The Secretariat shall collaborate with ICPO-INTERPOL to undertake an analysis of the information received from Parties. Two reports, one for public consumption and the other solely for the law enforcement community, should be prepared. The public document will be posted on the CITES website, whilst the other will be circulated in a restricted fashion to relevant enforcement agencies. The Secretariat shall report on this matter at the 61st meeting of the Standing Committee and make any relevant recommendations as a result of the analysis.

15.48 The Secretariat shall seek funds to convene, as soon as possible, a seminar involving senior-level Customs and police officers from tiger range States, to brief them on the threatened status of this species, particularly the impact wildlife crime has upon it. The officials shall also be briefed by the Secretariat regarding the Global Tiger Summit, planned under the Global Tiger Initiative, so that the law enforcement community throughout tiger range States is prepared to engage in efforts to safeguard this species and respond to measures adopted at the Summit. The Secretariat shall collaborate with ICPO-INTERPOL, the United Nations Office on Drugs and Crime and the World Customs Organization in preparing the seminar. The Secretariat shall report on the outcomes of the seminar at the 61st meeting of the Standing Committee.

Directed to the Standing Committee

15.49 At its 61st meeting, the Standing Committee shall consider the report of the Secretariat and determine what actions are necessary as a result of the analysis and the seminar. This could include instructing the Secretariat to convene the CITES Tiger Enforcement Task Force or CITES Enforcement Expert Group to consider further action.

Introduction from the sea

Directed to the Standing Committee

14.48 The Standing Committee shall:

(Rev.

- CoP15) a) extend operation of the Working Group on Introduction from the Sea, established at SC57, with the understanding that it shall continue to work primarily through electronic means, to consider a definition for 'transportation into a State', clarification of the term 'State of introduction' and the process for issuing a certificate of introduction from the sea as well as other issues identified for further consideration in the final report of the CITES Workshop on Introduction from the Sea Issues (Geneva, 30 November – 2 December 2005) and the final report of the meeting of the working group held in Geneva from 14 to 16 September 2009;
- b) include in the working group representatives of CITES authorities and fishery authorities from each of the six CITES regions and request the participation of and input from the United Nations Division for Ocean Affairs and the Law of the Sea, the Food and Agriculture Organization of the United Nations, regional fishery bodies, the fishing industry, and intergovernmental organizations and non-governmental organizations with CITES and fishery expertise; and
- c) ask the working group to prepare a discussion paper and draft revised resolution for consideration by the Standing Committee at its 62nd meeting and for consideration at the 16th meeting of the Conference of the Parties.

Directed to the Secretariat

15.50 The Secretariat shall, contingent on the availability of external funding, convene two meetings of the working group before the 62nd meeting of the Standing Committee.

Electronic permitting

Directed to the Standing Committee

15.55 The Standing Committee shall extend the mandate of its Working Group on Information Technologies and Electronic Systems in order for it to perform the following tasks:

- a) gather information from Parties and relevant organizations and initiatives on new developments related to electronic permitting systems, and submit such information to the Secretariat for possible inclusion in the toolkit;
- b) collaborate with the Secretariat in updating the toolkit with new information related to the use of common information exchange formats, protocols and standards and electronic signatures;
- c) promote the development and use of electronic permitting systems among Parties;
- d) examine how electronic permitting can contribute to ensuring legal electronic commerce in specimens of CITES-listed species;
- e) invite relevant organizations with knowledge about electronic permitting systems to join the Working Group; and
- f) report to the Standing Committee at its regular meetings on the results of its work.

Completed. See document SC61 Summary record item 33 and document SC62 Sum. 6 item 32.

Directed to the Secretariat

- 15.56 In collaboration with the Working Group on Information Technologies and Electronic Systems, the Secretariat shall, subject to external funding:
- a) update the CITES electronic toolkit according to new electronic permitting standards and norms;
 - b) work with relevant international organizations and initiatives related to electronic permitting systems to raise awareness of CITES business procedures and permitting requirements; and
 - c) organize capacity-building workshops to assist Parties in using the CITES electronic permitting toolkit to develop, implement or update electronic permitting systems.

Purpose codes on CITES permits and certificates

Directed to the Standing Committee

- 14.54 The Standing Committee shall re-establish an intersessional joint working group to review the use of (Rev. purpose-of-transaction codes by Parties, with the following terms of reference:
CoP15)
- a) the working group shall be composed of Parties from as many of the six CITES regions as possible, and appropriate intergovernmental and non-governmental organizations, with expertise in the issuance of CITES documents and use of purpose-of-transaction codes for evaluation within the permit issuance process and trade data analysis;
 - b) the working group shall, communicating through electronic media, focus on clearly defining purpose-of-transaction codes to encourage their consistent use, and consider the possible elimination of current codes or the inclusion of new ones;
 - c) in evaluating the use and definition of purpose-of-transaction codes, the working group should take into account any difficulties of implementation by Parties and the potential resource implications of inclusion of any new codes or deletion of current purpose-of-transaction codes; and
 - d) the working group should submit a report and any recommendations for amendments to Resolution Conf. 12.3 (Rev. CoP15), or to any revision thereof, at the 62nd meeting of the Standing Committee, which shall report, with its recommendations, at the 16th meeting of the Conference of the Parties.

Physical inspection of timber shipments

Directed to the Standing Committee

- 14.61 The Standing Committee, with the support of the Secretariat, and in consultation with Parties and (Rev. relevant intergovernmental organizations, shall consider the outcome of the working group on physical CoP15) inspection of timber shipments at its 61st meeting, to identify best practices and capacity-building measures that may be implemented with technical and/or financial support from donors, and report at the 16th meeting of the Conference of the Parties.

Completed. See document SC61 Sum 10 (Rev. 1) item 35 and document SC62 Sum. 6 (Rev. 1) item 36.

Use of taxonomic serial numbers

Directed to the Standing Committee

- 15.68 The Standing Committee shall, at its 61st meeting (SC61), establish a working group, in consultation with the nomenclature experts of the Animals and Plants Committees and the UNEP World Conservation Monitoring Centre, to:

- a) investigate the usefulness and feasibility of incorporating taxonomic serial numbers as an element of CITES data sets;
- b) report its findings at SC62; and
- c) if necessary, prepare a draft resolution for submission and consideration at the 16th meeting Conference of the Parties.

Completed. See document SC61 Summary record item 36.1 and document SC62 Sum. 6 (Rev. 1) item 37.

Personal and household effects

Directed to the Standing Committee

- 14.64 The Standing Committee shall extend the operation of its Working Group on Personal and Household (Rev. Effects until the 16th meeting of the Conference of the Parties (CoP16) and oversee the Group's work CoP15) in fulfilling the following terms of reference:

- a) clarify the relationship between 'tourist souvenirs', 'hunting trophies' and 'personal and household effects';
- b) clarify the interpretation of Article VII, paragraph 3 (b), of the Convention;
- c) assess whether there are specific species or types of personal or household effects which, in view of conservation concerns, would require different treatment under Resolution Conf. 13.7 (Rev. CoP14);
- d) collate information about how each Party has implemented Resolution Conf. 13.7 (Rev. CoP14), particularly with regard to requirements for export permits, and assess whether this indicates the need to amend the Resolution; and
- e) report at each regular meeting of the Standing Committee until CoP16 and at CoP16.

Completed. See document SC61 Summary record item 38 and document SC62 Sum. 7 item 40.

Conservation of and trade in tigers and other Appendix-I Asian big cat species

Directed to the Standing Committee

15.70 The Standing Committee shall review and update the form and guidance contained in Annexes 1 to 3 in Resolution Conf. 12.5 (Rev. CoP15) and report on this matter at the 16th meeting of the Conference of the Parties.

Completed. See document SC61 Summary record item 41 and document SC62 Sum. 6 (Rev. 1) item 43.

Conservation of and trade in African and Asian rhinoceroses

Directed to the Secretariat

15.71 The Secretariat shall:

- a) examine the implementation of Resolution Conf. 9.14 (Rev. CoP15) in those range States where illegal killing of rhinoceros poses a significant threat to populations of rhinoceros, particularly Zimbabwe and South Africa;
- b) examine progress with regards to curtailing illegal trade in rhinoceros parts and derivatives by implicated States, particularly Viet Nam; and
- c) report on the implementation of Resolution Conf. 9.14 (Rev CoP15) at the 61st, 62nd and 63rd meetings of the Standing Committee.

15.72 The Secretariat shall:

- a) facilitate, as a matter of urgency, and with others partners as appropriate, bilateral exchanges between key rhinoceros range States and rhinoceros horn consumer States, to improve wildlife enforcement cooperation efforts;
- b) report at the 61st and 62nd meetings of the Standing Committee (SC61 and SC62) on these efforts;
- c) seek funds to convene a joint CITES Ivory and Rhinoceros Enforcement Task Force. Besides the Secretariat, members should include the ASEAN Wildlife Enforcement Network Programme Coordination Unit, INTERPOL, the Lusaka Agreement Task Force, the United Nations Office on Drugs and Crime, the World Customs Organization and those Parties in Africa and Asia that are currently most affected by the smuggling of ivory and rhinoceros specimens. Priority should be given to including the following Parties: Cameroon, China, Ethiopia, Kenya, the Lao People's Democratic Republic, Mozambique, Nepal, the Philippines, South Africa, Thailand, the United Arab Emirates, the United Republic of Tanzania, Viet Nam and Zimbabwe. The Task Force should undertake an exchange of intelligence regarding smuggling of ivory and rhinoceros specimens and develop strategies for combating illegal trade; and
- d) report on the work of the Task Force at SC61.

Directed to the Standing Committee

15.73 At its 61st and 62nd meetings, the Standing Committee shall consider the reports of the Secretariat requested under Decision 15.72 and determine what further actions, if any, are necessary.

Completed. See document SC61 Summary record item 45.2 and document SC62 Sum. 7 (Rev. 1) item 47.

Elephant conservation

13.26 The Conference of the Parties adopted the *Action plan for the control of trade in elephant ivory* (Rev. attached as Annex 2 to these Decisions. [NB: Implementation of the *Action plan* requires consultation CoP15) with the Standing Committee and reporting at each regular meeting.]

Directed to Parties, intergovernmental organizations and non-governmental organizations

14.76 Parties, trading countries, the ivory carving industry, intergovernmental organizations, non-governmental organizations and other donors are called upon to contribute significantly to the African Elephant Fund for the implementation of the *African elephant action plan* and the programme for Monitoring the Illegal Killing of Elephants (MIKE) to ensure their establishment and maintenance.

Directed to the Standing Committee

14.77 The Standing Committee, assisted by the Secretariat, shall propose for approval at the latest at the 16th meeting of the Conference of the Parties a decision-making mechanism for a process of trade in ivory under the auspices of the Conference of the Parties.

Underway. See document SC61 Summary record item 44.4 and document SC62 Sum. item 46.4.

Directed to the Secretariat

14.78 In preparation for the 61st and 62nd meetings of the Standing Committee, pending the necessary (Rev. external funding, the Secretariat shall:
CoP15)

- a) produce an updated analysis of MIKE data, pending the availability of adequate new MIKE data;
- b) invite TRAFFIC to submit an updated analysis of ETIS data and UNEP-WCMC to provide an overview of the latest elephant trade data;
- c) invite the IUCN/SSC African and Asian Elephant Specialist Groups to submit any new and relevant information on the conservation status of elephants, and on pertinent conservation actions and management strategies; and
- d) invite the African elephant range States to provide information on progress made in the implementation of the *African elephant action plan*.

On the basis of the information specified above, the Secretariat shall recommend actions for consideration by the Standing Committee.

14.79 The Secretariat shall establish an African Elephant Fund that will be applied to the implementation of (Rev. the *African elephant action plan*.
CoP15)

The Secretariat shall establish a steering committee consisting of representatives of the range States and donors to govern the African Elephant Fund and to support and advise African elephant range States on the implementation of the Action Plan.

The Steering Committee shall decide on the organization of the administration of the fund.

Trade in elephant specimens

Directed to the Standing Committee

15.74 The Standing Committee shall, in consultation with African and Asian elephant range States and the Secretariat, evaluate the need to revise Resolution Conf. 10.10 (Rev. CoP15) and present a summary of the consultations and its proposals in this regard at the 16th meeting of the Conference of the Parties.

Completed. See document SC61 Summary record item 44.5 and document SC62 Sum. 4 item 46.5.

Snake trade and conservation management

Directed to the Secretariat

15.75 The Secretariat shall, subject to available funds, convene a technical workshop to consider the conservation priorities and management and enforcement needs related to the trade of snakes in Asia, with a particular focus on the markets and commercial trade in East, South, and Southeast Asia.

- a) The Secretariat shall invite the members of the Animals and Standing Committees, representatives from range, exporting and consumer states, and relevant inter-governmental and non-governmental organizations to participate in this workshop, to be held within 12 months of the conclusion of the 15th meeting of the Conference of the Parties.
- b) The Secretariat shall contract with appropriate technical experts to prepare documents on Asian snake conservation, trade management, enforcement, and biology for the workshop and shall invite workshop participants to submit the same.
- c) The findings and recommendations of this workshop should be reported by the Secretariat to the Animals and Standing Committees.

Directed to the Animals Committee

15.76 The Animals Committee shall consider the results of this workshop and provide their recommendations to the Standing Committee for its consideration.

Directed to the Standing Committee

15.77 The Standing Committee shall consider the recommendations by the Animals Committee and make its own recommendations at the 16th meeting of the Conference of the Parties.

Completed. See document SC61 Summary record item 46.1 and document SC62 Sum. 9 (Rev. 1) item 48.

Directed to Parties, non-governmental organizations, commercial traders, and donors

15.78 Parties and non-Parties, inter-governmental organizations, non-governmental organizations, commercial traders, and donors are encouraged to provide funding to the Secretariat for this technical workshop.

Tortoises and freshwater turtles

Directed to the Animals Committee

15.79 The Animals Committee, at its 25th meeting, shall review the final study from the IUCN Species Survival Commission, Tortoise and Freshwater Turtle Specialist Group (IUCN-TFTSG) mentioned in Decision 14.128¹ and make recommendations to the Standing Committee and/or at the 16th meeting of the Conference of the Parties as appropriate.

Directed to the Standing Committee

15.80 The Standing Committee, taking into account the recommendations of the Animals Committee, shall review the pertinent sections, conclusions, and recommendations of the final study mentioned in Decision 14.128³ and make its own recommendations at the 16th meeting of the Conference of the Parties.

Completed. See document SC61 Summary record item 47 (Rev. 2) and document SC62 Sum. 9 item 49.

¹ Note from the Secretariat: Decision 14.128 was deleted at the 15th meeting of the Conference of the Parties. It read as follows: "The Secretariat shall, subject to external funding, contract the Tortoise and Freshwater Turtle Specialist Group of the IUCN Species Survival Commission to undertake a study which would assist in the implementation of Resolution Conf. 11.9 (Rev. CoP13)."

Humphead wrasse

Directed to Parties

15.86 All Parties are urged to:

- a) consider adopting appropriate stricter domestic measures under the remit of the legislation of the Party, including limiting the international trade in humphead wrasse to be conducted by air only, to strengthen the control and enforcement of the Appendix-II listing for the species;
- b) improve monitoring of trade in humphead wrasse, especially through inspections of boxes of mixed live reef fish by exporting, re-exporting and importing countries;
- c) exchange law enforcement information of relevance to humphead wrasse with other relevant Parties, and regularly compile and forward to the Secretariat for distribution a comprehensive summary of Convention violations for the species;
- d) increase awareness of the CITES listing for humphead wrasse, including by improving identification capacity among law enforcement officers through the use of training and educational materials;
- e) facilitate discussion on practicable and acceptable options for action to be taken in case of illegally imported/confiscated live fish; and
- f) provide information to the Secretariat on actions taken to implement this Decision, in order to inform the work of the Humphead Wrasse Working Group to be established by the Standing Committee pursuant to Decision 15.87.

Directed to the Standing Committee

15.87 The Standing Committee shall, contingent on the availability of external funding, establish a Humphead Wrasse Working Group, which is to:

- a) review the actions taken by relevant Parties to implement this decision;
- b) develop and recommend to the Standing Committee further options for improving control and enforcement in relation to the international trade in humphead wrasse, and ensuring the effectiveness of the Appendix-II listing of the species; and
- c) report back and recommend appropriate follow-up actions at the 16th meeting of the Conference of the Parties to support this initiative.

Completed. See document SC61 Summary record item 49 and document SC62 Sum. 9 (Rev. 1) item 51.

Directed to the Secretariat

15.88 The Secretariat is requested:

- a) to assist Parties in the capacity-building activities outlined in paragraph d) of Decision 15.86; and
- b) where necessary, to provide assistance or advice to Parties to address the handling of confiscated live humphead wrasse.

Bushmeat

Directed to the Central Africa Bushmeat Working Group

14.73 The Central Africa Bushmeat Working Group is encouraged to collaborate with the Convention on Biological Diversity and the Food and Agriculture Organization of the United Nations in its work and is

invited to draw to the attention of the Standing Committee and/or the Conference of the Parties to any matters relating to the implementation of Resolution Conf. 13.11.

- 14.74 The Central Africa Bushmeat Working Group is encouraged to continue its work, also by collaborating (Rev. with the Convention on Biological Diversity Liaison Group on non-timber forest resources, and to CoP15) report to the Standing Committee on progress made in implementing national action plans relating to the trade in bushmeat and other initiatives it takes regarding this subject. A report on the subject of bushmeat should be submitted at the 16th meeting of the Conference of the Parties.
