## Working group – Appendix I import NDF draft mandate:

The Working Group shall:

- 1) Consider Module 4 and make improvements and amendments based on discussions.
- 2) Consider the following specific matters:
  - a) Taking into consideration the pre-NDF checklist in Module 2, identify whether additional specific aspects should be included in Module 4 (Stage 1) or whether Stage 1 of the guidance should be incorporated in Module 2;
  - b) Risks to be assessed in Stage 2 and whether guidance in Module 1 and 2 could be referenced or whether the list in the table of the decision tree in Stage 2 should be retained;
  - c) The indicators of potential trade after import in Stage 2: discuss the indicators included and resolve iv) that include reference to restrictions in adjacent countries;
  - d) Consider whether trade / import and / or only the intended purpose of import should be addressed in the NDF made by the importing country in view of the text of the Convention;
  - e) Consider the questions and aspects addressed in Stage 3 and the level of detail to be included as part of the engagement with the exporting country and resolve the bracketed section to ensure alignment with the text of the Convention;
  - f) Discuss the bracketed text in Stage 4: the level of risk associated with each category of information; and overall risk related to harvest and export controls to be assessed? The text of the Convention specifies that the purpose of the import should be considered by the Scientific Authority of the importing country.
  - g) Additional considerations, e.g., impact on demand;
  - h) Share practices of Parties in the working group to further inform the guidance (see list of Parties from trade records that have reported more than 50 records of imports of App. I specimens between 2017 and 2021);
  - i) Consider the trade data information below and discuss further guidance relating to specific purpose of imports;
  - j) Develop a case study / application of the draft guidance that could serve as an example.
  - k) Submit revised draft guidance to the Secretariat and IUCN.

- 5) By Thursday, 7 December, 5pm, submit recommendations to the Secretariat for a feedback mechanism for Parties and the wider CITES community to share experiences with using NDF guidance, and to review and update the NDF materials as may be needed.
