



# NOTIFICATION TO THE PARTIES

## CONCERNING:

## AMENDMENTS OF APPENDICES I AND II OF THE CONVENTION

- 1. In accordance with the provisions of Article XV, paragraph 1 (a) of the Convention, amendment proposals were received from the competent authorities of Argentina, Australia, Bahamas, Bangladesh, Belize, Benin, Bolivia (Plurinational State of), Botswana, Brazil, Burkina Faso, Burundi, Cabo Verde, Cameroon, Canada, the Central African Republic, Chad, Chile, Comoros, Congo, Costa Rica, Côte d'Ivoire, the Democratic Republic of the Congo, the Dominican Republic, Ecuador, Eguatorial Guinea, Ethiopia, the European Union, Fiji, Gabon, Gambia, Guinea, Guinea-Bissau, Honduras, Israel, Jamaica, Kazakhstan, Lebanon, Maldives, Mali, Mauritania, Mexico, Namibia, Niger, Nigeria, North Macedonia, Oman, Panama, the Philippines, Samoa, Senegal, Seychelles, Sierra Leone, South Africa, Sri Lanka, Sudan, Switzerland, the Syrian Arab Republic, Tajikistan, Togo, Tunisia, the United Kingdom of Great Britain and Northern Ireland, the United Republic of Tanzania, the United States of America and Zimbabwe. All of these are Parties to the Convention and have communicated to the Secretariat proposals for amendment of Appendices I and II of the Convention within the established deadline, i.e. 27 June 2025. A list of the amendment proposals received is annexed to this Notification. These proposals will be considered at the 20th meeting of the Conference of the Parties to the Convention, to be held in Samarkand (Republic of Uzbekistan) from 24 November to 5 December 2025.
- 2. In accordance with Resolution Conf. 4.6 (Rev. CoP19) and Resolution Conf. 9.24 (Rev. CoP17), all the above-mentioned proposals for amendment were accompanied by supporting statements presented in the agreed format. Taking into account the volume of the documentation received and in order to avoid delays for communicating the amendment proposals, supporting statements have been posted on the CITES website (<u>https://cites.org/eng/cop/20/amendment-proposals</u>) in their original form. The formatted amendment proposals for the meeting of the Conference of the Parties will be posted on the website as they become available.
- 3. In accordance with the provisions of paragraphs 1 (a), 2 (b) and 2 (c) of Article XV of the Convention, the list of amendment proposals is communicated to the Parties for comments. Since the responses have to be communicated to all Parties no later than 30 days before the meeting of the Conference of the Parties, the Secretariat would appreciate receiving responses from the Parties, if any, as soon as possible and no later than **25 September 2025**.
