Additional comments	<p>In general there are stricter measures for the trading and possession of Appendix I /Annex A specimens (source W or F), primates, large felidae, hawks, rhino horns and tiger bones. Through European Regulations and Directives, such as the European Bird and Habitat Directive, these restrictions also apply to other species. It is only possible to trade and keep hawks with source C if accompanied by DNA fingerprints and an exemption for prohibition of possession had been giving by the Minister.</p> <p>By national law for Annex A specimens of all sources, it is obligated to maintain a register. This rule also applies to birds of Annex B without a seamless closed foot ring.</p> <p>Birds of Annex A need to be marked conform the national legislation on foot rings. Other vertebrates of Annex A need to be marked conform EU legislation .</p>

Besluit:

## Artikel 1

1. Als plaatsen als bedoeld in artikel 17 van het Besluit vrijstelling beschermd dier- en plantensoorten worden voor levende dieren of planten, behorende tot soorten genoemd in de bijlagen van verordening (EG) nr. 338/97 van de Raad van de Europese Unie van 9 december 1996 inzake de bescherming van in het wild levende dier- en plantensoorten door controle op het desbetreffende handelsverkeer (PbEG L 61), en voor producten, nesten of eieren van die dieren of producten van planten, met inachtneming van artikel 12, vierde lid, van voornoemde verordening en het tweede lid, de volgende douane-kantoren aangewezen:

A. voor levende dieren:

1. Schiphol-Gebouw Cargocentre, Handelskade 130;
2. Schiphol-Gebouw WTC, Amsterdam Airport Schiphol;
3. Maastricht-Aachen Airport Passagiersafhandeling;
4. Maastricht-Aachen Airport Vrachtafhandeling, en

B. voor levende planten en producten, nesten en eieren van dieren of producten van planten, alle douane-kantoren.

2. Indien voor dieren dan wel producten, nesten of eieren van dieren, behorende tot soorten als bedoeld in het eerste lid, veterinaire voorschriften gelden, worden deze dieren, producten, nesten of eieren daarvan bin-

nengebracht op plaatsen die voor de betrokken dieren of producten, nesten of eieren daarvan als inspectiepost aan de grens zijn erkend ingevolge richtlijn 91/496/EWG van de Raad van de Europese Gemeenschappen van 15 juli 1991 tot vaststelling van de beginselen voor de organisatie van de veterinaire controles voor dieren uit derde landen die in de Gemeenschap worden binnengebracht en tot wijziging van de richtlijnen 89/662/EWG, 90/425/EWG en 90/675/EWG (PbEG L 268) of richtlijn 97/78/EG van de Raad van de Europese Unie van 18 december 1997 tot vaststelling van de beginselen voor de organisatie van de veterinaire controles voor producten die uit derde landen in de Gemeenschap worden binnengebracht (PbEG 1998, L 24).

## Artikel 2

## Toelichting

Ingevolge artikel 12 van Verordening (EG) nr. 338/97 van de Raad van de Europese Unie van 9 december 1996 inzake de bescherming van in het wild levende dier- en plantensoorten door controle op het desbetreffende handelsverkeer (PbEG L 61) dienen de lidstaten douanekantoren aan te wijzen waar de controles en formaliteiten worden vervuld voor het binnenvrengen in de Gemeenschap en voor de uitvoer uit de Gemeenschap

van specimens van dier- en plantensoorten die zijn opgenomen in de bijlagen van die verordening. Artikel 12 van bedoelde verordening schrijft voor dat levende dieren enkel mogen worden binnengebracht op plaatsen waar passende accommodatie aanwezig is.

Alleen de luchthavens in Amsterdam (Schiphol) en Maastricht zijn aangewezen waar levende dieren vanuit derde landen het grondgebied van Nederland mogen worden binnengebracht of vanuit Nederland naar derde landen mogen worden uitgevoerd. Levende planten of producten, nesten en eieren van dieren of producten van planten mogen via alle douanekantoren worden binnengebracht of uitgevoerd.

Voor een aantal specimens gelden ook veterinaire of fytosanitaire voorschriften. Veterinaire controles aan de buitenlijn van de Europese Gemeenschap mogen slechts worden uitgevoerd in daartoe bij besluit van de Commissie van de Europese Gemeenschappen voor de betrokken dieren of producten van dieren erkende veterinaire inspectieposten. Voor de betreffende specimens dient de internationale export dus via een van deze inspectieposten te geschieden. Artikel 1, tweede lid, van de regeling geeft dit aan. De lijst met erkende inspectieposten wordt bekend gemaakt in het Publicatieblad van de Europese Gemeenschappen.

De inwerkingtreding van deze regeling is gekoppeld aan de inwerkingtreding van artikel 17 van het Besluit vrijstelling beschermd dier- en plantensoorten, waarop de regeling gebaseerd is. Op deze wijze kunnen in een vroegtijdig stadium ministeriële regelingen in de Staatscourant gepubliceerd worden, opdat belanghebbenden hiervan tijdig kennis kunnen nemen.

**Live specimens: plants**

1. Administrative law enforcement CITES seized 1020 plants of the family Orchidaceae. The shipment was in transit from Ecuador to Switzerland. The actual quantity of plants transported exceeded the amount mentioned on the CITES export permits, due to the fact that many plants had been tied together. Our botanical expert did not find evidence that the plants were taken from the wild. The plants were donated to a botanical garden. All costs have been passed on to the airline company transporting the shipment.
2. Administrative law enforcement CITES seized 104 plants belonging to the genus *Paphiopedilum*. The shipment was in transit from Taiwan to the Russian Federation. The actual quantity of plants transported exceeded the amount mentioned on the CITES export permit. In addition the shipment contained different plant species than listed on the export permit. There was no evidence that the plants had been taken from the wild. The plants were donated to a botanical garden. All costs have been passed on to the Dutch transport company.
3. Administrative law enforcement CITES seized 5000 plants belonging to the species *Cypripedium reginae*. The shipment was accompanied by a Canadian CITES export permit, but the required CITES import permit was missing. The application for a retrospective CITES import permit did not meet the criteria. The plants were donated to a botanical garden. All costs have been passed on to the Dutch flower bulb company that ordered the plants.
4. Administrative law enforcement CITES seized 2000 plants belonging to the species *Lepismium boliviannum*. The shipment was imported from Kenia without the required CITES export and import permit. The application for a retrospective CITES import permit did not meet the criteria. The plants were donated to a botanical garden. All costs have been passed on to the Dutch horticultural company that ordered the plants.
5. Administrative law enforcement CITES seized 6820 plants belonging to the species *Cereus hildmannianus*. The shipment was accompanied by a Chinese export permit, but a valid CITES import permit was missing. The application for a retrospective CITES import permit did not meet the criteria. Under our supervision, the plants were destroyed by the Dutch horticultural company that ordered the shipment. No costs have been passed on to the offender.
6. Administrative law enforcement CITES seized 213 plants belonging to the family Orchidaceae, 80 of which belonged to the genus *Paphiopedilum*. The shipment was accompanied by two CITES export permits from Thailand, but the required CITES import permit was missing. Based on the inspection of a botanical expert and information received from the Thai CITES MA it was concluded that the plants were artificially propagated. They were donated to a botanical garden. All costs were passed on to the Dutch company that ordered the plants.
7. Administrative law enforcement CITES seized a shipment consisting of 3696 plants belonging to the family Cactaceae (*Mammillaria hahniana*, *Mammillaria spinosissima*, *Mammillaria compressa*, *Notocactus scopo*, *Ferocactus chrysacanthus*, not being colour mutants) and 8280 plants belonging to the species *Euphorbia lactea*, which were grafted on *Euphorbia tripona*. The shipment was imported from China without the required CITES export and import permits. The application for a retrospective CITES import permit did not meet the criteria. The plants were donated to a botanical garden. All costs were passed on to the Dutch company that ordered the plants.
8. Administrative law enforcement CITES seized 1500 plants belonging to the species *Rhipsalis burchelli*. The shipment was imported from South Korea without the required CITES export and import permits. The requirements for a retrospective CITES import permit were not met. The plants were donated to a botanical garden. All costs were passed on to the Dutch wholesale trader that ordered the plants.

9. Administrative law enforcement CITES seized 297 orchids belonging to the species *Spathoglottis plicata*. The shipment was accompanied by an American CITES export permit, but the required CITES import permit was missing. The requirements for a retrospective CITES import permit were not met. The plants were donated to a botanical garden. All costs were passed on to the Dutch wholesale trader that ordered the plants.
10. Administrative law enforcement CITES seized a shipment containing 50 plants belonging to the species *Zygosicyos pubescens* and 50 plants belonging tot the species *Zygosicyos tripartitus*. The shipment was imported from Madagascar without the required CITES import permit. The CITES MA of Madagascar had issued a retrospective CITES export permit, which stated that the plants were of wild origin. We asked the CITES MA of Madagascar if they wanted us to return the plants to Madagascar, but there was no response. The plants were donated to a botanical garden. All costs were passed on to the Dutch wholesale trader that ordered the plants.
11. Administrative law enforcement CITES seized 266 plants belonging to the family Orchidaceae. The shipment was imported from Taiwan without the required CITES documents. The Taiwanese export permit was not valid, as the amount and species of plants listed did not correspond to the actual shipment. There was no import permit and the requirements for a retrospective CITES import permit were not met. Determination by a botanical expert confirmed that the plants were artificially propagated. The plants were donated to a botanical garden. All costs were passed on to the Dutch horticultural company that ordered the plants.
12. Administrative law enforcement CITES seized 840 plants belonging to the genus *Euphorbia*. The shipment was imported from Tanzania without the required CITES export and import permits. The requirements for a retrospective CITES import permit were not met. The plants were donated to a botanical garden. As there had been considerable delay in handling this case, no costs were passed on to the Dutch wholesale trader that ordered the plants.
13. Administrative law enforcement CITES seized several shipments of seedlings of the genus *Oncidium*, amounting to more than 100,000 orchids. The shipments were sent from Thailand to the Netherlands. One of the accompanying Thai CITES export permits was not valid and CITES import permits were lacking. Before the seedlings were transported, they had been taken out of their bottles, so the CITES import permit exemption did not apply. The requirements for a retrospective CITES import permit were not met. The orchids are scheduled to be destroyed.
14. Administrative law enforcement CITES seized 12 plants belonging to the family Orchidaceae. The orchids were mailed in a package from Brazil to Taiwan without the required CITES export and import permits. The requirements for a retrospective CITES import permit were not met. The plants were donated to a botanical garden. All costs were passed on to the Dutch transport firm.
15. Administrative law enforcement CITES seized 6 plants belonging to the species *Cycas revoluta*. The plants were sent in a container from Indonesia to the Netherlands without the required CITES export and import permits. The requirements for a retrospective CITES import permit were not met. The plants were destroyed. No costs were passed on to the Dutch transport firm.
16. Administrative law enforcement CITES seized 3 plants belonging to the family Cactaceae, genus *Trichocereus*. The plants were mailed in a package from South Africa to the Netherlands without the required CITES export and import permits. The requirements for a retrospective CITES import permit were not met. The plants were donated to a botanical garden. As there had been considerable delay in handling this case, the costs were not passed on to the Dutch person that ordered the plants.
17. Administrative law enforcement CITES seized 52 orchids (*Cypripedium* spp.), sent from China to the Netherlands without the required CITES export and import permits. The requirements for a retrospective CITES import permit were not met. Expert examination indicated that the plants originated from the wild. The orchids were donated to a botanical garden. All costs were passed on to the Dutch offender.

18. Administrative law enforcement CITES seized 73 orchid cuttings (*Catasetum* hybrids and *Cycnoches* hybrids), sent from Thailand to the Netherlands. The shipment was accompanied by a Thai export permit, but the number of plants mentioned in the permit did not correspond with the actual shipment. The CITES import permit was lacking. The requirements for a retrospective CITES import permit were not met. The orchids were donated to a botanical garden. All costs were passed on to the Dutch offender.
19. Administrative law enforcement CITES seized 1 orchid belonging to the species *Dactylorhiza aristata*, sent from Japan to the Netherlands. The Japanese export permit was not valid and the CITES import permit was lacking. The requirements for a retrospective CITES import permit were not met. The orchid was donated to a botanical garden. All costs were passed on to the Dutch offender.
20. Administrative law enforcement CITES seized 8 plants belonging to the species *Tillandsia xerographica*, sent from Guatemala to Denmark. The shipment was accompanied by a valid CITES export permit, but the CITES import permit was not valid. The requirements for a retrospective CITES import permit were not met. The plants were donated to a botanical garden. Due to an omission in the decision to impose an administrative enforcement order, the costs could not be passed on to the Dutch offender.
21. Administrative law enforcement CITES seized 23 orchids belonging to the species *Paphiopedilum maudiae*. The shipment was imported from Taiwan without the required CITES export and import permits. As the shipment contained perishable products (cut flowers), it was immediately destroyed. No costs were passed on to the Dutch transport company.

#### **Live specimens: corals**

22. Administrative law enforcement CITES seized a shipment of 615 substrate stones, some of which contained living colonies of *Porites* spp. The shipment was imported from Indonesia without the required CITES export and import permits. The requirements for a retrospective CITES import permit were not met. Examination by a coral expert showed that 73 stones contained living colonies, the other stones were sent back to the importer. The coral was donated to an educational institution. All costs were passed on to the Dutch offender.
23. Administrative law enforcement CITES seized 169 pieces of living coral (157 *Acropora* spp., 11 *Montipora* spp., 1 *Merulina* spp.) and one clam (*Tridacna* spp.). The specimens were included in a shipment containing ornamental fishes, sent from Indonesia with destination Romania. No CITES export and import permits were present. The requirements for a retrospective CITES import permit were not met. The specimens were donated to a Dutch zoo. All costs were passed on to the Dutch transport company.
24. Administrative law enforcement CITES seized a shipment of 680 kg living corals, sent from Indonesia with destination the Netherlands. The accompanying CITES export and import permits did not correspond with the actual shipment. The requirements for a retrospective CITES import permit were not met. Preliminary investigation by an expert showed that at least 117 pieces were not mentioned in the CITES documents. The corals were donated to a Dutch zoo. All costs were passed on to the Dutch trader that ordered them.
25. Administrative law enforcement CITES seized 31 pieces of natural stone, part of a shipment sent from Indonesia with destination the Netherlands. Investigation by an expert had shown that these stones contained living or recently living colonies of *Scleractinia* spp. (30 pieces) and *Heliopora* spp. (1 piece), while the required CITES import permit was missing. The requirements for a retrospective CITES import permit were not met. Further investigation is still going on.

26. Administrative law enforcement CITES seized 13 pieces of stony corals, part of a shipment sent from Indonesia with destination the Netherlands. These corals were not mentioned in the accompanying CITES export and imports permits and the requirements for a retrospective CITES import permit were not met. The corals were identified as belonging to the order Scleractinia: *Tubastrea* spp. (4), *Fungia* spp. (3), *Cynarina lacrymalis* (1), *Sympyllia* spp. (5). They were donated to a Dutch zoo. All costs were passed on to the Dutch company that ordered the shipment.

**Live specimens: animals**

27. Administrative law enforcement CITES seized 4 horned parakeets (*Eunymphicus cornutus*), included in a shipment that was about to be exported to Thailand. No CITES export permit had been issued. The birds were placed in a care facility and afterwards donated to a zoo. All costs were passed on to the Dutch offender.
28. Administrative law enforcement CITES seized a shipment of tropical fish consisting of 40 specimen of the species *Arapaima gigas*. The shipment was sent from Peru to the Netherlands with a valid CITES export permit, but a CITES import permit was lacking. The requirements for a retrospective CITES import permit were not met. The fish were donated to various zoos. All costs were passed on to the Dutch offender.
29. Administrative law enforcement CITES seized an Eurasian hobby (*Falco subbuteo*), because the German CITES MA had withdrawn the EC-certificate that was issued for the parent bird. Due to new information they had concluded that the parent bird was probably taken from the wild and illegally traded. The seized bird was placed in a care facility. No costs were passed on to the Dutch offender.
30. During a routine control at a Dutch trading company five Hermann's tortoises (*Testudo hermanni*) were detected without valid EC-certificates. Administrative law enforcement CITES seized the animals, as it is not allowed to retrospectively replace the certificates. The animals were offered to a zoo. All costs were passed on to the offender.
31. Administrative law enforcement CITES seized an Illiger's macaw (*Primolius maracana*), because the owner had bought the bird without a matching EC-certificate and the bird did not have a seamless footring or a microchip. The bird was placed in a care facility and afterwards donated to a zoo. All costs were passed on to the Dutch offender.
32. Administrative law enforcement CITES seized a raven (*Corvus corax*), because the trading company had bought the bird in Austria without a matching EC-certificate and the bird did not have a seamless footring or a microchip at the moment of transaction. The bird was placed in a care facility and afterwards donated to a zoo. All costs were passed on to the Dutch offender.
33. Administrative law enforcement CITES seized a white-naped crane (*Grus vipio*) because of illegal possession and trade. DNA-tests could not prove that the bird was born and bred in captivity. Eventually the bird was donated to a zoo. No costs have been passed on.
34. Administrative law enforcement CITES seized a hybrid falcon (*Falco peregrinus x Falco rusticolus*) because of an invalid EC-certificate. The issued certificate had been withdrawn because it was obtained under false pretenses and the owner of the birds could not demonstrate the legal origin of the bird through DNA investigation. The bird was placed in a care facility and afterwards donated to a zoo. All costs were passed on to the Dutch offender.
35. Administrative law enforcement CITES seized ten reptiles because the holder did not have the required EC-certificates (1 *Cyclura nubila*, 3 *Epicrates subflavus*, 4 *Acrantophis dumerilli*, 2 *Testudo hermanni*). The animals were donated to an educational institution. All costs were passed on to the Dutch offender.

36. Administrative law enforcement CITES seized a red-crowned amazon (*Amazona viridigenalis*) because the bird had been transferred illegally and the legal origin could not be verified. Unfortunately, the parrot died during the confiscation period, as it was suffering from a severe disease. No costs were passed on.
37. Administrative law enforcement CITES seized twelve macaws (2 *Ara militaris*, 9 *Ara chloroptera*, 1 Harlequin macaw hybrid), because the owner could not demonstrate the legal origin of the birds. The macaws were discovered during a police raid at a cannabis growing facility. They were donated to a zoo. All costs were passed on to the Dutch offender.
38. Administrative law enforcement CITES seized an *Amazona finschi* because the owner, who had applied for an EC-certificate, could not demonstrate the legal origin. This was partly due to the fact that the bird had several owners during a short period of time. During the confiscation period the bird tested positive for an infectious disease and consequently has to be kept on its own.
39. Administrative law enforcement CITES seized a green monkey (*Chlorocebus aethiops*) because no CITES import permit had been issued for the animal (bought at a market in Istanbul). The monkey was donated to a Dutch zoo. All costs were passed on to the Dutch offender.
40. Administrative law enforcement CITES seized a yellow-crested cockatoo (*Cacatua sulphurea*) because the owner, who had applied for an EC-certificate, could not demonstrate the legal origin. The cockatoo was donated to a zoo. All costs were passed on to the Dutch offender.
41. Administrative law enforcement CITES seized 3 Madagascar ground boa's (*Acrantophis madagascariensis*) because the owner, who had applied for EC-certificates, could not demonstrate the legal origin. The reptiles were donated to a zoo. All costs were passed on to the Dutch offender.
42. Administrative law enforcement CITES seized a Dumeril's boa (*Acrantophis dumerili*) because the animal was traded without a legal EC-certificate. The reptile was donated to a zoo. All costs were passed on to the Dutch offender.
43. Administrative law enforcement CITES seized two Amazon parrots (*Amazona oratrix* and *Amazona tucumana*) because the birds did not have an identification mark and the owner could not demonstrate the legal origin. The birds were donated to a zoo. All costs were passed on to the Dutch offender.

**Non-living specimens: medicines**

All seized medicines were destroyed. No costs were passed on to the offenders.

44. Administrative law enforcement CITES seized 4000 capsules containing *Hippocampus* spp. The shipment was sent from Indonesia to Suriname without the required CITES export permit.
45. Administrative law enforcement CITES seized a shipment of Chinese medicines, sent from China to the Netherlands without the required CITES export and import permits. The shipment consisted of 10440 pills containing *Cibotium barometz*, 600 pills containing *Hippocampus* spp., 441800 pills containing *Saussurea costus* and 85,85 kilogram powdered *Saussurea costus*.
46. Administrative law enforcement CITES seized seven shipments containing *Prunus africana* or products containing *Prunus africana*, because the CITES export and import permits were missing: 1.3 kg powder imported from China, 12 bottles with capsules imported from the US, 166320 pills imported from the US, 61560 pills imported from the US, 1080 pills imported from the US, 360 pills imported from the US, 360 capsules imported from the US.

47. Administrative law enforcement CITES seized two shipments containing products of *Saiga tatarica* because the CITES export and import permits were missing: 12 gram powdered horn imported from China and 720 pills imported from Singapore.
48. Administrative law enforcement CITES seized three shipments containing products of *Hoodia gordoni*i because the CITES export and import permits were missing: 60 capsules imported from New Zealand, 3240 pills imported from the US, 1440 pills imported from the US.
49. Administrative law enforcement CITES seized two shipments containing American ginseng (*Panax quinquefolius*) because the CITES export and import permits were missing: 252 gram root parts imported from HongKong and 350 gram root parts imported from China.
50. Administrative law enforcement CITES seized four shipments containing plant products of the family Orchidaceae, because the CITES export and import permits were missing: 0,049 kilogram extract of *Dendrobium* spp. imported from the US; 124,8 kilogram capsules with ingredient *Dendrobium* spp., sent from the US to the UK; 4000 packets with ingredient *Dendrobium* spp. imported from China (sender unknown); 21 packets containing 0,15 kilogram product each with ingredient Orchidaceae, of unknown origin and detected at a supermarket selling medicinal herbs.
51. Administrative law enforcement CITES seized three shipments with products containing *Saussurea costus*, because the CITES export and import permits were missing: 45 packets containing 0,05 kilogram product each, imported from China; 57,6 kilogram pills sent from Hong Kong to the UK; 1440 packets imported from China (sender unknown). *Saussurea costus* is also mentioned in shipment number 45.
52. Administrative law enforcement CITES seized the following shipments because the required CITES export and import permits were missing: 52320 capsules containing *Hydrastis canadensis* imported from China; 10 bottles with ingredient bile of Ursidae spp. sent from China to the UK; 540000 capsules containing *Maris* spp. sent from China to Ghana; 6 kilogram product containing *Rauvolfia serpentina*, sent from India to the Russian Federation.

**Non-living specimens: ivory**

53. Administrative law enforcement CITES seized a shipment of 50 tusks of the African elephant (*Loxodonta africana*) because the required CITES export and import permits were missing. The tusks were sent from Nigeria to Thailand. The case is still under investigation.
54. Administrative law enforcement CITES seized two rhino horns (*Rhinocerotidae* spp.), presumably originating from Belgian Kongo. The owner, who tried to sell the horns, could not demonstrate their legal origin. A sample of the horns was donated to a South African laboratory, the remaining parts were destroyed.

**Non-living specimens: coral**

Dead corals are destroyed, unless otherwise stated.

55. Administrative law enforcement CITES seized two shipments of corals, about 780 pieces in all, imported from Indonesia. At least two thirds of the corals consisted of CITES protected species, but CITES export and import permits were missing. All costs were passed on to the Dutch company that ordered the corals.

56. Administrative law enforcement CITES seized five shipments of corals because the CITES export and import permits were missing:

- a piece of Scleractinia spp. sent from Cambodia to Italy (including two halves of a clam (Tridacnidae spp.))
- two pieces of coral (Scleractinia spp. and Helioporidae spp.) imported from the US
- a piece of *Heliopora coerulea* imported from the US
- 160 pieces of jewellery containing *Trachyphyllia geoffroyi*, imported from Indonesia
- a piece of *Diploria strigosa* imported from Aruba.

No costs were passed on to the offenders.

57. Administrative law enforcement CITES seized six pieces of coral of unknown origin: a piece of *Pocillopora verrucosa* and five pieces of *Acropora elseyi*. The corals were in the possession of a sailor without the required CITES documents. No costs were passed on to the offender.

#### **Non-living specimens: animal products**

Seized animal products are destroyed, unless otherwise stated. No costs were passed on to the offenders.

58. Administrative law enforcement CITES seized the following products of CITES protected species because the owners could not demonstrate the legal origin:

- an *Acrantophis dumerili* and a *Chamaeleo calyptratus* in alcohol
- 12 art objects consisting of parts of Cheloniidae spp.
- a stuffed *Amazona oratrix*
- a stuffed *Eretmochelys imbricata*
- a stuffed otter (*Lutra lutra*)
- two dead *Acrantophis dumerili* and a tortoise (*Testudo hermanni*) in alcohol
- 17 bags decorated with feathers of the cockatoo
- the tusk of a narwhal (*Monodon monoceros*) and the inner ear bone of a sperm whale (*Physeter macrocephalus*); these specimens will be donated to an educational institution
- the skin of a *Panthera leo*
- the skull of a Canadian otter (*Lontra canadensis*), the skull of a Rüppell's vulture (*Gyps rueppellii*), the skull of a bobcat (*Lynx rufus*) and the skull of a megabat (*Pteropus* spp.).

59. Administrative law enforcement CITES seized the following shipments because the required CITES export and import permits were missing:

- the skull of a *Panthera leo*, sent from the US to Denmark
- 4 teeth of a *Caiman crocodilus*, sent from Peru to Romania
- 5 ornaments for the head consisting of feathers of CITES protected bird species, imported from Suriname
- 2 teeth of a sawfish (Pristidae spp.) about to be exported (they were donated to an educational institution)
- 7500 spines of the porcupine (*Hystrix cristata*) imported from Kenya
- 2 spines of the porcupine (*Hystrix cristata*) sent from South Africa to Ireland
- the taxidermy skin of an *Equus zebra hartmannae* imported from South Africa
- 7 specimens of *Tridacna gigas* imported from Kenya
- the skin of an anaconda (*Eunectes murinus*) imported from Suriname
- the skin of an American black bear (*Ursus americanus*) and the skin and stuffed head of a brown bear (*Ursus arctos*) imported from Canada; these specimens will be donated to an educational institution



Ze kan daartoe planten en dieren middels een bestuursdwangbesluit in bewaring nemen als ze zonder de benodigde vergunningen worden ingevoerd/uitgevoerd, overgedragen of illegaal in bezit zijn.

## Achtergrondinformatie

CITES (Convention on International Trade in Endangered Species of wild flora and fauna) is een internationale overeenkomst tussen bijna 180 landen. In deze overeenkomst zijn afspraken gemaakt over internationale bedreigde dier- en plantensoorten. Het doel van deze overeenkomst is het uitsterven van dier-plantensoorten als gevolg van de handel in de soorten, te voorkomen.
